Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Iowa Student Loan Liquidity Corporation 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025 and the related notes to the financial statements (Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

(1) Description of Plan

The following description of the Iowa Student Loan Liquidity Corporation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan that covers substantially all full-time employees of Iowa Student Loan Liquidity Corporation (Employer) who have three months of service and are age 18 or older. The plan sponsor appointed plan administrator is responsible for the oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is subject to the provisions of ERISA and the applicable current Internal Revenue Service Code provisions.

(b) Contributions

Each year, participants may contribute up to the Internal Revenue Service limit of their pretax annual compensation as defined by the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan currently offers mutual funds, pooled separate accounts, self-directed brokerage accounts and common/collective trusts funds as investment options for participants. Participants direct the investment of both their contributions and employer contributions into the various investment options offered by the Plan. Participants may change their investment options daily. The Plan contains an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3.5% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. For eligible Plan participants, the Employer provides a 3.0% safe harbor contribution to the Plan each year. For participants employed by the Employer on the last day of the Plan year with a minimum of 1,000 hours and one year of service for the year, the employer made matching contributions of 3.5% of eligible compensation for the year ended June 30, 2025. In addition, the Employer, at its sole discretion, may make discretionary contributions to those Plan participants who were employed by the employer on the last day of the Plan year with a minimum of 1,000 hours and one year of service for the year. The Employer made discretionary contributions of 3.0% of eligible compensation for the year ended June 30, 2025. Contributions are subject to certain IRS limitations.

(c) Participant Accounts

Each participant's account is credited with the participant's applicable Employer contributions, as well as allocations of Plan earnings (losses). Allocations are based on participant earnings, account

balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) *Vesting*

Participants are immediately vested in their own contributions and the Employer's safe harbor contributions, plus any earnings (loss) thereon. Vesting in the Employer matching and discretionary contributions plus earnings (loss) thereon, is based on continuous years of service. A participant is 20% vested after two years of service, as defined, and continues to vest 20% each consecutive year until 100% vested after six years of service.

(e) *Payment of Benefits*

Participants or their beneficiaries are eligible for benefits upon retirement, termination, death, or disability. Benefits shall be distributed through the participant option of a lump sum payment or an annuity. Participant accounts with a vested balance of less than \$1,000 are distributed through a lump sum payment. Accounts with a vested balance of \$1,000 to \$5,000, are rolled over to the participant's individual retirement account.

(f) *Forfeited Accounts*

During the year ended June 30, 2025, forfeited non-vested accounts totaling approximately \$20,400 were used to pay Plan expenses. The forfeiture account balance on June 30, 2025 and 2024 was approximately \$36 and \$6, respectively.

(2) Summary of Accounting Policies

(a) *Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully-benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

(b) *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(c) *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the

measurement date. The Plan trustees determine the Plan's valuation policies utilizing information provided by Principal. See note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) *Payment of Benefits*

Benefits are recorded when paid.

(e) *Expenses*

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Certain administrative fees are charged directly to the participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(f) *Subsequent events*

Plan management has evaluated subsequent events through January 27, 2026, the date the financial statements were available to be issued.

(3) *Investments*

The following is a summary of the investment information as of June 30, 2025 and 2024, and for the year ended June 30, 2025, included throughout the Plan's financial statements and supplemental schedule that was prepared or derived from information provided by Principal, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from Principal that information provided to the Plan Administrator by Principal relating to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule relating to the following investments:

(4) Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of pooled separate accounts and common/collective trust funds managed by Principal. Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Principal of approximately \$25,600 for the year ended June 30, 2025, which was not covered by revenue sharing. The Plan Sponsor pays directly other fees related to Plan operations.

(5) Plan Termination

Although it has not expressed any intent to do so, the Plan Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(6) Stable Value Investment Contract

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of Plan. Contract value

represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses

The contract value of the Principal Stable Value fully benefit-responsive investment contract at June 30, 2025 and 2024 was \$4,604,551 and \$4,573,090, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, premature termination of the guaranteed investment contract by the Plan or termination of the Plan, would limit the Plan's ability to transact at contract value with Principal. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contact value with participants is unlikely.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of these investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are shown as Level 1.

Pooled Separate Accounts: The net asset value is used as a practical expedient to determine fair value for all pooled separate accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Each pooled separate account provides for redemptions by the Plan at the net asset value per share, with no advance notice requirement. Investments in pooled separate accounts are not classified according to fair value hierarchy, in accordance with ASU 820, as the net asset value is used as a practical expedient to value the investment.

Self-Directed Brokerage Account - Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded. The common stocks held by the Plan are deemed to be actively traded and are shown as Level 1.

Self-Directed Brokerage Account - Corporate debt instruments: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing values on yields currently available on comparable securities of issuers with similar credit ratings. The corporate debt instruments held by the Plan are deemed to be actively traded and are shown as Level 1.

(9) Tax Status

The Plan is based on a volume submitter plan which has received a letter from the Internal Revenue Service stating that the prototype Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
