Independent Auditor's Report

To the Plan Administrator

Opinion

We have audited the financial statements of Alcott HR Group LLC Group Insurance Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Note 1 - Description of the Plan

The following description of the Alcott HR Group LLC Group Insurance Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for complete information of the Plan's provisions.

General

The Plan constitutes an employee welfare benefit plan under the applicable section of the Employee Retirement Income Security Act of 1974 ("ERISA") and is sponsored by Alcott HR Group LLC (the "Company" and "Plan Sponsor"). The Plan is a fully-insured health and welfare plan that provides eligible employees who have completed a waiting period not to exceed the 1st of the month after 60 days following their date of hire or reclassification with various forms of coverage. Eligible participants may elect health coverage from several insurance carriers participating in the Plan. The Plan is intended to constitute a single-employer plan for purposes of ERISA.

Effective June 1, 2019, the Plan Sponsor established the Alcott HR Group LLC Group Insurance Plan Trust ("Trust") to facilitate the collection of Plan contributions, remittance to various Plan service providers, and payment of other Plan expenses.

Enrollment

Enrollment must occur within 30 days of the effective date of coverage. If not enrolled within 30 days, enrollment may occur upon the next annual enrollment period, a special enrollment event or a valid change in status.

Contributions

The Plan is contributory, funded by participant and company contributions, as applicable. Total contributions are based upon rates determined by the Plan Sponsor and the respective plan service provider.

Fully-insured benefits

The Plan provides (but is not limited to) major medical, dental and vision, life and accidental death and dismemberment plans, and short-term and long-term disability benefits to all eligible employees and their dependents through the purchase of coverage from third-party insurers. These benefits are fully-insured through various contracts with the insurance carriers. The Plan retains no risk of loss associated with these benefits.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Interest income is recorded on the accrual basis.

Payment of benefits

Premiums, paid by the Trust, are recorded as premiums paid in the accompanying statements of changes in net assets available for benefits.

Administrative expenses

The Plan incurs administrative costs specific to the operations of the Plan.

Contributions and prepaids

Contributions are reported as income to the Plan in the period to which they pertain. The Plan Sponsor collects certain contributions in advance to facilitate the payment of Plan premiums due in the subsequent month. The balance of contributions collected in advance as of May 31, 2025 and 2024 is \$6,211,402 and \$5,243,556, respectively. Upon the withdrawal of a participant from the Plan, any unused funds will be refunded at that time.

Reclassifications

Reclassifications have been made to the prior period balances to conform to the current year presentation.

Concentration of credit risk

The Plan maintains its cash in a bank deposit account which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such account. The Committee believes the Plan is not exposed to any significant credit risk on cash.

Subsequent events

The Plan has evaluated subsequent events through March 11, 2026, the date the financial statements were available to be issued and nothing was noted that would require adjustment or disclosure.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Interest-bearing cash: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of May 31, 2025 and 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4 - Related party transactions and party-in-interest transactions

The Plan pays a service fee ("Management Fee") to the Plan Sponsor as compensation for certain administrative costs of operating the Plan. These transactions are party-in-interest transactions under ERISA. The Management Fee incurred during the years ended May 31, 2025 and 2024 was \$724,713 and \$662,688, respectively, and is included in administrative expenses on the accompanying statements of changes in net assets available for benefits. As of May 31, 2025 and 2024, the Management Fee payable was \$3,729,037 and \$3,004,324, respectively.

Note 5 - Income tax status

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for, or on account of, the participants. Subsequent to May 31, 2025, the Plan Sponsor has decided to terminate the Trust and service the Plan from its accounts going forward.
