Basis for Opinion

1. Plan Description

The following description of the HDG Hotels LLC Profit Sharing and Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of HDG Hotels LLC ("Plan Sponsor" or "Company") who have completed thirty days of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan Sponsor entered into a transaction that resulted in the Plan, a multiple-employer plan, becoming a single-employer plan under a new entity, HDG Hotels, LLC, effective as of January 1, 2024. Due to the transaction, the adopting employers of the multiple-employer plan were no longer part of the control group of entities included in the Plan, and those entities were removed from the Plan. Participant accounts of those adopting employers were distributed to participants in 2024.

Also effective January 1, 2024, the Plan Sponsor entity changed to HDG Hotels LLC (formerly "Hotel Development and Management LLC"). In addition, the Plan name changed to "HDG Hotels LLC Profit Sharing and Trust" (formerly "Hotel Development and Management LLC 401(k) Profit Sharing Plan and Trust"). These financial statements reference the new plan name and plan sponsor.

- b) *Contributions* – Each year participants may contribute to the Plan up to 90% of their pre-tax annual compensation, subject to certain IRS limitations. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans ("rollover contributions").

The Employer will make a matching contribution to the individual account of each employee. All employer contributions are invested as directed by the participants. Contributions are subject to certain limitations and eligibility requirements. For the year ended December 31, 2024 and 2023, the Company contributed a safe harbor contribution of 100% of the first 4% of

compensation that a participant contributed to the Plan. The employer match contributions for the years ended December 31, 2024 and 2023 were \$228,997 and \$227,650, respectively.

The Company, at its discretion, may also make a contribution to the Plan that will be allocated to eligible participant accounts as specified by the Plan. No such contributions were made for the year ended December 31, 2024 and 2023.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

- c) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d) *Vesting* – Participants are vested immediately in their voluntary contributions, plus earnings thereon. Participants are also immediately 100% vested in Safe Harbor matching contributions and profit sharing contributions.
- e) *Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2 percent above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

- f) *Payment of Benefits* – Upon termination of service, participants may elect to receive either a lump-sum amount equal to the value of the vested interest in their account or rolled over into a qualified plan, subject to regulatory requirements. In-service distributions are available for those who have attained the age of 59 ½ or have a qualified hardship. Minimum requirement for in-service distributions is \$500. Hardships are permitted to be taken from Qualified Non-Elective Contributions or Qualified Matching Contributions.
- g) *Forfeited Accounts* – At December 31, 2024 and 2023, the forfeited non-vested accounts amounted to \$45,417 and \$45,404, respectively. Forfeitures may be used to reduce future employer contributions or to pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value assets includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through March 2, 2026, which is the date the financial statements were available to be issued.

Effective January 1, 2026, the plan sponsor of the Plan changed from HDG Hotels, LLC to ARK Hospitality Management, LLC.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in inactive markets; and level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts – The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Related Party Transactions and Party in Interest transactions

John Hancock Retirement Plan Services LLC is the recordkeeper of the Plan; therefore, transactions with the recordkeeper qualify as party-in-interest transactions. Fees paid by the Plan to the recordkeeper totaled \$30,112 for the year ended December 31, 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by ERISA Services Inc. ("ERISA Services"). ERISA Services its latest opinion letter dated June 1, 2021, in which the IRS stated that the Pre-approved Plan as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter. Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that that Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
