## INDEPENDENT AUDITOR'S REPORT

Board of Trustees  
United Food and Commercial Workers  
Union Local No. 1529 and Employers  
Health and Welfare Plan and Trust

### Opinion

We have audited the accompanying financial statements of United Food and Commercial Workers Union Local No. 1529 and Employers Health and Welfare Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the United Food and Commercial Workers Union Local No. 1529 and Employers Health and Welfare Plan and Trust as of May 31, 2025 and 2024, and the changes in its net assets available for benefits and of changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the United Food and Commercial Workers Union Local No. 1529 and Employers Health and Welfare Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED MAY 31, 2025 AND 2024

**NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The financial statements have been prepared using the accrual basis of accounting.

**Employer Contributions Receivable** - Contributions due from employers are accrued at year end only as to those amounts applicable to contribution periods which ended on or before the financial statement dates and are based on subsequent period cash collections. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, the Plan has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 2. GENERAL**

The United Food and Commercial Workers Union Local No. 1529 and Employers Health and Welfare Plan and Trust was formed in 1965 under an agreement between certain employers and United Food and Commercial Workers Local 1529 - member of United Food and Commercial Workers International Union. This agreement provides, among other things, for participating employers to contribute an exact dollar amount for each eligible employee.

The Plan maintains a plan of benefits which provides life, accidental death, disability, hospitalization, surgical, major medical, prescription drugs, optical, and dental benefits for eligible employees, as specified in the plan document. Effective October 1, 1985, the Plan elected to become self-funded for all benefits specified in the Plan except for life, accidental death and dismemberment, and optical benefits.

Effective January 1, 2014, the eligibility criteria of the United Food and Commercial Workers Local Union No. 1529 and Employers Health and Welfare Plan was changed. After this date, no retirees were eligible for benefits under the Plan.



### **NOTE 3. ESTIMATED LIABILITY FOR INCURRED BUT UNPAID CLAIMS**

At May 31, 2025, the liability for claims incurred but unpaid by the Plan is estimated by the consultant to be \$1,155,000. This represents \$237,000 reported and unpaid and \$918,000 incurred but unreported.

### **NOTE 4. TAX STATUS**

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c) of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated January 31, 2014. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the trust is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for income taxes in accordance with the Accounting Standards Codification (ASC) Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribed a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended May 31, 2025 and 2024, and determined that there were no matters that would require recognition in the financial statements or that may have an effect on its tax-exempt status. As of May 31, 2025, the statute of limitations for tax years 2021 through 2023 remains open with the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns.

### **NOTE 5. PRIORITIES UPON TERMINATION OF THE PLAN**

In the event that the obligations of all the Employers to make contributions shall terminate, the Trustees shall apply the Plan to the purposes of the Plan and none other and, upon the disbursement of the entire Plan, this Plan shall terminate.

In lieu of the normal distribution, upon the written request of the Union and approval of the majority of the Trustees, the Trustees shall, after all obligations of the Plan have been set aside or actuarially secured, turn over any surplus monies and property in the Plan to any future health and welfare trust fund that may be created by and between the Union and Employers through Collective Bargaining Agreements.



## NOTE 6. CASH AND CASH EQUIVALENTS

## NOTE 7. LEASE AGREEMENT

The Trustees entered into a five-year lease agreement ending January 1, 2021 with Focus Administrative Services of Tennessee, LLC. The first of three lease renewal options was exercised for the five year term ending January 1, 2026. The monthly rent is \$9,300.

The future minimum rental payments are as follows:

Rent expense for the years ended May 31, 2025 and 2024 was \$65,100 and \$112,294.

The Plan has elected, for all underlying classes of assets, to not recognize right of use assets and lease liabilities for short-term leases that have a lease term of 12 months or less at lease commencement per the guidance in Topic 842. The lease requires a 90-day notice period to terminate and creates a noncancelable right and obligation during the 90-day notice period, there is an enforceable term on a rolling 90-day basis. The Plan recognizes lease cost associated with short-term leases on a straight-line basis over the lease term.

## NOTE 8. COBRA COMPLIANCE

The Plan is subject to the continuation of coverage provisions of COBRA (Consolidated Omnibus Budget Reconciliation Act of 1985). Accordingly, the Plan has taken steps to comply with this Act.



## **NOTE 9. POST-RETIREMENT BENEFIT OBLIGATIONS**

The post-retirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered prior to May 31. Post-retirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee's service in the industry rendered prior to the valuation date.

As of January 1, 2014, the eligibility criteria of the United Food and Commercial Workers Local Union No. 1529 and Employers Health and Welfare Plan and Trust was changed. After this date, no retirees were eligible for benefits under the Plan.

## **NOTE 10. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

## **NOTE 11. ALLOCATION OF RETIREE FUND OPERATING COSTS**

The percentage of Retirees to the percentage of total eligibles was determined to be 6.80%. The Trustees approved this percentage and the Retiree Plan will reimburse the Active Plan for rent, utilities, postage, telephones, printing and paper products.

## **NOTE 12. EMPLOYER CONTRIBUTIONS AND PASS-THROUGH REIMBURSEMENT**

As a result of CBA contract negotiations, The Kroger Company discontinued contributions to the Plan effective March, 2020. Investments were depleted to cover benefit and operating costs. The Plan has a pass-through arrangement with The Kroger Company. The Plan submits a weekly statement of benefit and operating costs and The Kroger Company reimburses the Plan the total cost of the statement.

Effective January 1, 2025, The Kroger Company participants are no longer covered under the Plan.
