INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
UA Local 190 Health and Welfare Plan
Ann Arbor, Michigan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of UA Local 190 Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of UA Local 190 Health and Welfare Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended May 31, 2025 and 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UA Local 190 Health and Welfare Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UA Local 190 Health and Welfare Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF PLAN

The following description of the UA Local 190 Health and Welfare Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan provides health, loss of time, and death benefits to eligible members of the UA Local 190 Plumbers/Pipefitters/Service Technicians/Gas Distribution of the United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada (the Union). The Plan was formed under an agreement between the Plan, the Union and the Greater Michigan Plumbing & Mechanical Contractors Association, Inc. At a later date, the Michigan Distribution Contractors Association was added as an association with the right to designate persons as employer trustees. Effective January 1, 2011, the Michigan Distribution Contractors Association merged into the Michigan Infrastructure and Transportation Association (Distribution Association). Effective May 1, 2012, the Distribution Association has no relationship with the Plan and certain members are entitled to contributions under the National Distribution Agreement in the State of Michigan or under the National Distribution Agreement in the State of Ohio. Retirees who were covered by the Plan at their retirement date are also eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, prescription drugs, dental, and vision), life insurance, and loss of time benefits to active members and to their beneficiaries and covered dependents. Retired employees are entitled to similar health benefits (in excess of any Medicare coverage) provided they have attained at least age 55, were covered by the Plan at the date of retirement and pay the required monthly self-pay contributions.

Benefits are covered through a combination of fully insured and self-funded arrangements. Life insurance for active members and the Medicare Advantage Plan for Medicare-eligible retirees are fully insured. Coverage for Medicare-eligible retirees is fully insured under a Medicare Advantage Plan. The plan also pays premiums for stop-loss coverage. Self-funded benefits include dental, vision, prescription, and miscellaneous benefits. In addition, health benefits for active participants and non-Medicare retirees remain self-funded.

Contributions

Under agreements with the employer associations during the years ended May 31, 2025 and 2024, the Plan received contributions from employers for each hour worked by active Union members at rates ranging from \$7.38 to \$10.63 and from \$7.28 to \$10.43 per hour, respectively. The monthly minimum hours required for coverage is 100. Members with less than 100 hours worked have the option to continue coverage with a self-pay premium.

The costs of the postretirement benefit plan are partially paid by the retirees. Retirees contribute at monthly rates ranging from \$90.52 to \$749.99, depending on retirement date, current age, and dependent coverage. Retiree contributions for 2025 and 2024 represent approximately 35.6% and 35.2%, respectively, of the estimated cost of providing their postretirement benefits.

Other

The Plan's board of trustees, as Sponsor, has the right under the Plan to modify the Plan's benefits. The Plan may be terminated only by joint agreement between industry and union, subject to the provisions set forth in ERISA. If the Plan is terminated, benefits will continue to eligible employees until funds are exhausted or the fund equity may be transferred to a succeeding health and welfare trust.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, IBNR, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, *continued*

Contributions Receivable

Employer and participant contributions receivable are recorded based on amounts actually received; therefore, no allowance for doubtful collections has been recorded.

Valuation of Investments

Investments are stated at fair market value as of May 31, 2025 and 2024. If available, quoted market prices are used to value investments. Certificates of deposit are valued at the original purchase price, which approximates fair market value. Certificates of deposit cost may also reflect some accrued interest, depending upon whether or not the Plan has elected to receive periodic interest payments or add them to the principal balance.

Postretirement Benefits

The amount reported as postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to May 31, 2025 reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the post-retirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 6% annual rate of increase in the per capita cost of covered health care benefits was assumed for 2025; the rate was assumed to decrease gradually to 3% for 2031 and to remain at that level thereafter. This remains the same as 2024, when a 6% annual increase was assumed, decreasing gradually to 3%. In 2025 and 2024, projected self-pay contributions increased less than the projected cost of covered health care benefits.

Annual composite claim cost is based on the actual experience of the group and adjusted for age. The average per participant monthly cost for pre-Medicare retirees after self-payment was \$960. The average monthly cost for Medicare retirees after self-payment was \$376. Retirees contribute 35.6% of the estimated cost of providing their postretirement benefits. The average age of the retirees is approximately 72.7.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Other Plan Benefits

The Plan's obligations for health claims payable and claims incurred by active participants but not reported at that date, are estimated by the Plan's administrator based on reported claims data. The Plan's obligation for accumulated eligibility of participants is estimated by the Plan's actuary based on average actual historical costs.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified in Level 1.

Interest-bearing cash consists of an interest-bearing checking account. Interest-bearing cash and certificates of deposit are recorded at cost, which approximates fair value, and are not classified in the fair value hierarchy.

NOTE D - INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Comerica Bank and Comerica Bank and Trust, N.A.:

NOTE E - BENEFIT OBLIGATIONS

The Plan's deficiency of net assets over benefit obligations at May 31, 2025 and 2024, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current bargaining agreement. It is expected that the deficiency will be funded through future increases in the collectively bargained contribution rates and retiree self-pay contributions.

The weighted-average health care cost-trend rate assumption (see Note B) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of May 31, 2025 and 2024 by \$3,090,620 and \$4,279,261, respectively.

NOTE F - STOP-LOSS ARRANGEMENT

The plan has a stop-loss arrangement with an insurance company, Blue Cross Blue Shield of Michigan. Stop-loss recoveries are netted against benefit payments on the statement of changes in net assets available for benefits. Stop-loss recoveries were \$394,156 and \$295,785 for 2025 and 2024, respectively.

NOTE G - TAX STATUS

The trust established under the Plan to hold the Plan's assets obtained its latest determination letter on June 25, 1954, in which the Internal Revenue Service stated that the trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The trust has been amended since receiving the determination letter. On advice of legal counsel, the Plan Administrator believes the plan document is in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Amounts currently payable to or for participants, dependents, and beneficiaries are recorded on Form 5500 for benefit claims that have been processed and approved for payment prior to yearend but are not yet paid.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits. The Plan's mutual fund investments are not covered by FDIC insurance.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

NOTE J - PLAN AMENDMENTS AND IMPORTANT CHANGES

The regular rates including COBRA except Medicate Advantage rates are adjusted annually as of March 1 based on actual costs incurred by the Plans during the previous year.

NOTE K - SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through March 9, 2026, the date of release of the financial statements.

In January 2026, the Trustees have approved plan amendments that grant merger authority to the settlors of the Plan and the UA Local 190 Individual HRA Plan. The intent is to merge these two plans, effective June 1, 2026.
