## **Independent Auditors' Report**

To the Plan Administrator of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Perkins Motor Company, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Perkins Motor Company, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions.

***GENERAL***

The Plan is a defined contribution plan sponsored by Perkins Motor Company, Inc. (the “Company” or “Plan Sponsor”) for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Plan Administrator. The Plan Administrator has overall responsibility for the operation and administration of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

***ELIGIBILITY***

In order to participate in the Plan, employees must have reached 90 days of service and be at least age 18. Employees must have reached one year of service to be eligible for the employer’s matching and discretionary nonelective profit sharing contributions. Employees who are non-resident aliens, leased employees, union employees, and agency employees are ineligible to participate in the Plan. Participants enter the Plan on the first day of the quarter following the date they become eligible.

***CONTRIBUTIONS***

Participants may contribute up to 90% of annual compensation each year not to exceed the maximum allowed by law. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). If an employee has not completed a salary deferral agreement by the time they are eligible to make salary deferrals, the Company will automatically withhold 3% of their compensation each payroll period in the first year and contribute that amount to the Plan as a salary deferral. The automatic withholding of 3% of compensation increases to 4% of compensation in the second year.

Employees also have the option to make Roth elective contributions and to make in-Plan Roth transfers which allow part or all of a pre-tax account to be converted into a Roth account within the Plan. Only the vested portion of any account qualifies for in-Plan transfers and loans may not be distributed as part of an in-Plan Roth transfer.

The Company will make matching contributions equal to 50% of the first 4% of compensation that a participant contributes to the Plan. In addition, the Company, at its sole discretion, may make a discretionary nonelective profit sharing contribution. For the years ended May 31, 2025 and 2024, the Company did not elect to make a nonelective profit sharing contribution.

***PARTICIPANT INVESTMENT ACCOUNT OPTIONS***

The Plan currently offers various mutual funds and a guaranteed interest fund for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

***PARTICIPANT ACCOUNTS***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contributions, as well as profit sharing contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***VESTING***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are fully vested in their rollover contributions at all times. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is fully vested after six years of credited service, subject to the vesting schedule below. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or disability.

***NOTES RECEIVABLE FROM PARTICIPANTS***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance as defined by the Internal Revenue Service ("IRS"). The maximum loan term is five years, unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

***PAYMENT OF BENEFITS***

Upon termination of service or retirement, a participant with a vested account balance that exceeds \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, or the participant may leave their account balance in the Plan until their normal retirement age.

***PAYMENT OF BENEFITS (CONTINUED)***

Upon termination of service or retirement, a participant with a vested account balance of \$1,000 or less will receive an automatic lump-sum distribution. If the vested account balance is between \$1,000 and \$5,000 and an election is not made to either receive or rollover the distribution, the distribution will be directly rolled over to an individual retirement account (“IRA”).

Upon death, the participant’s beneficiaries will receive a lump-sum amount equal to the participant’s interest in his or her account if the vested account balance is \$5,000 or less. If the vested account balance is over \$5,000, the beneficiary may elect to have the death benefit paid in a single lump-sum payment of cash, annual installments at least equal to the required minimum distribution amount, or as a qualified annuity if the beneficiary is the participant’s surviving spouse.

***FORFEITED ACCOUNTS***

The Company can use forfeitures to either offset future employer contributions or to pay administrative expenses of the Plan. Additionally, the Company may use their discretion to use forfeitures in the Plan year in which they occur or in the following Plan year.

At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$28,050 and \$24,479, respectively. For the years ended May 31, 2025 and 2024, \$16,000 and \$11,292 were used to pay administrative expenses of the Plan, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***BASIS OF ACCOUNTING***

The financial statements of the Plan are prepared on the accrual method of accounting.

***USE OF ESTIMATES***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***INVESTMENT VALUATION AND INCOME RECOGNITION***

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

***INVESTMENT VALUATION AND INCOME RECOGNITION (CONTINUED)***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***CONTRIBUTIONS***

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

***NOTES RECEIVABLE FROM PARTICIPANTS***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***EXCESS CONTRIBUTIONS PAYABLE***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. Excess contributions are returned to affected participants to maintain the Plan's qualified tax status and are generally distributed within two and a half months following the Plan year end, as required by applicable regulations.

***PAYMENT OF BENEFITS***

Benefits are recorded when paid.

***ADMINISTRATIVE EXPENSES***

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***SUBSEQUENT EVENTS***

The Plan has reviewed and evaluated subsequent events through March 11, 2026, which is the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, "Empower"), the Plan's custodians, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends and interest
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described below:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a fully benefit-responsive guaranteed investment contract with Empower invested in the Key Guaranteed Portfolio Fund (“KGPF”). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting interest rate is reviewed on a quarterly basis for resetting. The average yield earned by the KGPF, calculated by averaging the gross interest rates for the fund over the year, was 1.44% and 1.30% for the years ended May 31, 2025 and 2024, respectively. The actual yield earned by the Plan, calculated by averaging the Plan’s quarterly interest rates, was 1.44% and 1.30% for the years then ended, respectively. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and the KGPF managed by Empower. Empower is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$30,963 and \$25,604 for the years ended May 31, 2025 and 2024, respectively, which was not covered by revenue sharing. Transactions with investment advisors and auditors of the Plan qualify as party-in-interest transactions under ERISA. The Plan made direct payments to the investment advisors and auditors of \$16,284 and \$11,850 for the years ended May 31, 2025 and 2024, respectively. The remaining administrative expenses have been allocated to the accounts of participants for the years ended May 31, 2025 and 2024.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

**NOTE 8 - TAX STATUS**

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (“IRC”) and is therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At May 31, 2025, approximately 23% of the Plan's investments were invested in two funds. At May 31, 2024, approximately 10% of the Plan's investments were invested in one fund.
