To the Board of Trustees of

Opinion

We have audited the accompanying financial statements of International Association of Heat and Frost Insulators & Allied Workers Local #3 Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits – modified cash basis as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits – modified cash basis of International Association of Heat and Frost Insulators & Allied Workers Local #3 Pension Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits – modified cash basis for the years then ended, in accordance with the modified cash basis of accounting as described in Note B.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 
Supplemental Schedules Required by ERISA

NOTE A – PLAN DESCRIPTION

The following description of the International Association of Heat and Frost Insulators & Allied Workers Local #3 Pension Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. **General** – The Plan is a multiemployer defined contribution plan, which provides benefits upon retirement, death, total disability, and termination of employment in the industry to eligible members of International Association of Heat and Frost Insulators and Allied Workers Local #3 (the Union). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is sponsored and administered by the Joint Board of Trustees.
2. **Contributions** – Employers of the Union contribute to the Plan in accordance with the collective bargaining agreement with the Union subject to Internal Revenue Code (the Code) limits. The collective bargaining agreement requires contributions to the Plan at fixed rates per hour worked. The fixed rate at May 31, 2025 and 2024 was \$10.50. The Plan provides for rollover contributions from other plans qualified under the Code. Participants direct the investment of their contributions into various options offered by the Plan.
3. **Participant Accounts and Vesting** – The Plan provides for self-directed individual participant accounts. Each participant’s account is credited with (a) contributions made by their employers on their behalf, and (b) an allocation of plan earnings. Allocations of plan earnings are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. Participants can elect to invest their funds in a variety of different investment options. Participants are immediately vested in all contributions and earnings allocations credited to their accounts.
4. **Payment of Benefits** – Benefits are provided from the Plan's assets, which are accumulated under the provisions of the collective bargaining agreement and the trust agreement, and held in trust funds. Upon retirement, death, or disability, the participant's account may be distributed in the form of a lump-sum payment, an annuity, periodic payments, or a rollover to a qualified retirement plan. A participant who has retired may also elect to commence distributions of less than 100% of the participant’s account and may receive additional distributions upon request. If the value of benefits credited to a participant’s account is \$1,000 or less at the time of termination, the entire amount will be distributed without the participant’s consent.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, contributions and interest and dividends are recognized when received rather than when earned and benefits and expenditures are recognized when paid rather than when incurred.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

- 2. Investment Valuation and Income Recognition** – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustees determine the Plan’s valuation policies utilizing information provided by the investment advisors, and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- 3. Payment of Benefits** – Benefits are recorded when paid.
- 4. Expenses** – Participant accounts are charged a fee ratably based on their account balances for expenses incurred to maintain the Plan. These expenses are included in administrative expenses in the statement of changes in net assets available for benefits - modified cash basis. These expenses include recordkeeping, third-party administration, legal, and accounting fees. Fees related to the administration of benefits paid to participants are charged directly to the participants’ accounts and are included in administrative expenses.
- 5. Use of Estimates** - The preparation of financial statements in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.
- 6. Subsequent Events** – The Plan has evaluated subsequent events through March 11, 2026, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical assets in inactive markets
- Inputs other than quoted prices that are observable for the asset;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Mutual Funds – Valued at the daily closing price reported by the Fund. The funds are open-ended and are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds are deemed to be actively traded.

Guaranteed Investment Contract – Valued by multiplying the number of shares owned by the separate account's unit value.

Common Collective Trusts - Valued at the net asset value (NAV) of the interest held by the fund at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Fund will sell the investment for an amount different than the reported NAV.

The Plan has a traditional fully benefit-responsive stable value investment contract with Transamerica Life Insurance Company (Transamerica) with a balance of \$3,860,935 and \$1,945,359 at May 31, 2025 and 2024, respectively. Contributions from the Plan and credited interest are maintained in Transamerica's general account. On a semi-annual basis, Transamerica declares a guaranteed rate of interest at least 45 days before the rate becomes effective. There is no stated minimum or maximum interest rate under the contract, therefore the investment is not considered a guaranteed investment contract.

This contract meets the fully benefit-responsive investment contract criteria, therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value to non-competing funds at contract value within 30 days of the request.

The repayment of principal and interest credited to participants in the Plan is a financial obligation of Transamerica. The Plan's ability to receive amounts due is dependent on Transamerica's ability to meet its financial obligations. Transamerica's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of Transamerica or otherwise.

Transamerica may terminate the contract with 30 days advanced written notice due to significant plan changes that impact Transamerica's obligations under the contract, if the contract can no longer be treated as a pension plan contract under the Code, if the Plan is terminated, if the Plan fails to comply with the requirements under the contract, if the Plan fails to give Transamerica information needed under the contract, if the Plan fails to furnish Transamerica with copies of any amendments to the Plan or annual report records, or if the sum of the contract account values at any time equals \$20,000 or less. Transamerica may delay withdrawals or transfers in unusual conditions, including receipt of requests totaling \$20,000,000 or more or that exceed 20% of the market value of the separate account. If either of these conditions are met, the delay will be no more than 30 business days following the date on which the withdrawal or transfer would have otherwise been made.

Certain events might limit the ability of the Plan to transact at contract value, such as partial or complete contract termination by the Plan. Upon termination, the payment may be delayed up to 30 days. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

NOTE E – RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of funds managed by Transamerica Retirement Solutions, LLC which is associated with Transamerica Life Insurance Company, the Plan's custodian. Transactions within these funds qualify as party-in-interest transactions. As described in Note B, the Plan paid expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right under the Plan to discontinue the operations of the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain fully vested and the full value of their accounts will be distributed to them. Since the Plan is a defined contribution plan, it is not covered by plan termination insurance under Title IV of the Employee Retirement Income Security Act of 1974 (ERISA).

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits – modified cash basis.

NOTE H – PRIOR PERIOD ADJUSTMENT

Net assets as of June 1, 2024 has been adjusted to correct an error relating to the presentation of participant administrative service fees and income made as of May 31, 2024. The error had no effect on the change in net assets for the year ended May 31, 2025.

NOTE I – INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by letter dated January 7, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Trustees and the Plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
