Notes to Financial Statements

May 31, 2025 and 2024

NOTE A - DESCRIPTION OF PLAN

The following description of the International Association of Heat and Frost Insulators & Allied Workers Local #3 Health and Welfare Trust (the “Plan”) provides only general information. Participants should refer to the trust agreement for a more complete description of the Plan’s provisions.

General – The Plan was established in 1979 as a trust fund to administer and provide group insured health, life, accidental death and dismemberment, vision, and dental insurance coverage, plus a wellness program, medical expense reimbursement account, and bank plan to eligible members of the International Heat and Frost Insulators & Allied Workers Local No. 3 (Union) and their dependents. Active employees of contributing employers and certain retirees are eligible for coverage under the Plan. The Plan requires active employees of contributing employers to work 288 hours in 9 consecutive months, 144 hours worked each month on an ongoing basis, to be eligible for coverage under the Plan. The Plan is a multiemployer health and welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the Joint Board of Trustees of the Plan.

Benefits - Benefits offered by the Plan are not guaranteed to the employees, retirees, or dependents covered by the Plan. The Board of Trustees of the Plan anticipates that it will continue the benefits indefinitely, but reserves the right to modify or discontinue the benefits at any time, to establish and modify eligibility rules, benefits, and self-payment requirements, and to limit the right of participation to specific groups or classes.

Contributions – The trust agreement provides that employers make monthly contributions to the Plan of a specified amount for each hour worked to provide benefits for eligible employees. The collective bargaining agreements require contributions to the Plan at fixed rates per hour worked. Fixed rates at May 31, 2025 and 2024 were \$15.80 and \$15.30, respectively. Participants who are no longer receiving employer contributions due to termination, reduction in hours, disability, or retirement may self-pay contributions to continue to receive benefits from the Plan.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Modified cash basis recognizes revenue and the related assets when received and expenses when paid. Under the requirements of generally accepted accounting principles, revenue and the related assets are to be recognized when earned and expenses are to be recognized when incurred.

Benefit Obligations – As the Plan does not provide post-retirement benefits, FASB ASC 965 does not require actuarial determination of benefit obligations. The Plan’s benefit obligations represent management’s estimates based on current Plan provisions and past experience.

Use of Estimates – The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

NOTE B – SUMMARY OF ACCOUNTING POLICIES – Continued

Cash and Cash Equivalents – The Plan’s cash balances on deposit with financial institutions may exceed Federal Deposit Insurance Corporation (FDIC) limits.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustees determine the Plan’s valuation policies by utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value of measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses in investments bought and sold as well as held during the year.

Fringe Benefits Payable - Amounts received by the Plan in excess of agreed upon member contribution rates or not attributable to plan operations are recorded as Fringe Benefits Payable liabilities on the Statements of Net Assets Available for Benefits - Modified Cash Basis.

Administration of the Plan – The Plan’s expenses are paid by the Plan as provided by the trust agreement. Expenses incurred in connection with the general administration of the Plan and investment related expenses that are paid by the Plan are recorded as deductions in the Statements of Changes in Net Assets Available for Benefits – Modified Cash Basis.

Subsequent Events – Management has evaluated subsequent events for the Plan through March 11, 2026, the date the financial statements were available to be issued.

NOTE C – INVESTMENTS

The Plan’s investments are held by an administered trust fund.

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs into valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

NOTE D – FAIR VALUE MEASUREMENTS – Continued

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If an asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation of the method used for assets measured at fair value. There have been no changes to the methodologies used at May 31, 2025 and 2024.

Money Market Funds & Certificates of Deposit – Valued at the closing price reported on the active market on which the individual securities are traded.

Registered Investment Companies – Valued at the daily closing price reported by the fund. The funds are open-ended and are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

NOTE E – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F – TERMINATION OF THE PLAN

In the event of termination of the Plan, the amount in the Plan will be applied, subject to administration and liquidation expenses, to prepare a final accounting of the trusteeship and to pay obligations of the Plan. Any remaining surplus will be distributed in such a manner as will best effectuate the purpose of the Plan, as determined by the Trustees.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

Certain plan assets are invested in securities managed by the custodian of the Plan. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are considered party-in-interest transactions under ERISA.

NOTE I – PRIOR PERIOD ADJUSTMENT

The accompanying financial statements as of May 31, 2024 have been restated to correct an error made as of May 31, 2024. The effect of the restatement was to increase the medical reimbursement account balance as of May 31, 2024 by \$538,219 and the change in net assets for the year then ended by \$538,219.

NOTE J – ESTIMATED FUTURE BENEFIT OBLIGATIONS LIABILITY

The maximum accumulated eligibility credits within the Plan at any month end is equal to the dollars representing contributions for hours worked, not to exceed \$16,000 per participant. Dollars representing contributions for 144 hours will be deducted from the participants' accounts each month to pay for coverage. Any amounts contributed for hours in excess of 144 hours worked in a month will result in credits to the participants' accumulated eligibility credits accounts as a reserve, to help provide with continued eligibility for benefits in the months when the participants may have not worked 144 hours. The total amount of estimated future benefit obligations liability for the years ended May 31, 2025 and 2024, is \$1,460,000 and \$1,178,439, respectively.
