INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Cook Area Health Services, Inc. Tax Sheltered Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Cook Area Health Services, Inc. Tax Sheltered Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended May 31, 2025 and 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material

respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **NOTES TO FINANCIAL STATEMENTS
Years Ended May 31, 2025 and 2024**

NOTE A – DESCRIPTION OF PLAN

The following description of the Cook Area Health Services, Inc. (“Organization”) Tax Sheltered Annuity Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. *General* – The Plan is a defined contribution plan covering all full-time employees of the Organization, who are age 21 or older and have one year of service to be eligible for employer nonelective contributions. Employees working at least sixteen hours per week are immediately eligible for elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).
2. *Contributions* – Each year, participants may contribute a percentage or dollar amount of their pre-tax or post-tax (designated Roth) annual compensation, as defined in the Plan, up to an annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan and may make changes at any time. At the discretion of the Organization’s Board of Directors, additional nonelective contributions may be made to the Plan. For the year ended May 31, 2025, the Organization contributed \$171,380. For the year ended May 31, 2024, there were no nonelective contributions made by the Organization. Contributions are subject to certain IRS limitations.
3. *Participant Accounts* – Each participant’s account is credited with the participant’s contributions, as well as allocations of the Organization’s non-elective contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
4. *Vesting* – Participants are immediately vested in all contributions plus actual earnings thereon.
5. *Payment of Benefits* – Benefits are paid to the participant or beneficiary upon death, disability, financial hardship, normal retirement age (age 65), in-service distribution (age 59 ½), or termination of employment, subject to plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. If a participant’s vested interest at termination of employment is \$1,000 or less, it will be distributed in a lump sum as soon as administratively feasible. The distribution will be made to the participant or, if elected, will be rolled over either to another qualified retirement plan that agrees to receive the distributions or to an individual retirement account (IRA).

If the vested interest is more than \$1,000 at termination of employment because of retirement on or after normal retirement age or because of disability, the vested interest will generally be distributed within an administratively feasible time after termination. If employment is terminated for other reasons, the vested interest will generally be distributed

within an administratively feasible time after payment is requested. The vested interest will be distributed in a lump sum which can be paid to the participant, or if elected, can be rolled over either to another qualified retirement plan that agrees to receive the distribution or to an individual retirement account.

6. *Forfeitures* – Participant forfeitures will be used to pay administrative expenses. Any remaining forfeitures may be added to any Organization non-elective contribution. At May 31, 2025 and 2024, forfeited nonvested accounts total \$12,900 and \$5,993, respectively.
7. *Reclassifications* – Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE D – FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. NAV's are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source, such as Interactive Data Corporation (IDC). The mutual funds held by the Plan are deemed to be actively traded.

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will have a 100 percent vested interest in their accounts and all accounts will be available for distribution at the same time and in the same manner as would have been permissible had the Plan not terminated.

NOTE G – TAX STATUS

On December 1, 2019, the Plan adopted a new volume submitter plan which is intended to comply with the provisions of Code Section 403(b) and, to the extent applicable, the provisions of Title I of ERISA. The Document Agility, Inc. Volume Submitter 403 (b) Plan received its latest determination letter on August 2, 2017, in which the IRS stated that the form of the plan is acceptable under section 403(b) of the Internal Revenue Code for use by eligible employers for the benefit of their employees. The Plan administrator believes the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Capital Bank & Trust (CB&T) who is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

CB&T provides certain administrative services to the Plan pursuant to a Recordkeeping Services Agreement (RSA) between the Organization and CB&T. CB&T receives revenue from mutual fund service providers for services CB&T provides to the funds. This revenue is used to offset certain amounts owed to CB&T for its administrative services to the Plan.

Big Sky Retirement, Inc. is a third-party administrator for the Plan. Big Sky Retirement provides services such as recording the employer contributions, filling out form 5500 and testing requirements.

If the revenue received by CB&T from such mutual fund service providers exceeds the amount owed under the RSA, CB&T remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2025, excess amounts of \$6,175 were credited to the Plan but not used to pay administrative expenses. During 2024, excess amounts of \$2,276 were credited to the Plan but not used to pay administrative expenses.

The Plan or Plan Sponsor may make a payment to CB&T for administrative expenses not covered by revenue sharing.

NOTE K – SUBSEQUENT EVENTS

Subsequent events were evaluated through March 13, 2026, which is the date the financial statements were available to be issued.
