Independent Auditor's Report

Opinion

We have audited the financial statements of Bank Midwest and Affiliates Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year then ended September 30, 2025, and the related notes to the financial statements.

Note 1 - Description of Plan

The following brief description of the Bank Midwest and Affiliates Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The common stock of Bank Midwest is 100% owned by Goodenow Bancorporation (Goodenow) therefore, all employer stock under the Plan is common stock of Goodenow Bancorporation (collectively, Bank Midwest and Goodenow Bancorporation will be referred to as the Company). As of September 30, 2025, all stock was allocated to participants. The Plan is administered by the ESOP committee of the Company.

Eligibility

Employees of the Company and its affiliates are eligible to participate in the Plan after they have completed one hour of service and are 20½ years of age. Leased employees, members of a collective bargaining agreement, and non-resident aliens are not eligible to participate in the Plan.

Entry Date

Employees may enter the Plan on the first day of each month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

The Company contributes an amount at the discretion of the Company's Board of Directors, as defined in the Plan, which was 3% of a participant's eligible compensation for the year ended September 30, 2025. The Company contributions will be allocated according to the pro rata share of each participant's compensation to total eligible compensation. Participants must have at least 1,000 hours of service during a Plan year and must be employed on the last working day of the Plan year to share in the Company contributions, unless the participant has terminated employment during the Plan year on account of death, disability, or retirement at or after normal retirement age of 65.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised with respect to any corporate matter that requires shareholder voting and involves approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of the Plan sponsor, or similar transactions. Some of the employer stock in the Plan may not be allocated to the account of any participant at the time a vote is required and some of the participants to whose accounts the employer stock is allocated may decide not to instruct the trustee as to the voting of that stock. The trustee will vote those shares, and all shares in all other matters.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of their account which is invested in shares of employer stock. In the sixth year, the percentage increases to 50%. Participants who elect to diversify may elect to receive a cash distribution or rollover their account balance into the Bank Midwest 401(k) Profit Sharing Plan and Trust. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Participant Accounts

Each participant's account is credited as of the last day of the Plan year with an allocation of shares of Goodenow common stock and forfeitures of terminated participants' non-vested accounts and Plan earnings, and charged with payments of benefits and Plan losses. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company's contribution portion of participants' accounts and related earnings thereon is based on years of continuous service. Vesting is based on years of credited service as set forth in the following table:

Participants are 100% vested in their account balances upon retirement, death or disability.

Forfeitures

At September 30, 2025 and 2024, there were no forfeited non-vested accounts. Forfeited accounts are used to reduce future employer contributions or allocated to eligible participants. During the year ended September 30, 2025, forfeited non-vested accounts totaling \$17,635 were allocated to eligible participants.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or monthly, quarterly, or annual installments as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a vested balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a vested balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account or Individual Retirement Annuity of an eligible financial institution.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investment is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on the investment bought and sold, as well as held during the year.

The classification of investment earnings (losses) reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid by the Plan sponsor, as provided by the Plan document. Expenses that are paid directly by the Plan sponsor are excluded from these financial statements.

In the month of April 2025, the Plan sold 207 shares of common stock for \$458,504.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2025 and 2024.

Interest-bearing cash: Valued at carrying value, which approximates fair value, based on the amount of net contributions, plus any investment earnings allocated to the account.

Goodenow common stock: The fair value of the Goodenow common stock held by the Plan is valued at fair value based upon an independent appraisal. The appraisal considered the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, discount rate, market comparables, estimated fair value of Goodenow assets and liabilities and discount for lack of marketability and lack of control.

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 4, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-In-Interest Transactions

The Plan's investment in Goodenow Bancorporation common stock is the common stock of the parent company of the Plan sponsor. The Plan holds an interest-bearing cash account with the Plan sponsor. The balance on the interest-bearing cash accounts may exceed the federal deposit insurance limits and, therefore, subject the Plan to credit risk. Dividends of \$313,308 on common stock were paid by Goodenow during the year ended September 30, 2025. Interest income on the interest-bearing cash account of \$4,738 was paid by the Plan sponsor to the Plan during the year ended September 30, 2025. These transactions qualify as related party and exempt party-in-interest transactions under ERISA.

Note 7 - Risk and Uncertainties

The Plan's investments consist primarily of the Plan sponsor's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 8 - Right of First Refusal

Company stock that has been distributed to a participant and not immediately repurchased by the Company or trust, may be subject to a right of first refusal if so determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the trust at fair market value as determined by an independent appraiser appointed by the ESOP Committee.

Note 9 - Dividends

Goodenow Bancorporation paid dividends of \$313,308 on common stock during the year ended September 30, 2025, all of which were allocated to the participants.

Note 10 - Subsequent Events

On January 13, 2026, the Plan sold 400 shares of common stock to the Company for \$960,000.

The Plan sponsor has evaluated subsequent events through February 23, 2026, the date which the financial statements were available to be issued.
