- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

*Other Matter - Supplemental Schedule Required by ERISA*

The supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of June 30, 2025, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements June 30, 2025

### Note 1 - Description of the Plan

The following description of The Wadsworth Atheneum Money Purchase Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution, noncontributory money purchase pension plan established effective July 1, 1979, and most recently amended and restated effective July 1, 2021. The Plan covers eligible employees of the Wadsworth Atheneum Museum of Art (the "Museum") excluding union employees and leased employees. Employees who are eligible to participate have attained age 21 and have completed one year of service with a minimum of 1,000 hours worked. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees of the Museum is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### **Contributions**

The Museum makes a contribution semi-annually of 5% of earnings of eligible employees, as defined in the Plan. The employee must be employed on the last day of the contribution period and complete 500 hours of service during the contribution period to be eligible to qualify for the contribution. The Museum's contributions are invested directly in variable annuity contracts, a nonfully benefit-responsive fixed annuity contract, and a pooled separate account, as directed by the participant. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

#### **Participant accounts**

Each participant's account is credited with the allocation of the Museum's contribution as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Vesting in the Museum's contributions is based on years of service. A participant is 100% vested after three years of credited service. However, if an active participant dies prior to the normal retirement age, becomes totally disabled or satisfies the conditions for early retirement, then the participant's account becomes 100% vested.

#### **Payment of benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive the value of their account as a lump-sum distribution, as a partial distribution, or as installment payments, or they may elect to receive their benefits as a life annuity contract upon retirement or termination. The Plan permits distribution of accounts with vested balances of \$5,000 or less after severance of employment without participant or spousal consent. Benefit claims are recorded as expenses when they have been paid by the Plan.

#### **Forfeited accounts**

At June 30, 2025 and 2024, forfeited nonvested matching accounts totaled \$38,926 and \$43,672, respectively. For the year ended June 30, 2025, \$27,279 nonvested amounts were utilized to reduce employer contributions.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by Teachers Insurance and Annuity Association ("TIAA") and College Retirement Equities Fund ("CREF"), the insurance entities holding certain investments and also the recordkeeper as an agent for TIAA Trust, N.A., the custodian of other investments of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Participant contributions from the Museum are recorded in the year in which the contributions are earned.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Museum. Expenses that are paid by the Museum are excluded from these financial statements. The Plan incurred investment management fees and plan services expenses, which are presented on the statement of changes in net assets available for benefits within the Plan's financial statements.

##### **Subsequent events**

The Plan has evaluated subsequent events through March 4, 2026, the date the financial statements were available to be issued.

#### Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2025 and 2024, and investment income for the year ended June 30, 2025, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA and CREF.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under the Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Variable annuity contracts:* Valued at the unit value as reported by the account. The unit values are listed on the National Association of Securities Dealers Automated Quotations ("NASDAQ") website and updated overnight for each day that the NASDAQ is open. The accounts held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued at the unit value as reported by the fund, which is based on the fair value of the underlying assets of the account, as provided by TIAA and CREF.

*Nonfully benefit-responsive fixed annuity contract:* Valued based on the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. These annuity contracts are not available for sale or transfer on any securities exchange. Withdrawals under the retirement annuity contracts may be made in the form of a life annuity or in 10 annual installments.

### **Note 5 - Related party transactions and party-in-interest transactions**

Certain Plan investments were invested in funds managed by TIAA and CREF. TIAA and CREF are the insurance entities holding certain investments and also the recordkeeper as agent for TIAA Trust, N.A., the custodian holding other investments of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### **Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their individual accounts.

### **Note 7 - Tax status**

The prototype plan document, which the Plan has adopted in a nonstandardized adoption agreement, obtained its latest opinion letter on October 7, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not yet filed for an individual determination letter. Although the Plan's adoption agreement has been amended since receiving the opinion letter on the prototype plan, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
