1. DESCRIPTION OF THE PLAN

The following brief description of the Kelley Automotive Group Health and Welfare Plan is provided for general information only. Participants should refer to the Plan Agreement for more complete information.

GENERAL - The Plan provides medical benefits covering full time employees of the following companies: Courtesy Ford Motors, LLC, Kelley Courtesy Motors, LLC, Kelley Buick GMC, LLC, Kelley Cadillac, LLC, Tom Kelley Volvo, LLC, Kelley Chevy, LLC, 14/69 Carwash, LLC, Kelley Automotive Group, LLC, Kelley Auto Imports, LLC, TKCD, LLC, Decatur Auto Accessories, LLC, Tom Kelley Jaguar Land Rover, LLC, Kelley Imports Real Estate, LLC, Kelley Body Shop, LLC, and Midwest Auto Parts, The Plan became effective June 1, 1986, and has a year end of May 31. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS - The Contributions are provided by the employers and employees. The contribution rate is determined annually.

FUNDING - The Plan is split-funded. The self-insured portion covers benefits up to \$135,000 per covered person. The insured portion covers benefits above the limits specified above (excess coverage) and are paid by the insurance carrier.

BENEFITS - The Plan provides medical benefits (hospital, surgical, medical, dental, and major medical) for the participants of the Plan.

ADMINISTRATIVE - The Plan Administrator is responsible for administering the benefit plan. The Third Party Administrator, Unified Group Services, Inc., is responsible for processing the medical claims of the participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING - The financial statements of the Plan are prepared on the accrual basis of accounting.

CASH AND CASH EQUIVALENTS - Cash equivalents consist of an interest-earning money market account and checking account.

ESTIMATES - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INSURANCE PREMIUMS - The insurance premiums for excess coverage are reflected as a deduction from Plan assets (expenses) and do not give rise to a Plan asset.

CONCENTRATIONS OF CREDIT RISK - Financial instruments which potentially subject the Company to concentrations of credit risk consist principally of cash deposits. The Company generally is exposed to credit risk from balances on deposit in financial institutions in excess of the FDIC-insured limit.

TAX STATUS - The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code as a tax exempt organization. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsor believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of May 31, 2025, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of May 31, 2025, the Plan's federal tax returns generally remain open for the last 3 years.

SUBSEQUENT EVENTS - The Plan has evaluated subsequent events through **---DATE---** the date the financial statements were available to be issued.

3. ACCOUNTS RECEIVABLE - SPONSORS

Accounts receivable, sponsors, represents the additional contributions due from the sponsors to cover the claims incurred as of May 31, 2025, but reported to the Plan subsequent to May 31, 2025.
