Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of InterCam Financial Services, Inc. Cash Balance Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets in liquidation available for benefits as of May 13, 2025 and December 31, 2024, and the related statements of net assets available for benefits in liquidation for the period January 1, 2025 through May 13, 2025 and year ended December 31, 2024, the statements of accumulated plan benefits as of May 13, 2025 and December 31, 2024, and the related statements of changes in accumulated plan benefits for the period January 1, 2025 through May 13, 2025 and year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 13, 2025 and December 31, 2024, and for the period and year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Intercam Financial Services, Inc. Cash Balance Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(c) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 2 to the financial statements, the governing body of Intercam Financial Services, Inc. Cash Balance Plan approved a plan of liquidation by the governing body on September 1, 2023. The Plan's assets were transferred on May 13, 2025. Accordingly, the accompanying financial statements for the period from January 1, 2025 through May 13, 2025, are prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Intercam Financial Services, Inc. Cash Balance Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF PLAN

The following description of the Intercom Financial Services, Inc. Cash Balance Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established January 01, 2015, by Intercom Financial Services, Inc. (the "Company").

On July 10, 2021, the Plan was amended to freeze Principal Credits and accumulation of benefits for all participants in the Plan.

Plan Termination

The Company terminated the Plan on September 1, 2023. Upon termination, all participant accounts became 100% vested. The net assets were distributed to participants on May 13, 2025. Participants may elect an annuity, lump-sum payment, individual retirement account rollover, or direct transfer into one of the Company's other plans.

Eligibility

Participation in the Plan was available to all employees who have reached the age of 18 years and have completed 1 year of consecutive service. The Plan excludes those employees covered by a collective-bargaining agreement, leased employees, or non-resident aliens with no earned income in the United States of America.

Pension Benefits

The Company made Principal credits to the Plan with the amount specified below at the end of each principal credit period, depending on the group that applies to the employee.

Members of group one:

The Company would credit the participant accounts with 100% of compensation at the end of each principal credit period during which the participant satisfies the service requirement of completion of at least 1,000 hours of service. Group one consists of the owner.

Members of group two:

The Company would credit the participant account with 1.3% of compensation at the end of each principal credit period during which the participant satisfies the service requirement of completion of at least 1,000 hours of service. Group two consists of all other employees.

Employees were not permitted to make contributions to the Plan.

Participant accounts would be credited at the end of each Plan year with an annualized interest rate of 5% by multiplying the participant account balance as of the first day of each Plan year.

Death Benefits

Upon termination of service due to death or retirement, benefits were paid either in a lump-sum, in the form of a single life annuity, or in equal installments over a period not more than the participant's or designated beneficiary's assumed life expectancy at the time of distribution. The maximum annual benefit a participant may earn in the Plan is limited to \$230,000. In addition, participant's benefit cannot exceed 100% of the highest three-year average compensation. No distributions from the Plan would be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. All benefit payments were made on May 13, 2025. No benefit payments were made for the year ended December 31, 2024.

Participant Accounts

The Plan was a defined benefit plan under which a separate hypothetical individual account is established for each participant. Each participant's account was credited as of the last day of each principal credit period with Principal and Interest credits. All eligible participants will receive Principal and Interest credits.

Vesting

Participants became 100% vested in their account balances after completing three years of service, based on a three-year cliff vesting schedule. Participants must be at least 18 years old and have worked at least 1,000 hours in a Plan year to receive credit for a full year of service. If a participant's employment ends for reasons other than normal retirement, death, or disability, vesting is based on total years of service in the Plan.

Upon the Plan's termination effective September 1, 2023, all participant accounts became 100% vested, regardless of prior service or vesting status, in accordance with ERISA and the Plan's provisions. As a result, no forfeitures of non-vested account balances occurred for the period ended May 13, 2025, or for the year ended December 31, 2024.

Forfeitures

There were no forfeitures of terminated participants' non-vested account balances for the period ended May 13, 2025, or for the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting and Adoption of the Liquidation Basis of Accounting

Effective September 1, 2023, the Plan adopted the liquidation basis of accounting because the Plan Administrative Committee approved an amendment to terminate the Plan, and liquidation was considered imminent. Under the liquidation basis of accounting, assets are generally measured at their estimated net realizable values and liabilities are stated at their estimated settlement amounts as of the reporting date. The adoption of the liquidation basis of accounting results in financial statements that are not comparable to those prepared on a going concern basis.

Management has evaluated liabilities expected to be incurred during the liquidation process and determined no additional liabilities are required to be recognized as of the reporting dates.

As of the adoption date and through May 13, 2025, the Plan's assets and liabilities were not remeasured, as management determined that their carrying values approximated their estimated net realizable values and settlement amounts. No changes in estimated liquidation values have occurred or been recognized since the adoption of the liquidation basis. Accordingly, the amounts reported in the financial statements reflect the carrying values as of September 1, 2023, and no further remeasurement was deemed necessary.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses

Certain expenses of maintaining the Plan, such as recordkeeping, legal, audit, and other administrative services, were paid by the Plan unless otherwise paid by the Company. Expenses paid directly by the Company are not included in these financial statements. Investment-related expenses are included in the net appreciation (depreciation) of the fair value of investments.

For the period ended May 13, 2025, administrative expenses included routine plan administration costs, as well as one-time expenses related to the termination and liquidation of the Plan. No significant nonrecurring or unusual expenses were paid by the Plan Sponsor on behalf of the Plan during the period.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, as defined by Accounting Standards Codification (ASC) 820, Fair Value Measurement (Note 4). All security transactions are accounted for on the date securities are purchased or sold (trade-date basis). Realized gains and losses are computed based on the fair value of assets at the trade-date. Dividends, which include capital gain distributions, are accrued as of the ex-dividend date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized gains and losses and the unrealized appreciation (depreciation) from those investments.

Management fees charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately disclosed. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments and reflected in the net appreciation (depreciation) in the fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to service rendered by employees as of the valuation date. Accumulated Plan benefits include benefits expected to be paid to: (i) retired or terminated employees or their beneficiaries; (ii) beneficiaries of employees who have died; and (iii) present employees or their beneficiaries. The actuarial present value of accumulated Plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The effect of Plan amendments on accumulated Plan benefits is recognized during the year in which such amendments are adopted.

An actuary estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected payment date.

There were no changes in actuarial assumption upon adoption of the liquidation basis of accounting.

Funding Policy

Contributions to provide benefits under the Plan are made solely by the Sponsor. The Sponsor's funding policy is to make cash contributions to the Plan as determined by the Plan's independent actuary. The Sponsor met the minimum funding requirements of ERISA for the period ended May 13, 2025 and year ended December 31, 2024.

3. UNAUDITED INVESTMENT INFORMATION CERTIFIED BY THE CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Ascensus Trust as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

- A. All investment balances reflected in the accompanying Statements of Net Assets Available for Benefits as of May 13, 2025 and December 31, 2024;
- B. All investment activity reflected in the Statements of Changes in Net Assets Available for Benefits for the period ended May 13, 2025 and year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at May 13, 2025 and December 31, 2024.

Mutual funds: Valued at daily closing prices as reported by the Fund. Mutual Funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The Mutual Funds held by the Plan are deemed to be actively traded.

5. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated October 1, 2019, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended effective January 1, 2020, and has not received an updated determination letter. The administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 13, 2025. There are no uncertain tax

positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market, foreign exchange, and credit risk. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. The value, liquidity, and related income of securities with contractual cash flows are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the change in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits. Investments are subject to, among other factors, the risk conditions of the individual investment objectives, stock market performance, credit markets, interest rates, economic conditions, and world affairs.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

7. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

The Company pays all Plan expenses. The Company is the sponsor of the Plan and, therefore, these are related-party and party-in-interest transactions. Sponsor contributions are held and managed by the Ascensus Trust. As a result, these are party-in-interest transactions. The Plan has a number of service providers, which are parties in interest under ERISA.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through March 09, 2026, the date the financial statements were available to be issued, and has determined that no other events require disclosure.

Following the distribution of all Plan assets on May 13, 2025, the Plan ceased operations and no further activity is expected.

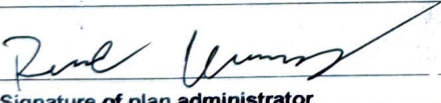
