Independent Auditors' Report

Opinion

We have audited the financial statements of Avon Grove Charter School Employee Dental Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits--modified cash basis as of August 31, 2025 and 2024, the related statement of changes in net assets available for benefits--modified cash basis for the year ended August 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits--modified cash basis as of August 31, 2025 and 2024, and the changes in net assets available for benefits--modified cash basis for the year ended August 31, 2025 in accordance with the cash basis of accounting described in Note B.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Avon Grove Charter School Employee Dental Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules (modified cash basis), we evaluated whether the supplemental schedules (modified cash basis), including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the Avon Grove Charter School Employee Dental Benefit Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan covers all full-time employees of Avon Grove Charter School (the "Company") and their spouses or domestic partners and eligible dependents. In 2016, the Plan sponsor contracted with Veris Benefits Consortium to self-fund medical insurance benefits. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Benefits

The Plan provides medical, dental, vision, life, short and long term disability benefits to the full-time employees and their eligible dependents. All full-time employees are eligible after 30 days employment.

Self-Insured Benefits

The Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

The Company and the participants' share the premiums for the self-funded medical insurance with the participants contributing based on bi-weekly payroll deductions in accordance with the provisions of the plan. The Company covers 100% of the dental premiums available in the plan. The Company and the participants share the premiums for the vision benefits available in the plan with the participant contributing based on bi-weekly payroll deductions in accordance with the provisions of the plan. The participants pay 100% of the premiums for the optional vision, short term disability, long term disability and life benefits available in the plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of participants' accounts shall be in accordance with the Plan document. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions are recorded when received and are not accrued. Benefits paid and premiums/fees paid are expensed when paid and are not accrued. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; claims incurred but not reported; eligibility credits; claims payable; and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of cash deposits. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At August 31, 2025, the Plan had approximately \$1,596,818 in excess of federally insured amounts. Amounts not covered by the FDIC may be covered by the Plan's Fidelity Bond insurance. Plan management does not believe this has a material impact on the financial statements.

Tax Status

The trust established under the Plan to hold the Plan's assets is not qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is not exempt from income taxes. Avon Grove Charter School, the plan sponsor, files form 1041 each year to pay the tax on the trust's net investment income. The Plan did not make any income tax payments for the year ended August 31, 2025, and as such, no provision was recorded for income taxes paid. Income taxes are recorded when paid.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of Benefits

Health claims and premiums are reported when paid. Premiums paid by either the Company or the trust are recorded as claim payments to healthcare providers and premium payments for healthcare and insurance in the accompanying statement of changes in net assets available for benefit--modified cash basis.

Stop Loss

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in premium payments for healthcare and insurance in the accompanying statement of changes in net assets available for benefits--modified cash basis. During the year ended August 31, 2025, stop loss reimbursements netted against claim payments to healthcare providers paid on the statement of changes of net assets--modified cash basis were \$753,448.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan Sponsor by making a contribution to the plan's trust account. Veris Benefit Consortium provides an invoice for the administrative expenses due each month. The contribution receipt and the payment of the administrative expenses is recorded in plan's trust activity.

Cash and Cash Equivalents

Cash included currency on hand, demand deposits, and highly liquid investments purchased with financial institutions with a maturity of three months or less.

Date of Management's Review

Management has evaluated subsequent events through March 11, 2026, the date which the financial statements were available to be issued.

NOTE C - CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at August 31, 2025 and 2024 for claims incurred but not reported are estimated by the Plan's management in accordance with accepted principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.
