INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Furniture and Industrial Carpenters Health Plan:

Opinion

We have audited the financial statements of Furniture and Industrial Carpenters Health Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, information regarding Furniture and Industrial Carpenters Health Plan's net assets available for benefits and benefit obligations as of May 31, 2025 and 2024, and the changes in the net assets available for benefits and changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Furniture and Industrial Carpenters Health Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Furniture and Industrial Carpenters Health Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Furniture and Industrial Carpenters Health Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of Furniture and Industrial Carpenters Health Plan (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific method used for the Plan’s investment class is presented below:

Money Market Fund - The fair value of the money market fund is based on the total value of all securities held using the amortized cost method. Generally, the amortized cost approximates the current fair value. The fund seeks to maintain a net asset value of \$1.00 (Level 2).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date.

Contributions Receivable

Employer contributions due and not paid prior to year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Accumulated Eligibility Credits

Accumulated eligibility credits include the cost of benefits associated with eligibility earned based on work performed by participants through May. The Plan's obligations for benefits based on participants' accumulated eligibility credits were estimated based on premiums experience.

In addition, effective January 1, 2023, the Plan is amended to provide extended eligibility credit for qualifying participants of the Plan up to a maximum of three months. Refer to Note 2 for further information.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. The significant estimates affecting the financial statements are the benefit obligations and changes in benefit obligations. Actual results could differ from these estimates.

Risks and Uncertainties

The Plan invests in money market funds. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The following description of Furniture and Industrial Carpenters Health Plan (the "Plan") provides only general information.

The Plan was established by the terms of an agreement and declaration of trust, as restated May 31, 1990, for the purpose of providing health and welfare benefits to eligible employees and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility is provided if a participant was actively at work for 87 hours or more in the previous month and the participating employer pays the required contributions to the Plan on the participant's behalf in the month following the month in which the participant worked.

Participants have the option of electing medical benefits and, when applicable, prescription drug benefits under the Plan through Kaiser Foundation Health Plan. Dental benefits are provided by Delta Dental and Safeguard Health plans.

Life and accidental death and dismemberment benefits are underwritten by Prudential. Vision benefits are provided by Vision Service Plan. All benefits are for participants and their beneficiaries who meet the Plan's minimum eligibility requirements.

The Plan does not provide benefits for retirees; therefore, no post-retirement benefit obligations exist at the financial statement date. Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), has been adopted by the Plan.

Effective January 1, 2023, the Plan is amended to provide extended eligibility credit for qualifying participants of the Plan. Participants are credited one month of extended eligibility for each consecutive 12-month period of coverage under the Plan, up to maximum of three months of extended eligibility. The measurement period for the 12 months of consecutive coverage will begin the month participants earn initial eligibility, the month participants regain eligibility subsequent to losing eligibility, or January 1, 2023, whichever is later. All extended eligibility months must be used if participants do not meet the continuing eligibility criteria, and participants cannot defer use of extended eligibility months.

Participants should refer to the summary Plan description and recent Plan amendments, which increase various benefits, for more complete information.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated June 29, 1990, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan and the related trust continue to be tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of May 31, 2025, and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by employer contributions and from members electing COBRA coverage. The contribution rate is specified in the collective bargaining agreements.

6. CASH CONCENTRATION

The Plan places its cash with financial institutions. The balances are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000 per institution. Cash balances at May 31, 2025 and 2024, exceeded the insured deposit limits by approximately \$1,957,000 and \$2,685,100, respectively. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations and cash flows.

7. MAJOR EMPLOYERS

As of May 31, 2025 and 2024, the Plan had four employers that accounted for approximately 85% and 81%, respectively, of the Plan's employer contributions. In the event that any of these employers suspend contributions, the Plan would terminate coverage of the employers' participants, as required under the Plan document. The Plan would retain the risk of current fixed administrative expenses until the appropriate adjustments were made.

8. RELATED-PARTY TRANSACTIONS

Members of the Plan's Board of Trustees are also members of the Industrial Carpenters and Precast Pension Plan. Employer contributions for the various Furniture and Industrial Carpenters Trust Funds are initially deposited into a transit account, which is included in cash on the statements of net assets available for benefits. Funds deposited into the transit account and allocated to applicable entities for the years ended May 31, 2025 and 2024, totaled approximately \$8,322,000 and \$7,375,000, respectively. The monies are invested into a non-interest-bearing cash account for approximately one month, until the allocation process is complete, and the contributions are then transferred to the appropriate entities in the following month.

As of May 31, 2025 and 2024, approximately \$330,000 and \$475,000, respectively, reflect amounts collected on behalf of other Furniture and Industrial Carpenters Trust Funds that were not transferred to them by the Plan's year-end.

9. SUBSEQUENT EVENTS

Subsequent events were evaluated through March 12, 2026, on which the financial statements were available to be issued. This date is approximately the same as the independent auditor's report date. No subsequent events have occurred that require recognition or disclosure in these financial statements.
