- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The ERISA-required supplemental Schedule H, Line 4i- Schedule of Assets (Held at End of Year) as of June 30, 2025 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of the Plan

The following description of the United Cerebral Palsy of Queens, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan is sponsored and administered by United Cerebral Palsy of Queens, Inc. d/b/a Queens Centers for Progress (QCP or the Employer).

General

The Plan is a defined contribution plan available to all employees of QCP who have completed at least 1,000 hours of service in one year and are at least 21 years old. Union and leased employees, and non-resident aliens are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration

The Plan is administered by four trustees who are appointed by the Board of Directors of QCP and constitute the Pension Committee. The trustees have appointed Long Island Employee Benefits Group, Ltd. (LIEBG) as a third-party administrator. John Hancock Trust Company LLC is the custodian of the Plan.

Participant Accounts

Each participant's account is credited with QCP discretionary contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions

Under the terms of the Plan, the annual Employer contribution is a discretionary amount approved by the Board of Directors of QCP and is allocated among Plan participants who are employed on the last day of the Plan year based on a formula that takes into account each participant's years of service and eligible compensation for the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employer contributions are subject to certain Internal Revenue Service (IRS) limitations. Employee contributions are not allowed in the Plan.

Vesting

All participants become fully vested after the completion of three years of service. Participants are 0% vested for less than three years of service. Participants are always 100% vested in any balance in their rollover contribution account.

Plan Benefits

On retirement, death, disability, or termination of service, a participant (or the participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance, or to be paid in installments as described in the Plan

document. In addition, an accelerated distribution is permitted if certain criteria, including hardship, are met.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 1% at the time the loan is taken. The term of the loan is five years or less, unless the funds are utilized to acquire a principal residence, in which case the term may be longer. A participant is allowed up to five loans outstanding. Principal and interest are paid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, and at any time thereafter, a participant may direct rollovers and Employer contributions and any related earnings into a wide variety of investment fund options offered by the Plan.

Forfeited Accounts

At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$1,470 and \$43,242, respectively. Forfeitures may be used to pay Plan expenses or reduce Employer contributions. During the years ended June 30, 2025 and 2024 the forfeiture account earned \$1,466 and \$1,550, respectively. During the years ended June 30, 2025 and 2024, \$1 and \$20,261, respectively, were forfeited. During the years ended June 30, 2025 and 2024, \$43,239 and \$3,630, respectively, were used to offset employer contributions.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by QCP, including legal and auditing, and are excluded from these financial statements. Other administrative expenses, such as distribution and loan fees, are paid for by the Plan.

Contributions Receivable

The Employer discretionary contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

3. Risk and Uncertainties

The Plan provides various options for investment securities. These securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund - This fund is valued at the daily closing price as reported by the fund.

Collective Trust Fund - This fund is valued at the NAV of units held by the Plan at June 30, 2025 and 2024. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily without restriction. There are no unfunded commitments at June 30, 2025 and 2024.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis during the years ended June 30, 2025 and 2024.

Participant loan, distribution processing, and recordkeeping fees are paid to the custodian, John Hancock Trust Company LLC, by participants. These transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

6. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of June 30, 2025 and 2024, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC, a qualified institution.

7. Tax Status

The Plan adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with Cash or Deferred Arrangement sponsored by John Hancock Financial Services, which received a favorable opinion letter from the IRS dated June 30, 2020, which states the pre-approved plan, Plan, as then designed, satisfies the applicable provisions of the Internal Revenue Code (the Code). The Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, QCP has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant will become 100% vested. Participants will be entitled to take their entire vested balances from the Plan following termination.

9. Subsequent Events

Plan management has evaluated subsequent events through February 24, 2026, the date on which the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements.
