## **INDEPENDENT AUDITORS' REPORT**

To the Trustees of the  
Pennsylvania Federation of Teachers  
Health and Welfare Fund – Public Sector

### **Opinion**

We have audited the accompanying financial statements of Pennsylvania Federation of Teachers Health and Welfare Fund – Public Sector (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Pennsylvania Federation of Teachers Health and Welfare Fund – Public Sector as of May 31, 2025 and 2024 and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pennsylvania Federation of Teachers Health and Welfare Fund – Public Sector and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

Note 1 -

**DESCRIPTION OF THE FUND**

The following description of the Pennsylvania Federation of Teachers Health and Welfare Fund - Public Sector (the Fund) provides only general information. Participants should refer to their respective bargaining unit and plan agreements for a complete description of the Fund's provisions.

**General**

The Fund is designed to establish a separate trust for the purpose of paying, either from principal or income or both, health care benefits (including prescription, dental and vision) for the employees, their families and dependents of the Centre County and Pottstown Public Schools.

**Contributions**

Contributions are made by employers at contractual rates.

**Other**

Although it has not expressed any intention to do so, the parties to the agreement have the right under the agreement to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Expenses**

Expenses incurred by the Fund in connection with its operation are paid by the Fund.

**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Cash and Cash Equivalents**

Cash and cash equivalents consist of a checking account and a money market fund. The Fund considers all highly liquid investments with an initial maturity of three months or less to be cash equivalents and available for current use. At May 31, 2025, the Fund had a cash balance in a financial institution that exceeded federal depository insurance limits. Management believes that it is not exposed to any significant risk in its cash accounts.

Note 2 - **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Pending and Unrevealed Claims**

For the years ended May 31, 2025 and 2024, the pending and unrevealed claims relating to membership benefits were estimated by management's assessment which utilizes historical trends and subsequent payment data. There were no pending and unrevealed claims accruals as of May 31, 2025 and 2024.

**Administrative Fee**

The Fund is administered by the Philadelphia Federation of Teachers Health and Welfare Fund for an annual fee based on a percentage of contributions. Total administrative fees paid to the Philadelphia Federation of Teachers Health and Welfare Fund for the years ended May 31, 2025 and 2024 amounted to \$8,670 and \$7,962, respectively.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent Events**

Management has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued. Management has indicated that they are not aware of any subsequent events that need to be disclosed.

Note 3 - **INCOME TAXES**

The Fund has obtained a favorable tax determination letter from the Internal Revenue Service under section 501 (c)(5). The Fund's administrator believes that the Fund continues to qualify and operate in accordance with applicable provisions of the Internal Revenue Service. The Form 5500 of the Fund for 2024, 2023 and 2022 is subject to examination by the IRS and state taxing authorities, generally for three years after it is filed. Management has indicated that they are not aware of any examinations being performed by the IRS and/or state taxing authorities.

Note 4 - **RELATED PARTIES**

The Fund had transactions with the following affiliate:

Philadelphia Federation of Teachers Health and Welfare Fund

As described in Note 2, the Fund pays the Philadelphia Federation of Teachers Health and Welfare Fund an administrative fee. The total fees paid for the years ended May 31, 2025 and 2024 are disclosed in Note 2. There were no amounts due to the Fund as of May 31, 2025 and 2024.



