Note 1 - Description of the Plan

The following description of the University Book Store, Inc. Employees' Retirement Savings Plan and Trust (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility and other matters.

General - The Plan is a defined contribution plan that was established in 1966 to provide retirement benefits for all eligible employees of University Book Store, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration - ADP, LLC (ADP) and Reliance Trust Company (Reliance) served as the recordkeeper and trustee, respectively, for the Plan.

Effective August 12, 2024, the Company changed its recordkeeper and trustee services from ADP and Reliance to Nationwide Financial Services, Inc. (Nationwide). Plan assets amounting to \$19,938,239 were transferred to Nationwide following the change.

Eligibility - All employees are eligible to participate in the Plan after completing a minimum of 500 hours of service in their first six months of employment, or one year of service. Participants may enroll in the plan on the first day of the month after meeting the eligibility requirements.

Contributions - Employees may elect to contribute between 1% and 90% of their eligible compensation as pre-tax or Roth contributions. The Plan has an automatic enrollment feature under which new employees are enrolled with a 1% pre-tax deferral unless they formally waive participation or elect a different participation level. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants are also allowed to rollover contributions from other qualified retirement plans.

The Plan allowed the Company to make discretionary matching contributions in any specific dollar amount or any specific percentage. For the period July 1, 2024 through August 11, 2024, the Company elected to make matching contributions equal to 100% of each participant's elective deferrals up to 4% of compensation and 50% on the next 2% of deferrals. Effective August 12, 2024, the discretionary employer matching contribution was replaced by a fixed employer matching contribution, equal to 100% of each participant's elective deferrals up to 4% of compensation and 50% of the next 2% of deferrals.

The Company may also make additional discretionary profit sharing contributions. There were no additional profit sharing contributions approved for the year ended June 30, 2025.

Contributions are subject to limitations prescribed by the Internal Revenue Service (IRS).

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Company's profit sharing contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Distributions - Upon termination of service, death, disability, or retirement, a participant may elect to receive a distribution of their vested account balance. The Plan also provides for in-service and hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan. If the value of a participant's vested account balance is \$5,000 or less at the time of termination, the participant will receive an immediate cash-out of their account balance as soon as administratively feasible.

Vesting - Participants are immediately vested in their salary deferral and employer matching contributions plus actual earnings thereon.

Forfeitures - At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$10,273 and \$2,705, respectively. During the year ended June 30, 2025, \$1,737 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Payment of Benefits - Benefits paid to participants are recognized when they are paid.

Subsequent Events - The Company has evaluated subsequent events through February 27, 2026, the date on which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides a consistent framework for determining fair value measures for financial assets and liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Investment Contract - Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

Stable Value Collective Trust Fund - The fund is valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of June 30, 2025 and 2024, and investment income or loss for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Nationwide Trust Company, FSB. Effective August 12, 2024, the Plan changed its qualified institution from Reliance Trust Company to Nationwide Trust Company, FSB. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Certain Plan investments are managed by Nationwide and its affiliates. Nationwide is the custodian of the Plan and, therefore, transactions with such investments are party-in-interest transactions. During the year, ADP and Reliance provided trustee, recordkeeper and administrative duties for the Plan. As such, fees paid by the Plan to ADP and Reliance qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

Note 7 - Tax Status

The Company adopted a Nationwide Financial Services Inc. (Nationwide) pre-approved plan document. Nationwide received an approval letter from the IRS dated May 29, 2024, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
