### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Pacific Northwest Farmers Cooperative Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of May 31, 2025 and 2024, and for the year ended May 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

### 1. Plan Description

The following description of the Pacific Northwest Farmers Cooperative Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan was established on June 1, 1979 to provide benefits for employees of Pacific Northwest Farmers Cooperative (the Company). The Plan was most recently restated on May 1, 2022. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

ADP Retirement Trust Service, LLC (Trustee, Trust, or ADP Trust) is the trustee and ADP Retirement Services (Recordkeeper or ADP) is the recordkeeper in accordance with the provisions of the service provider agreements with the Company. Reliance Trust Company was the trustee prior to January 1, 2025. The administrator of the Plan is the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Full-time employees of the Company are eligible to participate in the Plan and receive an allocation of Safe Harbor matching contributions and additional matching contributions the first of the month following completion of six months of service. Participants are eligible for the profit-sharing contributions the first of the year following the attainment of age 21 and the completion of one year of service in which at least 1,000 hours are worked. Part-time employees, who work less than 1,000 hours per year, are not eligible for the Plan.

#### *Contributions*

Each year, participants may contribute up to 90% of eligible compensation, as defined in the Plan Document, on a pre-tax or after-tax Roth basis, and are subject to limitations by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts (IRA) as a rollover to the Plan. All employees are automatically enrolled in the Plan at a pre-tax deferral rate of 4% once eligible, unless the participant makes an affirmative deferral election.

The Company makes Safe Harbor matching contributions equal to 100% of the participant's contributions, up to 4% of eligible compensation.

The Company may elect to make discretionary profit-sharing contributions to the Plan. Profit-sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Employees must meet certain continuing eligibility requirements to be eligible for the profit-sharing contribution. The Company may also elect to make discretionary matching contributions. There were no profit-sharing or discretionary matching contributions for the year ended May 31, 2025.

### *Participants' Accounts*

Each participant's account is credited with the participant's deferral contributions (pre-tax, Roth, catch-up, and rollovers), the employer Safe Harbor matching, discretionary matching contributions, and profit-sharing contributions, if any, and an allocation of Plan earnings and losses. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest is charged on the outstanding balance at prime plus 1% and is fixed for the term of the note. Two notes may be outstanding at a time. The term of repayment may not exceed five years unless the loan qualifies as a home loan, in which case the term of repayment may be longer than five years. Principal and interest is paid ratably through payroll deductions.

### *Vesting*

Participants are 100% vested in their participant deferral contributions, rollover contributions, and Safe Harbor matching contributions and the earnings thereon. A participant's vesting in the Company's discretionary profit-sharing and discretionary matching contributions are based on years of continuous service.

Participants vest in the Company's discretionary profit-sharing contributions and discretionary matching contribution based on the following schedule:

Participants are fully vested upon death or disability, as defined in the Plan Document, and termination of the Plan.

### *Payment of Benefits*

On termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, elect payments in installments, or elect a partial withdrawal. Terminated participants with balances greater than \$1,000 may choose to keep their funds in the Plan. Unless a participant directs otherwise, distributions of vested account balances of \$1,000 or less are paid to participants in cash. In-service distributions at age 59½ and in the case of hardship are allowed if certain criteria are met.

### *Forfeitures*

The non-vested portions of terminated participants' account balance are treated as forfeitures. At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$10. The account can be used to pay Plan expenses or may be used to reduce the Company contributions. During the year ended May 31, 2025, \$3 was used to fund employer contributions or pay expenses of the Plan.

### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. Participants would become fully vested in their accounts upon termination of the Plan.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments, as detailed in the accompanying supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year), are stated at fair value, as further discussed in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Company determines the Plan's valuation policies utilizing information provided by the Trustee.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income and capital gains are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance; any accrued but unpaid interest is de minimis. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan Document.

### *Contributions*

Participant contributions and related Safe Harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### *Benefit Payments*

Benefits paid to participants are recorded when paid.

### *Administrative Expenses*

Plan expenses relating to loan and distribution transactions are charged directly to participants' accounts and are included in administrative expenses. Certain investment management and advisory fees are shown net with investments earnings within the registered investment companies. All other costs of administering the Plan are paid by the Company and are excluded from these financial statements.

## **3. Certified Investment Information**

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and ADP Trust, qualified institutions, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as reported in the statements of net assets available for benefits as of May 31, 2025 and 2024.
- Net appreciation in the fair value of investments, dividends and interest income, and interest income on notes receivable from participants, as reported on the statement of changes in net assets available for benefits for the year ended May 31, 2025.
- Investment amounts included in the notes to financial statements.
- All investment amounts included in the supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of May 31, 2025.

At the request of the Company, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **4. Fair Value Measurements and Disclosures**

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the

lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There were no changes in methodologies used as of May 31, 2025 and 2024.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered Investment Companies* - Registered investment companies are mutual funds valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trust* - The collective investment trust (CIT) is valued at fair value using NAV as a practical expedient. NAV is determined by the issuer based on the fair value of the underlying investments. The practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the NAV. This investment is a direct filing entity with the DOL.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### **6. Income Tax Status**

The ADP, LLC sponsored Defined Contribution Pre-Approved Plan Document has received an opinion letter from the Internal Revenue Service (IRS), dated October 6, 2020, indicating that the Plan and Trust are designed in accordance with the applicable sections of the IRC. The Company believes the Plan is being operated in accordance with the IRC and therefore continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **7. Concentrations, Risks, and Uncertainties**

The Plan provides for various investment securities in registered investment companies and a CIT. Investment securities, in general, are exposed to various risks such as interest rate, overall market volatility, and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Subsequent Events**

The Plan has evaluated subsequent events through February 25, 2026, the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements, other than those noted below.

Effective June 1, 2025, the Plan was amended to change the Safe Harbor matching contribution to 100% of the participant's contributions, up to 6% of eligible compensation.
