### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Langley School DC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 1, 2025 and August 31, 2024, the related statement of changes in net assets available for benefits for the period September 1, 2024 to May 1, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of May 1, 2025 and August 31, 2024, and for the period from September 1, 2024 to May 1, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

### Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan was merged into Independent Schools of Maryland and Greater Washington Multiple Employer Plan and legal responsibility was transferred to the Independent Schools of Maryland and Greater Washington Multiple Employer Plan effective May 1, 2025. Our opinion has not been modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor’s Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan’s financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor’s report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

#### Note 1. Plan Description

The following description of the Langley School DC Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan, covering substantially all employees of The Langley School (the School) who meet the eligibility requirements. Individuals deemed by the Plan Administrator to be independent contractors are not eligible to participate. The Audit Committee is responsible for oversight of the Plan. Management determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan's Audit Committee. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

**Plan merger:** The Plan Sponsor approved the merger of the Plan into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan, effective May 1, 2025. Legal title and responsibility was transferred to the Independent Schools of Maryland and Greater Washington Multiple Employer Plan at that time and employees who were participating in this plan became participants in the Independent Schools of Maryland and Greater Washington Multiple Employer Plan.

**Contributions:** Eligible participants may make contributions based on a flat dollar election or a percentage of pay as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

For all eligible participants, the School provides a safe harbor nonelective contribution of 4% of each participant's eligible wages whether or not the participant has elected to contribute to the Plan. In addition, the School matches up to a maximum of 4% of the participant's eligible wages contributed to the Plan.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the School in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the School's matching contributions as well as allocations of safe harbor contributions and plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in all contributions plus actual earnings thereon.

**Payment of benefits:** The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½, or at any time with respect to pre-1989 deferrals invested in an annuity contract.

Participants can select from the following payment options: lump-sum, partial payments, installment payments, annuity contract (if assets are held in custodial account) or converted to an income option (if assets are invested in an annuity contract).

#### Note 1. Plan Description (Continued)

**Transfers between accounts:** Participants are permitted to transfer funds between their CREF accounts, TIAA Real Estate Account and mutual funds and into their TIAA Traditional Retirement Annuity Account at any time. However, transfers out of the TIAA Traditional Retirement Annuity Account (RA) into any of the other plan investment options by an active participant can only be made through a Transfer Payout Annuity, which provides for the transfer of funds in substantially equal installments over a period of 10 years.

**Plan loans:** Until January 1, 2022, participants could borrow from Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF) using a portion of their plan account as security for the loan. The minimum loan was \$1,000 and up to the maximum equal to the lesser of: (a) \$50,000, reduced by the highest outstanding loan balance; or (b) 50% of the participant's account balance subject to certain additional limitations based on TIAA-CREF investments.

The loans are secured by the participant's account. The interest rate and other terms and conditions for a plan loan and its security and repayment, are to be generally comparable to those that would be imposed by a commercial lender for a similar loan made at the same date under similar circumstances. The term of the loan is limited to five years except where a loan is taken for the purchase of a participant's principal residence, in which case it may be extended to 10 years.

The plan loans bear interest at rates that range from 4.00% to 5.97%, which are commensurate with local prevailing rates as determined periodically by TIAA-CREF. Principal and interest are paid ratably through quarterly payments by the participant to TIAA-CREF. Plan management has concluded that these loans are not plan assets and that such arrangements are exempt transactions. The plan loan balances as of May 1, 2025 and August 31, 2024, totaled \$32,403 and \$81,484, respectively. Under the borrowing terms, \$35,644 and \$89,632 of plan assets serve as collateral for these loans as of May 1, 2025 and August 31, 2024, respectively.

In the event of default, such loans are reportable to plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the participant or until the participant becomes eligible to receive a distribution under the terms of the Plan. As of May 1, 2025 and August 31, 2024, plan loans in default totaled \$32,403 and \$80,413, respectively. Such amounts include the principal and accumulated interest.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000. Loan terms range up to five years or up to ten years for the purchase of a participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. These rates range from 4.25% to 9.50% on loans as of the date the assets were merged into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan, and the loans mature through 2035. Monthly principal and interest payments are required.

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### **Note 2. Summary of Significant Accounting Policies**

**Investment valuation and income recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the plan valuation policies utilizing information provided by TIAA-CREF. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Contributions:** Contributions from plan participants, and the matching and nonelective safe harbor contributions from the School are recorded in the year in which the underlying compensation is paid. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through March 13, 2026, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 1, 2025 and August 31, 2024:

**Insurance annuity contract (nonbenefit responsive):** Discounted cash flows are used to determine the fair value of the TIAA Traditional Retirement Annuity. The TIAA Traditional Retirement Annuity is reported at contract value, which management has determined approximates fair value. Each premium allocated to the contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

**Variable annuities and pooled separate account:** All of the CREF variable annuities and the TIAA Real Estate Account are valued at the daily unit value published on NASDAQ. The funds are not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the funds.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### Note 5. Investment Contract With TIAA

The Plan has a fixed annuity contract that is fully and unconditionally guaranteed by TIAA, which is shown in the accompanying statements of net assets available for benefits as an insurance annuity contract. The crediting interest rate is based on a formula agreed upon with the issuer. Additional interest, when declared, remains in effect for the declaration year. Additional interest is not guaranteed for future years. When the accumulation in TIAA Traditional Annuity is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The fund is not considered fully benefit-responsive due to withdrawal restrictions and is reported at contract value, which plan management has determined approximates fair value.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by TIAA. Contract value represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses.

#### **Note 5. Investment Contract With TIAA (Continued)**

The Plan's ability to receive amounts due in accordance with the investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would continue to be 100% vested in their entire account.

#### **Note 7. Tax Status**

The Plan has adopted a volume submitter plan sponsored by TIAA. The volume submitter plan provider has received an advisory letter from the IRS as to the volume submitter plan's compliance with IRC section 403(b). The volume submitter advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter received the advisory letter. The Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

#### **Note 7. Tax Status (Continued)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Related-Party and Party-in-Interest Transactions**

Plan assets are invested in funds sponsored and managed by TIAA-CREF. Transactions involving these investments and the Plan are considered to be party-in-interest transactions for which statutory exemption exists under the Department of Labor's Rules and Regulations. The School also paid certain administrative expenses of the Plan.

#### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
