Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MBC Companies 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025 through May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2025 and December 31, 2024 and for the period January 1, 2025 through May 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to the Financial Statements

May 31, 2025 and December 31, 2024

(1) Description of Plan

The following description of MBC Companies 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering all full-time employees of MBC Companies and its wholly owned subsidiaries (the Company) who have attained the age of 21 and completed six months of service, excluding employees subject to collective bargaining agreements, leased employees and employees who are nonresident aliens. Plan entry dates are the first day of the month coinciding with or next following the date on which an employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors of the Company is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Merger - Pooled Employer Plan (PEP)

In May 2025, the Company elected to become a participating employer of a PEP (the Plan Merger). As a result, in 2025, the Plan transferred all of its assets and was merged into the ExcelWise Pooled Employer Plan. All participants and their surviving beneficiaries in the Plan immediately prior to the Plan Merger (the Transferred Participants) will become participants of the ExcelWise Pooled Employer Plan as of the effective date of the Plan Merger and the Transferred Participants will no longer be eligible to participate in the Plan. As a result of Plan Merger, during the period January 1, 2025 through May 31, 2025, \$19,311,577 of plan assets were transferred to another trust for the benefit of the Transferred Participants. The Plan Merger had no impact on the Transferred Participants' account balances or vesting status.

Contributions

Each year, participants may contribute a percentage or fixed dollar amount of eligible compensation, as defined, up to the annual limit established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also allows self-directed investments, which are limited only to investments in accordance with ERISA.

The Company may make discretionary safe harbor and non-elective employer contributions as defined in the Plan. For the period ended May 31, 2025, the Company elected to provide a safe harbor matching contribution equal to 100% of employees' compensation up to 3% plus 50% of employees' compensation up to the next 3% of each eligible participants' compensation.

(1) Description of Plan, Continued

Participants' Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and plan earnings. Participant accounts may also be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their pre-tax contributions and rollover contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service in accordance with the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate as defined by the Wall Street Journal, plus 1%.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons as permitted by the plan document, a participant may elect to receive a lump-sum, installment payment, partial payment or an annuity equal to the value of the participant's vested interest in his or her account. The Plan will make a mandatory distribution of a participant's vested account balance following severance from employment for participants with balances up to a maximum of \$5,000.

(1) Description of Plan, Continued

Forfeited Accounts

Upon termination from the Company, participants will forfeit any nonvested portion of their account balance as of the termination date. Forfeitures should be used first to restore forfeitures of reinstated employees. Forfeitures may also be used to reduce employer contributions and/or offset plan administrative expenses. As a result of the Plan Merger, forfeited nonvested accounts were \$0 as of May 31, 2025. At December 31, 2024, forfeited nonvested accounts totaled \$1,917. Forfeitures totaling \$413 were used to pay administrative expenses during 2025.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The Plan has a revenue sharing arrangement with the trustee and established a plan level account (ERISA account) that captures excess income collected by the trustee that can be used to pay eligible plan expenses or can be allocated to participants. As a result of the Plan Merger, the ERISA account had no balance as of May 31, 2025. At December 31, 2024, the ERISA account totaled \$56,174. During 2025, Plan expenses aggregating \$27,054 were paid from the ERISA account. Additionally, other income of \$14,432 earned on the ERISA account is reflected on the statement of changes in net assets available for benefits for the period January 1, 2025 through May 31, 2025.

Subsequent Events

The Plan has evaluated subsequent events through February 17, 2026, the date the financial statements were available to be issued.

(3) Financial Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and contract value and notes receivable from participants held at May 31, 2025 and December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2025 through May 31, 2025, was obtained by management and agreed to or derived from the information certified as complete and accurate by State Street Bank and Trust Company, a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

There were no significant transfers among investment levels during the period May 31, 2025 and the year ended December 31, 2024.

(5) Investment Contracts with Insurance Companies

The Plan has entered into fully benefit-responsive investment contracts with Prudential Investment Company of America (Prudential) and Voya Retirement Insurance and Annuity Company (Voya). Prudential and Voya maintain the contributions in separate investment accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed interest contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contracts. The contracts are included in the financial statements at contract value, as reported to the Plan by Prudential and Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days, or in the rare circumstances, paid over time. There are not any events that allow the issuer to terminate the contract and which would require the sponsor to settle at an amount different than contract value.

(6) Related Party Transactions and Party-In-Interest Transactions

One Plan investment was a registered investment company managed by an affiliate of Transamerica Retirement Solutions, the record-keeper of the Plan. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

Certain administrative expenses were paid by the Plan. Administrative expenses paid by the Plan to the record-keeper and trustee, net of ERISA account activity, amounted to \$29,243 for the period January 1, 2025 through May 31, 2025.

(7) Tax Status

The Plan uses a prototype plan document sponsored by Transamerica Retirement Solutions (Transamerica Solutions). The IRS has determined and informed Transamerica Solutions Corporation by a letter dated June 30, 2020, that the prototype document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Non-exempt Transactions

During 2024, the Company failed to remit to the Plan's custodian certain participant contributions within the period prescribed by the Department of Labor regulations. Late contributions for 2024 totaled \$2,492. The Company intends to compensate the affected participants for any lost earnings resulting from the delay in contributions in 2025.
