INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of 401(k) Profit Sharing Plan for the Employees of Westbrook Health Services, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Basis of Accounting

As discussed in Note 7 to the financial statements, a resolution to terminate the Plan effective October 1, 2024, was executed on September 13, 2024, by the chairman of the Board. As of June 30, 2025, all of the net assets for benefits have been transferred to another qualified plan.

Responsibilities of Management for the Financial Statement

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1 – DESCRIPTION OF PLAN

The following description of the 401(k) Profit Sharing Plan for Employees of Westbrook Health Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement plan which was formed for the purpose of providing retirement benefits to substantially all nonunion employees of Westbrook Health Services, Inc. (the Organization). Employees become eligible to participate in the Plan upon reaching age 21 and completing one year of service, as defined, of at least 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

Amendments

Effective July 1, 2020, the Plan was amended to exclude all highly compensated employees as well as any employees hired on or after July 1, 2020. Effective January 1, 2021, the Plan was amended to disallow new participant loans after the effective date. Additionally, the chairperson of Westbrook Health Services signed a resolution on September 13, 2024, to terminate the Plan effective October 1, 2024. Upon termination all remaining assets in the Plan were distributed to the participant or rolled over to the successor 403(b) Plan in May 2025.

Contributions

Each year, participants may elect to contribute up to 100% of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Effective September 1, 2019, the Plan added an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they are affirmatively elected not to participate in the Plan. Automatically enrolled participants have their deferral set at 1% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. Additionally, participants will have an automatic increase in deferral of 1% each of the two years following the year of automatic enrollment unless they affirmatively elect not to increase the deferral rate. Matching contributions equal to 50% of the first 4% of the compensation that a participant contributes to the Plan were made by the Organization for the year ended June 30, 2025 and 2024. At the discretion of the Board of Directors, additional discretionary employer contributions for the year ended June 30, 2025 and 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contribution and (b) Plan earnings. The account is then charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their contributions into any of several investment options with varying degrees of risk and volatility, allowing participants to allocate their investments in accordance with their own risk tolerances and time horizons. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's matching and discretionary employer contributions is based on years of credited service, a year of credited service is earned when an employee works 1,000 hours in an anniversary year. A participant is 100% vested after four years of credited service. Additionally, a participant is immediately vested in all contributions upon reaching the early retirement age of 55, regardless of years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. As noted previously, new loans were disallowed effective January 1, 2021. The balance in the participant's account secures the loans. Such loans bear interest at a reasonable rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money as determined by the Trustees at the time the loan is approved. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or monthly annuity installments over a future period. Distributions of a participant's account balance may be authorized at any time by the Plan Administrator under certain hardship conditions.

Forfeited Accounts

Forfeited non-vested accounts are used to reduce future employer contributions. At June 30, 2025 and 2024, forfeited, non-vested accounts totaled \$0 and \$11,723, respectively. During the year ended June 30, 2025 and 2024, employer contributions were reduced by \$8,578 and \$23,432, respectively.

2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basic of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract values the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of maintaining the Plan, including participants recordkeeping, are paid by the Organization and are excluded from these financial statements. Certain fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value investments.

Subsequent Events

Plan management has evaluated subsequent events through March 9, 2026 the date the financial statements were available to be issued. There are no reportable subsequent events as the plan terminated during the year.

3 – CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2025. The following information, included in the accompanying financial statements and supplemental schedule, was obtained from data that has been prepared and certified as complete and accurate by Mutual of America, the custodian of the Plan for 2025:

4 – FAIR VALUE MEASUREMENTS

Accounting standards include a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2025 and 2024.

Pooled separate accounts: Valued at net asset value (NAV) per unit based on quoted market prices of the underlying investments. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the account.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets measured at fair value at June 30, 2025 and 2024, are comprised of pooled separate accounts measured using NAV as a practical expedient, which totaled \$0 and \$6,895,364. In accordance with Subtopic 820-10, investments that are measured at NAV per share (or its equivalent) are not classified in the fair value hierarchy.

For the years ended June 30, 2025 and 2024, the Plan did not hold and Level 2 or Level 3 assets.

5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive investment contract with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is declared from time to time by the issuer. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan). (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

6 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by Mutual of America. Mutual of America is the custodian and recordkeeper as defined by the Plan and, therefore, such transactions qualify as party-in-interest transactions. Additionally, the Plan holds party-in-interest receivables of \$0 and \$7,150 as of June 30, 2025 and 2024, respectively, in the form of notes receivable from participants.

7 – PLAN TERMINATION

On September 13, 2024, the Westbrook Health Services, Inc. Board of Directors approved the termination of the Plan. In connection with the Plan termination effective October 1, 2024, the Plan sponsor established the Successor 403(b) Plan of Westbrook Health Services, Inc. to receive the assets and assume the obligations of the Plan.

Pursuant to the termination, all participants became 100% vested in their account balances as of October 1, 2024. During the period from September 13, 2024, to October 1, 2024, participants were provided with the option to elect a distribution of their account balances or a direct rollover to the Successor 403(b) Plan or another qualified plan.

As of June 30, 2025, assets totaling \$4,859,592 were transferred to the Successor 403(b) Plan while \$4,074,335 was paid to participants who elected a distribution of their account balance, representing the transfer of substantially all participant accounts and related plan obligations. Because the Plan's obligations were transferred to a successor plan rather than settled through final payouts to participants, these financial statements continue to be prepared on the going concern basis of accounting.

8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2025 statement of net assets available for benefits.

As of June 30, 2025, the plan held \$0 of investments in the form of pooled separate accounts and an investment contract within Mutual of America, which was 100% of total investments. Therefore, net assets available for benefits are particularly sensitive to changes related to these investments.

9 – TAX STATUS

Mutual of America, sponsor of the Prototype Non-standardized Profit-Sharing Plan with CODA document, has obtained an opinion letter dated March 31, 2014, in which the (IRS) stated that the restated prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Organization adopted this restated prototype plan document on April 25, 2016. The Plan was amended on January 1, 2021. The Prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

In accordance with GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.
