NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Victoria Theatre Association Retirement Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - On July 1, 1992, Victoria Theatre Association (the "Organization") adopted a Section 403(b) profit-sharing plan. The Plan allows all employees of the Organization to participate in the Plan at date of hire. Upon satisfaction of the eligibility requirements, employees can enroll in the Plan on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants can also make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Deferral percentages can be changed by participants at any time.

Effective July 1, 2024, employees age 21 or over, with the exception of non-resident aliens or those subject to a collective bargaining agreement, are eligible for a discretionary employer matching contribution after 60 days of service, provided that they complete 1,000 hours of service during the Plan year, unless not employed due to retirement, death, or disability. Prior to July 1, 2024, employees were also required to be employed on the last day of the Plan year in order to be eligible and employees classified as part-time or seasonal were excluded unless they worked 1,000 hours during the Plan year. The Organization elected to contribute an amount equal to 50% of each eligible participant's elective deferrals, with a maximum contribution of 3% of eligible compensation, for the years 2025 and 2024.

The Organization is also permitted to make a discretionary profit sharing contribution to employees that are age 21 or over, with the exception of non-resident aliens or those subject to a collective bargaining agreement, provided they have 60 days of service, are employed on the last day of the Plan year, and complete at least 1,000 hours of service during the Plan year, unless not employed due to retirement, death, or disability. No profit sharing contributions were made for the years 2025 and 2024. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

Participant Accounts - Newport Trust Company, LLC ("Newport") was the Trustee of certain Plan investments through November 13, 2024. Effective November 14, 2024, Ascensus LLC, as an authorized representative of Ascensus Trust Company, became Trustee of certain Plan investments. The Voya Retirement Insurance and Annuity Company ("Voya") is also Trustee of certain Plan investments. Each participant's account is credited with the participant's contributions, employer contributions, net earnings or losses, distributions, and withdrawals. Employer contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution and employer contributions are to be invested.

Vesting - Participants are immediately vested in all contributions and corresponding earnings, including contributions made by the Organization.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Notes Receivable from Participants - Participants may borrow from their account balance any amount between \$1,000 and \$50,000, but not to exceed 50% of their vested account balance. Notes receivable bear interest at the prime rate plus 1% and terms are for a period not exceeding five years. A term up to ten years may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Notes receivable are secured by the balance in the participants' accounts and a participant may only have one note receivable outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

Benefits Paid - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$1,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. If the balance does not exceed \$5,000, and the participant does not elect to have the distribution paid directly to them or an eligible plan, the Plan Administrator may make a lump sum distribution to a direct rollover individual retirement account. In addition, participants may receive distributions of their account balance, excluding their matching contributions, for qualified financial hardships.

Forfeitures - Forfeitures are to be used in the following order: to pay Plan expenses, to reduce employer contributions, and, finally, forfeitures may be allocated to participants as additional employer contributions. Forfeitures in the amount of \$3,089 and \$0 were used during 2025 and 2024. Unallocated forfeitures at June 30, 2025 and 2024 were \$8,430 and \$1,525.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options at any time.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Financial Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses is deemed necessary as of June 30, 2025 and 2024. If a participant ceases to make repayments and the Plan Administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Organization pays certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through February 17, 2026, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2025 and 2024, net appreciation (depreciation) in fair value of investments, and interest and dividends for the years 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC, Ascensus LLC, as an authorized representative of Ascensus Trust Company, and The Voya Retirement Insurance and Annuity Company (the Trustees of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025.

Money market fund: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed account: Valued based on the valuation formula contained in the contract.

The preceding methodologies described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain Plan assets were invested with Newport Trust Company, LLC through November 13, 2024, and with Ascensus Trust Company effective November 14, 2024. In addition, certain Plan assets are invested with The Voya Retirement Insurance and Annuity Company. These entities also handle the record keeping and third-party administrator services for the Plan. Thus, Newport Trust Company, LLC, Ascensus Trust Company, and The Voya Retirement Insurance and Annuity Company, as Trustees defined by the Plan, qualify as parties-in-interest. Additionally, PNC Institutional Asset Management provides investment advisory services to the Plan, and thus, qualifies as a party-in-interest. Fees paid by the Plan for Trustee, recordkeeping, and investment advisory services for the years 2025 and 2024 totaled \$29,092 and \$32,023.

The Plan Sponsor provides certain accounting, record keeping, and administrative services to the Plan, for which it receives no compensation.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan subject to the provisions of ERISA and its related regulations.

NOTE 7 - TAX STATUS

The Plan adopted a volume submitter 403(b) plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on March 31, 2017, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
