### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Arrow Electric Co., Inc. Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c).

### Basis for Opinion

### Note 1—Description of the Plan

The following description of the Arrow Electric Co., Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution profit sharing plan covering all eligible employees of Arrow Electric Co., Inc. and related adopting employer, Accuserv Equipment & Supply, LLC (collectively, the “Company”, “Sponsor” or “Employer”). An employee shall become eligible to participate in the Plan after attainment of age 18 and three months of service. For purposes of wage rate contributions, an employee will become an active participant on the first date for which wage rate contributions have been earned. The Plan was established to provide and administer retirement benefits for employees of the Company that participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Administration* – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – Each year, participants may elect to make pre-tax or after-tax Roth contributions to the Plan up to the maximum permissible under the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Contributions are subject to certain limitations.

The Company may also make discretionary contributions to the Plan. For the Plan year ended June 30, 2025, the Company made a discretionary matching contribution equal to 50% of deferrals up to the first 6% of compensation each eligible participant contributed to the Plan. No other additional discretionary contributions were made for the 2025 Plan year.

Company contributions pertaining to prevailing wage laws totaled \$246,485 for the Plan year ended June 30, 2025. These contributions are based on rates that satisfy the wage determination issued by the governmental agency responsible for the contract.

*Participant Accounts* – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, Company matching and prevailing wage contributions, and an allocation of Plan investment results. Participant accounts are charged with their withdrawals and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, specific participant transactions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their voluntary and Company prevailing wage contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Effective July 1, 2024, the Plan was amended for a participant to become fully vested upon completion of four years of credited service. Prior to July 1, 2024, a participant became fully vested upon completion of six years of credited service.

*Investment Options* – Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the Plan year.

### Note 1—Description of the Plan (continued)

*Notes Receivable from Participants* – Effective July 1, 2024, the Plan was amended to allow participants to borrow from their fund accounts. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms do not exceed five years unless a residential loan which can have terms up to 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate based on interest rates being charged by commercial lenders for loans of comparable risk. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits* – Upon termination or service or attaining normal or early retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments not exceeding the participant's life expectancy. In-service and hardship withdrawals are also allowed as defined in the Plan agreement.

*Forfeited Accounts* – The non-vested portion of former participants' accounts may be used to pay administrative expenses of the Plan or to reduce the amount of Employer contributions. Forfeited accounts totaled \$8,209 and \$7,593 at June 30, 2025 and 2024, respectively. During the Plan year ended June 30, 2025, forfeitures totaling \$5,788 were used to pay administrative expenses of the Plan.

### Note 2—Summary of significant accounting policies

*Basis of Presentation* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

*Investment Management Fees and Operating Expenses* – Investment management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of investments.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits* – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at June 30, 2025 and 2024.

*Administrative Expenses* – Administrative expenses of the Plan are paid by the Company or Plan participants, as defined in the Plan agreement.

### **Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company ("Voya"), a qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments at fair value, and investments at contract value as shown in the statements of net assets available for benefits as of June 30, 2025 and 2024
- Net appreciation in fair value of investments, and interest and dividends as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2025.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of June 30, 2025.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **Note 4—Fair value measurements**

U.S. GAAP provides the framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2025 or 2024.

*Pooled Separate Accounts ("PSA")* – Valued at the net asset value ("NAV") of units held by the Plan at year end provided by the issuer of the account. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised primarily of shares of mutual funds at June 30, 2025 and 2024. The PSAs seek to mirror the investment objectives and strategies of the underlying mutual fund for which the PSA is named. Certain PSAs are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There are currently no redemption restrictions or unfunded commitments on these investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5—Fully benefit-responsive investment contract**

The Plan has a fully benefit-responsive investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract is included in the financial statements at contract value as reported to the Plan by Voya. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all of a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder. The guaranteed investment contract does not permit Voya to terminate the agreement prior to a breach of the contract terms by the contract holder.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

### **Note 6—Related party and party-in-interest transactions**

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest. It invests in pooled separate accounts and a guaranteed investment contract managed by Voya, the qualified institution. These transactions and related activity qualify as party-in-interest.

### **Note 7—Plan termination**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Note 8—Income tax status**

The Internal Revenue Service (“IRS”) ruled on March 22, 2021, that the pre-approved plan of Retirement Management Services LLC upon which the Plan is based, is designed in accordance with the applicable sections of the IRC. The Plan has been amended since receipt of the opinion letter. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

### **Note 10—Subsequent events**

The Plan has evaluated all subsequent events through March 9, 2026, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.

### **Note 11—Non-exempt transactions**

During the Plan year ended June 30, 2025, employee withholdings totaling \$8,199 were not remitted to the trust within the appropriate time period by the Company. These transactions constituted prohibited transactions as defined by ERISA. The Company remitted the withholdings during the Plan year ended June 30, 2025.
