Notes to Financial Statements

May 31, 2025 and 2024

(1) Description of the Plan

The following description of the Container Graphics Corporation Health and Welfare Benefit Plan (the "Plan") provides general information about the Plan. Participants should refer to the Plan agreement and amendments for a more detailed description of the Plan's provisions.

(a) Formation of the Plan

The Plan was established as a health benefits plan effective June 1, 1988. The purpose of the Plan is to provide medical, dental, life, disability and accidental death insurance benefits for those employees of Container Graphics Corp. ("CGC") and their eligible dependents who desire medical care and other insurance coverage. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

(b) Benefits

The Plan provides health, dental, life, short-term disability and accidental death insurance benefits to all eligible participants. Benefit payments are subject to a deductible and certain limitations depending upon the type of benefits to be paid.

(c) Contributions

CGC makes periodic contributions to the Plan in amounts estimated to be sufficient to pay Plan benefits and administrative expenses. In addition, participants are required to make contributions for a portion of their coverage and the coverage of their dependents.

(d) Plan Termination

CGC has the right to terminate the Plan at any time. Upon termination of the Plan, the Plan's assets will be paid out by the Trustee, Interactive Medical Systems, as directed by CGC to cover unpaid medical claims, administrative expenses, and other costs. Any remaining assets will be used to provide benefits for employees as directed by CGC.

(e) Insurance Coverage

The Plan is covered by stop-loss insurance which reimburses the Plan for medical benefits paid in excess of a specific deductible for an individual participant in any one year (\$150,000 for 2025 and 2024) and in excess of an aggregate deductible (\$120,000 for 2025 and 2024). See note 5 for reimbursements received under this policy. The Plan is fully insured for life, long-term disability and accidental death and dismemberment coverage.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America and present the net assets available for plan benefits and the plan benefit obligations as of May 31, 2025 and 2024, and changes in those net assets and obligations for the years then ended.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the statements of net assets available for plan benefits and the reported amounts of additions to net assets and deductions from net assets for the periods presented. Actual results could differ significantly from those estimates.

(c) Plan Obligations

Plan liabilities for health claims submitted but not paid and those incurred but not reported are accrued based upon a review of claims paid subsequent to the Plan's year end and estimates based on prior loss experience. Due to the uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates in the near term could be material to the financial statements.

(3) Claims Processing

Claims for benefits under the Plan are processed by Interactive Medical Systems (IMS). IMS pays claims for covered services and prescriptions to eligible participants on a weekly basis. The Plan reimburses IMS from plan assets. A monthly administrative fee is also paid to IMS from plan assets.

(4) Income Tax Status

The Trust established under the Plan is qualified pursuant to section 501(c)(9) of the Internal Revenue Code, and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter, dated September 7, 1990, from the Internal Revenue Service ("IRS"), and the Plan sponsor believes that the Trust, as amended, continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(5) Stop-Loss Reimbursement

As described in note 1(e), the Plan is covered by a stop-loss insurance policy. Health claims were reduced by \$1,892,997 and \$69,684 for reimbursements received in 2025 and 2024, respectively.

(6) Benefit Obligations

If plan benefit obligations exceed net assets available for plan benefits, primarily because of estimated claims incurred but not reported for current benefit coverage, CGC has the intent and ability to fund this difference.

(7) Administrative Expenses

Certain administrative expenses of the Plan are absorbed by CGC.

(8) Subsequent Events

The date to which events occurring after May 31, 2025, the date of the most recent statement of net assets available for plan benefits, have been evaluated for possible adjustment to the financial statements or disclosure is March 13, 2026, the date the financial statements were available to be issued.
