Note 1 - Description of the Plan

The following description of the Overland West, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan provides benefits to employees working at least 30 hours per week. The date of eligibility is the first day of the month following 60 days of employment.

Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers the employees of Overland West, Inc., and its wholly owned subsidiary (the Sponsor) and their covered dependents as defined by the Plan document.

Benefits

The Plan provides medical, dental, vision, mental health, basic life insurance, accidental death and dismemberment, prescription drug and substance abuse benefits. Included in the benefits provided by the Plan are preventative care, telehealth, hospital care, rehabilitation services, maternity care, dental care, vision care and prescription coverage. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures basic life insurance benefits and accidental death and dismemberment benefits through insurance contracts. The Sponsor purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid to the insurance company from the assets of the VEBA trust.

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan is responsible for individual claims up to \$75,000 per year, not to exceed an overall aggregate limit that varies with the number of active participants.

Self-Insured Benefits

The Plan is “self-insured” for medical, dental, prescription, vision, mental health and substance abuse benefits up to individual and aggregate stop loss limits. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan’s VEBA trust. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Employees electing to participate pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Sponsor pays the full cost of basic life insurance, basic accidental death and dismemberment insurance and stop loss insurance.

The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

Deposit

As of May 31, 2025 and 2024, the Plan maintains a security risk deposit totaling \$134,352 held by its claim processor to be used as a security to pay claims should the Plan be unable to fund future claim payments.

Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Sponsor or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as due to claims administrators in the accompanying statements of net assets available for benefits and are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$1,224,400 have been netted with benefits paid in the accompanying statement of changes in net assets available for benefits.

Refunds

Refunds due from the Plan's PBM are recorded when received. Pharmacy rebates totaling \$0 have been netted with benefits paid in the accompanying statement of changes in net assets available for benefits.

Administrative Fees

Administrative fees incurred in the administration of the Plan that are paid by the Plan include bank charges, preferred provider organization and review fees, and other administration fees. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are directly paid by the Sponsor, such as professional fees, are excluded from these financial statements.

Benefit Obligations

Plan obligations at May 31, 2025 and 2024, for health claims incurred by participants but not reported at that date are estimated by an analysis of claims paid subsequent to the Plan year end. Such estimated amounts are included in Note 3.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through March 6, 2026, the date which the financial statements were available to be issued.

Note 4 - Tax Status

The VEBA trust, funding certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated September 26, 2003, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2025 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Party-in-Interest Transactions

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 6 - Risks and Uncertainties

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 7 - Concentrations of Credit Risk

The Plan's cash is held in a federally insured account that, at times, may exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank. At May 31, 2025 and 2024, the Plan had approximately \$93,919 and \$54,952, respectively, in excess of FDIC-insured limits.


