To the attention of the IRS Agent,

Please, with the utmost respect, accept this letter as a reasonable cause as to why the 5500-SF forms are just being filed.

Please remove any charges that may have occurred due to my not knowing that this was my responsibility to file. I had previously been using the company, Paychex, who had set this 401k up for my business. They had been in charge of the 401k since 2017 and in 2022 when I left them to go to another payroll company, I was unaware that it was my responsibility to take over filing these forms.

November 3rd, 2025, I received a letter stating that I needed to file form 5500-SF for the tax period ending in 2023. I followed the instructions on the sheet and sent it back via mail. In the first week of March 2026, I received paperwork back that had been marked up by an agent in Ogden, UT, and a letter with this stating that it needed to be filed electronically. So that is what I am doing after understanding that it is my responsibility. In addition, please note that I have only received a letter for 2023, but after trying to fill out the 2023, I realized that they had also not filed anything for 2022. So that is what I am sending you today. 2023 was the final year as stated on the 5500-SF form that I am attaching.

Please also note I am a small business with only five employees and most of the revenue is generated by me. If I would incur these fees and penalties, it would negatively affect my ability to pay my employees as well as my overhead.

I appreciate your time and consideration in reading this letter and accepting this paperwork that is required.
