Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Bledsoe Health Trust (the "Plan") is a multiemployer benefit plan designed to provide benefits for eligible participants. The Plan is funded by employer contributions in accordance with applicable collective bargaining agreements and participants' contributions covered under the self-pay provision of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides hospital, medical, prescription drug, dental, vision, hearing aid, disability, life, weekly indemnity, accident and sickness and accidental death and dismemberment benefits to eligible active participants and their covered dependents. The Plan also provides health benefits to self-pay participants and retirees for which contributions are received.

The Plan documents include detailed rules for each situation. Participants should refer to the Plan agreement and amendments regarding specific provisions of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Contributions

The Plan is funded by participating employers that make monthly contributions for each hour of service in covered employment worked by eligible participants as required under collective bargaining, and by retiree contributions and participants electing COBRA coverage. The Board of Trustees sets contribution rates based on information provided by the Plan's consultant. Employer contributions receivable are estimated based on contributions received subsequent to year end for hours worked during the Plan year. No allowance is provided for uncollectible accounts.

Active participants may elect to contribute specified amounts to extend coverage under self-pay provisions of the Plan when a participant loses employer-paid eligibility because of a reduction in hours, layoff, leave of absence, plant closure or labor dispute. Qualified participants can also elect to continue participating in the Plan when they retire.

D. Benefits and Benefit Obligations

The Plan purchases contracts with insurance companies to provide certain benefits including dental, vision and life insurance. All other benefits under the Plan are self-insured. Claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims on behalf of participants and are reimbursed by the Plan. Premiums and claims payments are recorded when paid.

D. Benefits and Benefit Obligations (Continued)

The obligation for claims payable and estimated claims incurred but not reported are an estimate of the cost to the Plan for claims incurred under the terms of the Plan at May 31 but paid by the Plan subsequent to May 31. Accumulated eligibility credits are an estimate of the cost to the Plan for benefits earned based on work in April and May which provide eligibility for the following June and July.

E. Experience Rated Contracts

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company are calculated by the insurance company in the following year and may result in a premium surplus or deficit.

F. Refunds and Rebates

Refunds and rebates consist principally of amounts received from the Plan's pharmacy benefits manager (PBM) that periodically refunds the Plan based on the Plan's utilization of specific drugs.

G. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all signification assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Purchases and sales of securities are reported on the trade date basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - CONCENTRATIONS, RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, credit and market risk. Due to the level of risk associated with investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Deposits may at times exceed federally insured limit of \$250,000 per bank. Cash from the Plan's main funding account is transferred to an uninsured overnight sweep account with its bank. The balance in the sweep account at May 31, 2025 and 2024 was approximately \$1,229,000 and \$1,264,000, respectively.

The postretirement benefit obligations are based on certain assumptions pertaining to interest rates, health care trend inflation and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 4 - TAX-EXEMPT STATUS

The Trust established under the Plan is intended to qualify for tax exempt status pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"). The plan administrator and plan legal counsel believe the Plan is designed and operated in compliance with code requirements, and the trust qualifies for exemption from federal income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Provisions of the Agreement and Declaration of the Trust provide that all funds remaining in the Plan after payment of all expenses and obligations of the Plan shall be used for the continuance of purposes of the Plan until such monies have been exhausted or transferred to another trust or trusts providing similar benefits. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 7 - POSTRETIREMENT BENEFITS

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee services rendered to May 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by actuaries and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following are significant assumptions used in the valuations as of May 31, 2025 and 2024:

Discount Rate:	2025 - 5.5%; 2024 - 5.3%
Mortality:	Pri-2012 Amount Weighted Employee/Retiree Mortality Tables with Blue Collar adjustments for Males and Females, projected generationally from 2012 using the MP-2020 mortality improvement rates.
Actuarial Cost Method:	Projected unit credit actuarial cost method
Administrative Expenses:	Explicitly included in claims costs
Medical Inflation:	Pre-65 trend ranges from 6.70% starting with year ending 2025 to 3.70% through year ending 2075; Post-65 trend ranges from 5.90% starting with year ending 2025 to 3.70% through year ending 2075.

The Plan actuary estimates an increase of assumption change is \$10,562,000 in the postretirement benefit obligation at May 31, 2025 from the prior year estimate. The primary reasons for this was the change in the discount rate from 5.3% to 5.5% and the passage of time due to the payment of benefits.

Health care cost trend rate assumptions have a significant effect on the postretirement benefit obligation. If assumed rates increase by 1% per year above the rates assumed in the 2025 and 2024 valuations, the postretirement benefit obligation at May 31, 2025 and 2024 would increase by \$2,594,000 and \$1,635,000, respectively.
