Opinion

Note 1. Description of the Plan

General

The following description of Dimmit Regional Hospital 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Dimmit Regional Hospital (Company or Plan Sponsor) for the benefit of its employees.

Historically, the Plan was part of the Texas Hospital Association Participant Directed Retirement Program for Member Hospitals Group Trust (Old Group Trust). The custodian was Charles Schwab Trust Bank and the record-keeper was Milliman, Inc. until August 1, 2024, at which time the Plan entered into an agreement with Empower Trust Company to become the custodian and record-keeper of the Plan. Effective December 31, 2024, the Old Group Trust merged with the THA Participant Directed Retirement Program Group Trust (New Group Trust), and all plan assets are now held with the New Group Trust as of this date. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA) effective July 1, 2016. The Company also sponsors the Dimmit Regional Hospital Retirement Plan (Retirement Plan).

Contributions

Participants are allowed to make elective pre-tax or Roth contributions to the Plan up to the maximum amount permitted by the Internal Revenue Code (IRC). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified retirement plans or individual retirement accounts.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan upon meeting the Plan's eligibility requirements unless they have in effect a salary reduction agreement on the automatic deferral effective date or affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of annual eligible plan compensation, and their contributions are invested in a designated balanced fund, unless changed by the participant.

The Company may elect to make a discretionary matching contribution to the Plan equal to a uniform percentage of employee contributions determined and authorized by the Plan and the Company's Board of Directors up to the maximum amounts permitted by the IRC. The Company may also elect to make discretionary nonelective contributions. No discretionary matching contributions or discretionary nonelective contributions were approved or made to the Plan for 2024 or for 2023. The Company makes matching contributions to a separate plan sponsored by the Company, the Retirement Plan, based upon each participant's contribution to the Plan.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested upon death, disability, or retirement. Company matching contributions have a five-year graded vesting period as follows:

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeitures. Forfeitures will be used to reinstate previously forfeited account balances, pay plan administrative expenses, or reduce future employer contributions.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account or annual installments. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer’s unrestricted common stock less a discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings consistent with multiples of similar companies based on current market prices. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations, considering the creditworthiness of the issuer.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company’s discretion.

Note 3. Investment in Group Trust

As previously discussed in Note 1, plan assets were held in the Old Group Trust until December 31, 2024, at which time they were transferred to the New Group Trust. Investments are specifically allocated to the participating member plans based on the underlying investments and activity of the member plan as the New and Old Group Trusts are participant-directed.

Note 4. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used for the years ended December 31, 2024 and 2023.

- Mutual funds: Valued at the NAV of shares held by the New and Old Group Trusts at year-end

The Plan's investment in the New Group Trust is stated at fair value. It is held by a bank-administered trust fund. The New Group Trust is comprised primarily of mutual funds and a guaranteed income fund. If available, the New Group Trust uses quoted market values to value investments; if not, market values for similar investments are used to estimate the fair value of the investments. Many factors are considered in arriving at the fair value.

The New Group Trust participates in a contract with Empower Annuity Insurance Company of America (EAICA) via an investment in the Guaranteed Income Fund (GIF), which is a traditional group annuity insurance product. EAICA combines the assets of the GIF with other assets. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the GIF is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefit attributable to the investment contract. Contract value, as reported to the New Group Trust by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Generally, there are not any events that could limit the ability of the New Group Trust to transact at contract value paid within 90 days or, in certain rate-based circumstances, paid overtime. There are not any events that allow the issuer to terminate the contract and which require the New Group Trust to settle at an amount different than the contract value paid either within 90 days or over time.

Note 5. Related-Party and Party-in-Interest Transactions

Plan assets include notes receivable from participants and an investment in the New Group Trust. Fees incurred by the Plan for investment management services are included in New Group Trust investment income on the accompanying statements of changes in net assets available for benefits, as they are paid through revenue sharing or directly by the New Group Trust, rather than through a direct payment by the Plan. Investment oversight of the New Group Trust is managed by an appointed board of hospital executives called the Board of Successor Trustees (Trustees). The Plan pays certain administrative fees to Texas Hospital Association, the plan administrator, under an agreement with the Trustees to provide such services.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and trust document sponsored by Milliman, Inc. This volume submitter plan document has obtained an advisory letter from the Internal Revenue Service stating that the volume submitter satisfies the requirements under Section 403(b) of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and not subject to tax.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$365,845 and \$197,001 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.
