Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Think Academy 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Think Academy 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Think Academy 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Think Academy 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Think Academy 401(K) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan substantially covering all employees of Think Academy International Education, Inc. (“Company”) who are at least 21 years of age. Under the Plan’s 401(k) provisions, participants are eligible after three months of service. After meeting eligibility requirements, the individual may participate beginning the first day of the month following eligibility, as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan agreement, up to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company contributes a safe harbor matching contribution of 100% of the participants’ contributions up to 3% of the participants’ eligible plan compensation, at its discretion. The Company contributed \$312,820 to participant accounts for the year ending December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s elected compensation deferral and an allocation of (a) the employer’s contribution, (b) plan earnings, and (c) forfeitures of terminated participants’ non-vested accounts. In addition, the participant’s account is charged with an allocation of the Plan’s administrative expenses. These allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Investment Options

Upon election of compensation deferral, the participant directs the deferred amounts to be invested based on percentages into investment options sponsored by Automatic Data Processing (“ADP”). Participants may change their investment options at any time and revoke their election on any pay date.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

Vesting

Participants are immediately vested in their elective deferrals, safe harbor matching contributions, any rollover contributions to the Plan, and actual earnings thereon. Vesting in the Company's matching plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service. The Plan defines a year of credited service to be a period of twelve consecutive months during which an employee works. Upon the death or disability of any participant prior to retirement, the participant's account balance shall become fully vested.

Participant Loans

Participants may borrow from their accounts up to one-half of their vested balance with the total of all loans made not to exceed \$50,000 and must be a minimum of \$500. Loan maturities range from one to five years or greater than 5 years if the loan is used for the purchase of the participant's principal residence. The loans are secured by up to one-half of the participant's vested account and bear interest at a rate of 1% above the current prime interest rate. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. All loans become due upon separation of service or are deemed a distribution.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or partial payments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. Hardship withdrawals are also available to participants with certain types of immediate and heavy financial need, which fall under the stated guidelines of the Plan.

Forfeitures

Forfeitures occur when participants leave the Plan when they are less than fully vested. These amounts may be used to pay administrative costs of the Plan, reduce future employer contributions, or may be allocated proportionately among the participants. As of December 31, 2024, forfeitures available were \$6,747.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("U.S. GAAP") requires the trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The fair values of mutual funds and money market funds are based on quoted net asset values of the shares held by the Plan at year-end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are recorded as distributions in accordance with the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through March 9, 2026, the date the financial statements were available to be issued.

NOTE 3 – INVESTMENTS - INFORMATION CERTIFIED BY CUSTODIAN

Investments, income and net appreciation or depreciation in fair value of investments included in the accompanying financial statements and supplemental schedule have been certified by Fidelity Information Services, LLC ("FIS"), the investment custodian, to the Plan administrator as being complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 – TERMINATION OF PLAN AND RELATED TRUST

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan and related trust, subject to the provisions of ERISA. In the event of Plan termination, the amount of each participant's or beneficiary's account as of the date of such termination would become 100% vested and non-forfeitable in the employer matching and discretionary profit-sharing contributions, plus actual earnings thereon.

NOTE 5 – ADMINISTRATIVE EXPENSES

Administrative costs of the Plan related to administration of participant accounts and benefits, accounting, auditing and legal fees are paid directly by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Administrative expenses to the Plan were \$14,370 for the year ended December 31, 2024.

NOTE 6 – RELATED PARTIES AND PARTIES IN INTEREST TRANSACTIONS

Fidelity Information Services, LLC is the trustee of the Plan and fees paid by the Plan to FIS qualify as party in interest transactions and were included as a reduction of the return earned on each fund or charged to administrative expenses. ADP is the record keeper of the Plan. Fees paid by the Plan to ADP qualify as party in interest transactions and were charged to administrative expenses.

NOTE 7 – INCOME TAX STATUS

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan last obtained a favorable determination letter from the Internal Revenue Service on October 06, 2020. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – INVESTMENT FAIR VALUE MEASUREMENT

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Mutual funds with registered investment company: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE 10 – INELIGIBLE PARTICIPANT CONTRIBUTIONS

Under the terms of the Plan, independent contractors are not eligible to participate. During the 2024 Plan year, certain independent contractors were incorrectly treated as eligible due to an error in the Plan’s eligibility configuration. As a result, elective deferrals and Roth contributions, totaling approximately \$7,000 were erroneously accepted. These amounts were included in Plan assets as of December 31, 2024.

In the subsequent period, the Plan Sponsor updated the eligibility configuration to prevent further ineligible contributions and is currently working with the recordkeeper to determine the process for returning the ineligible contributions, including allocable earnings or losses.
