As described in Note 1 to the financial statements, management of the Plan sponsor adopted a pooled employer plan (“PEP”) and merged this Plan into the PEP effective May 31, 2025. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF PLAN

The following description of the Huddle Resource Services LLC-401(k) (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established effective January 1, 2018 and was most recently restated effective July 31, 2022. The Plan covered substantially all employees of Huddle Resources Services LLC (the “Company” or “Plan Sponsor”), except for nonresident aliens and residents of Puerto Rico. Employees were eligible to participate in the Plan upon attaining 21 years of age. Eligible employees could enter the Plan on the first day of the month coincident with or immediately following satisfaction of the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Merger

In April of 2025, management of the Company resolved to adopt The RetireSmart PEP (the “PEP”), a pooled employer plan, effective June 1, 2025. In connection with adopting the PEP, management of the Company elected to merge the Plan into the PEP effective May 31, 2025. All Plan assets and related participant accounts were transferred and assigned to the PEP on May 31, 2025.

As a result of the Plan merger discussed above, there is an additional short plan year reporting period for the period January 1, 2025 to May 31, 2025 included in these financial statements that concludes when all Plan assets were merged into the PEP. Accordingly, these financial statements comprise the statements of net assets available for benefits as of May 31, 2025, December 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period January 1, 2025 to May 31, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Contributions

The Plan allowed for pre-tax and Roth salary deferrals. Participants could contribute up to 90% of annual compensation, as defined in the Plan. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Rollover contributions were subject to the terms of the Plan and were fully vested and non-forfeitable. Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan included an automatic enrollment feature under which newly eligible employees were automatically enrolled in the Plan after satisfying the eligibility requirements unless they affirmatively elected not to participate in the Plan. Automatically

enrolled participants had their deferral rate set to make pre-tax contributions to the Plan at a rate of 3% of compensation, as defined, and their accounts under the Plan were automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"), unless the employee elected otherwise. The Plan had elected the Fidelity Freedom Index Fund series as its QDIA. Employer contributions were not permitted in the Plan. Contributions were subject to certain statutory limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants were secured by the balance in the participant's account. The loan interest rate, determined monthly, was set at 2% above the prime rate, as defined. Principal and interest was paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump sum amount, substantially equal installments equal to the value of the participant's vested interest in his or her account, or a partial withdrawal of a portion of their vested account balance. Participants were entitled to receive in-service withdrawals upon attainment of age 59½ or as a hardship distribution, as defined in the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

At December 31, 2024 and December 31, 2023, investments are reported at fair value. At May 31, 2025, there were no investments held by the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

At December 31, 2024 and 2023, notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. At May 31, 2025, there were no notes receivable from participants held by the Plan. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

3. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value, and notes receivable from participants held at May 31, 2025, December 31, 2024 and December 31, 2023, and net change in fair value of investments, dividends, and interest income from notes receivable from participants for the period January 1, 2025 to May 31, 2025 and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services, LLC and Reliance Trust Company, the trustees of the Plan.

Effective January 1, 2025, the trustee of the Plan changed from Reliance Trust Company to ADP Retirement Trust Services, LLC.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust

Common Collective Trusts are not publicly quoted and are priced at net asset value ("NAV"). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

ADP, LLC was the recordkeeper of the Plan and therefore certain transactions qualify as exempt party-in-interest transactions. During the period January 1, 2025 to May 31, 2025 and the year ended December 31, 2024, administrative fees of approximately \$6,000 and \$13,000, respectively, were paid to ADP, LLC from the Plan.

6. PLAN TERMINATION

Prior to the Plan merger discussed in Note 1, although it had not expressed any intent to do so, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would have remained fully vested in their accounts.

7. TAX STATUS

The Company had adopted a pre-approved plan document that received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan had been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
