## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 403(b) Thrift Plan for Employees of Visiting Nurse Association of Boston Foundation, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2 to the financial statements.
- The information in the financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. GAAP. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting. This includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**1. Description of Plan**

The following description of 403(b) Thrift Plan for Employees of Visiting Nurse Association of Boston Foundation, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a tax-exempt, defined contribution plan, sponsored by the Visiting Nurse Association of Boston, Inc. (the "Association"). The Plan was adopted on October 1, 1982 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Lincoln National Life Insurance Company (Lincoln) and Mutual of America Life Insurance Company (MOA) (collectively, the "custodians") are the custodians of the Plan.

**Eligibility**

The Plan is available to all Association employees for elective deferrals, except employees who are non-resident aliens. Employees may begin making elective deferrals to the Plan upon hire.

The Plan is available to all Association employees for the purpose of the employer match contributions upon completion of two years with 1,000 hours of service in each year and attainment of age 21, with the exception of employees who are non-resident aliens, part-time employees who normally work less than 18.75 hours per week, per diem employees and non-benefit eligible per visit employees.

**Contributions**

Each year, eligible employees may make contributions to the Plan through salary deferrals up to 100% of eligible compensation, as defined in the Plan. The maximum amount that a participant may contribute is limited to provisions of the Internal Revenue Code (the Code).

For employees covered under the Massachusetts Nursing Association Contract (the Contract), the Association match contributions are made in accordance with the Contract. For all other eligible employees, the Association provides a discretionary base contribution. The contribution is allocated among participants based on their compensation as a percentage of the total compensation of all eligible participants for the Plan year. For the year ended December 31, 2024, the Association made a contribution equal to 2% of eligible participant compensation. The Association does not match age 50 catch-up deferrals.

**Participant Accounts**

Individual accounts are maintained for each participant and are credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Investment Options**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in various pooled separate accounts and group annuity contracts.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. For employees covered under the Contract, vesting in the Association's match contributions, plus actual earnings thereon, is immediate. For all other employees receiving the employer discretionary base contribution, vesting in the contributions plus actual earnings thereon, is based on continuous service (1 year of service is 1,000 hours) as follows:

A participant becomes immediately 100% vested in accounts derived from employer contributions and investment earnings upon death, disability, or attainment of normal retirement age (age 65).

**Forfeitures**

Participants who terminate their employment prior to becoming 100% vested, forfeit their non-vested account balance. These benefits plus accumulated investment earnings are left in the Plan and will be used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$120 and \$6,027, respectively. Forfeitures are not used to reduce employer contributions and are instead reallocated to eligible participant accounts after the close of the Plan year.

**Payment of Benefits to Participants**

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump-sum payment or a monthly annuity. In addition, participants may withdraw their elective deferral contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined by the Code.

**Notes Receivable from Participants**

Participants may borrow up to the lesser of 50% of their participant account balance or \$50,000, subject to certain limitations as set forth in the Plan document.

Plan loans taken by Lincoln and MOA participants are issued directly from the funds owned by the custodians instead of being removed from the participant's account balance. These loans are collateralized by 100% of the participant's account, which is required to be maintained in the group annuity contracts. As loans are paid off, participants may reinvest their funds as they choose. As of December 31, 2024 and 2023, respectively, \$162,574 and \$246,348, respectively, was pledged as collateral for loans to participants from these custodians.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses and related liabilities are recognized when paid, rather than when incurred.

**Use of Estimates**

The preparation of financial statements in conformity with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Group annuity contracts which are fully benefit-responsive are reported at contract value. See Note 9 for a summary of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Certain administrative expense are paid by the Association.

**Payment of Benefits**

Benefit payments are recorded upon distribution.

**Subsequent Events**

Management has considered transactions or events occurring through March 12, 2026, the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

**3. Tax Status**

The Plan is a volume submitter plan, sponsored by the recordkeeper. The volume submitter plan received a favorable advisory letter dated March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**4. Information Prepared and Certified by the Custodians**

The investments, investment transactions, net appreciation in fair value of investments and interest and dividends were obtained by management and agreed to or derived from the information certified by MOA and Lincoln, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis);
- Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis); and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

**5. Investment Contracts with Insurance Companies**

*Interest Accumulation Account*

The interest accumulation account is an investment contract, between participants and MOA, which is held in the general account of MOA. The contract is a fully benefit-responsive contract. The contract is included in the financial statements at contract value as reported to the Plan by MOA. The account represents contributions made under the contract, plus cumulative interest earnings, less participant withdrawals and administrative expenses. This account becomes part of MOA's general assets, which supports the company's insurance and annuity obligations. MOA bears the full investment risk of all amounts participants allocate to the interest accumulation account. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

To the extent permitted within the Plan contract, participants may ordinarily direct the withdrawal or transfer their investment at contract value. There are no events noted within the Plan that would limit the ability to execute transactions at contract value.

*Multifund Fixed Account*

Investment in Lincoln Multifund Fixed Account is in an insurance company general account. Contributions to this investment buys contractual or guaranteed amounts of future benefits for the participant. Interest credited to the investment includes guaranteed rates plus additional amounts established on a year-by-year basis. The contract is included in the financial statements at contract value, as reported to the Plan by Lincoln. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1% to 3.50% for all contracts. Such interest rates are reviewed on an annual basis for resetting.

**6. Parties-In-Interest**

Certain Plan investments are managed by the custodians; therefore, these transactions qualify as party-in-interest transactions. The Plan incurred administrative expenses with the custodians amounting to \$3,890 during the year ended December 31, 2024.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Association has the right to terminate the Plan subject to the provisions of ERISA.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

**9. Fair Value Measurement**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurement*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts are valued at the quoted market price of the underlying assets and adjusted for administrative charges of the separate account.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
