## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Litigation Services Management 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1. DESCRIPTION OF PLAN**

The following description of Litigation Services Management 401(k) Saving Plan (the "Plan") provides only general information. Participants should refer to the plan agreement or summary plan description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Litigation Services Management and its affiliated companies (collectively the "Company" or the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustee.

Effective January 1, 2024, the Plan merged with another plan and there were no participants or funds remaining in the Plan. The other plan was the surviving plan.

**Eligibility**

Employees become eligible to participate in the Plan after completion of three months of service with one hour of service in each month and attainment of 18 years of age or older.

**Contributions**

Each year, participants may authorize the Company to reduce their compensation and defer up to 100% of compensation up to the maximum allowable under the Internal Revenue Code ("IRC"). In addition, all employees who are eligible and who have attained age 50 before the close of the Plan year are eligible to make "catch-up" contributions up to the maximum allowable under the IRC. Participants may also contribute under the Roth contribution option. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a safe harbor match contribution on 100% of salary deferrals up to 3% of plan compensation and 50% of salary deferrals for the next 2% of plan compensation. In addition, the Company may also make an additional discretionary employer match and/or profit-sharing contribution to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's matching and profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

**Vesting**

Participants are immediately vested in their contributions and all employer contributions to the Plan plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid in equal installments consisting of principal and interest over a period not to exceed five years. The loans are secured by the balance in the participant's account and bear interest at rates specified in the plan document. The appropriate interest rate is based on interest rates for loans of comparable quality and duration extended by banks and other financial institutions for loans under similar circumstances. Rates on outstanding loans ranged from 4.25% to 5.50% at December 31, 2023.

**Payment of Benefits**

On termination of service, death, disability or retirement, a participant may choose to withdraw his or her balance as a lump sum, receive a series of monthly payments or continue to maintain the balance in the Plan. A participant who has attained age 55 and completed five years of vested service shall be entitled to withdraw all or any portion of his or her account.

**Forfeited Accounts**

At January 31, 2024 and December 31, 2023 forfeited nonvested accounts totaled \$0. These accounts will be used to reduce future employer contributions and administrative expenses.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The process of preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions regarding certain types of assets, liabilities, additions to net assets, and deductions from net assets. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of January 31, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Excess Contributions Payable:**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There was none as of January 31, 2024 and \$10,966 as of December 31, 2023.

**Payment of Benefits**

Benefits are recorded when paid. Amounts allocated to participants who have chosen to withdraw from the Plan, but who have not yet been paid are not recorded as a liability, but are disclosed.

**Administrative Expenses**

The Company pays certain administrative expenses associated with the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Loan origination and distribution fees other than hardships are deducted from participant account balances and are included in administrative expenses. Fees associated with hardship distributions are paid by the Company.

**Subsequent Events**

The Plan has evaluated all events and transactions that occurred after January 31, 2024 for potential recognition or disclosure through February 4, 2026, the date the financial statements were available to be issued.

**NOTE 3. INFORMATION CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at December 31, 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by VOYA Retirement Insurance and Annuity Company (VOYA).

**NOTE 4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

**Mutual Funds**

Value at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5. GROUP ANNUITY CONTRACTS WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with VOYA Retirement Insurance and Annuity Company (“VOYA”) totaling \$801,983 as of December 31, 2023. VOYA maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate and is contractually obligated to repay the principal and a specified interest rate that is declared at the beginning of each year.

The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully-benefit responsive investment contract criteria; therefore, is reported at contract value. Contract value is the relevant measure of fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the Issuer’s ability to meet its financial obligations. The Issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options, (3) bankruptcy of the Plan’s sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

**NOTE 6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by VOYA. VOYA is the qualified institution as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. VOYA receives revenue from investment providers for services VOYA provides to the funds. This revenue is remitted to the Plan. Such amounts may be applied to pay Plan administrative expenses.

**NOTE 7. PLAN TERMINATION**

As of January 1, 2024, the Plan merged into Veritext, LLC 401(k) Savings plan and all assets were transferred to that plan.

**NOTE 8. TAX STATUS**

The Internal Revenue Service (“IRS”) provided an opinion letter dated March 31, 2014 that the Prototype Non-Standardized Profit Sharing Plan with CODA qualifies under Section 401 of the Internal Revenue Code (“IRC”). The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits.
