## Independent Auditors' Report

### Opinion

**Note 1 - Description of Plan**

The following description of the Miles IT Company Employee Benefit Plan (the “Plan”) provides only general information. Participants should refer to the plan document and any amendments thereto for a more complete description of the Plan’s provisions.

**General**

The Plan and Trust were established on January 1, 2021 to provide medical and prescription drug benefits to eligible participants and their dependents. The sponsoring employer, Miles IT Company (the “Company”, previously Miles Technologies, Inc.) is bound by the terms and conditions of the Trust agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Securities Act of 1974, as amended (ERISA). The Plan was amended effective May 22, 2023 to change the name of the Plan from Miles Technologies, Inc. Employee Benefit Plan to Miles IT Company Employee Benefit Plan. The Plan was amended effective January 1, 2024. The Trust was terminated effective January 1, 2024.

**Benefits**

The Plan provides self-funded medical and prescription drug benefits for eligible participants and their dependents. For the year ending December 31 2023, the claims for self-insured benefits are processed by the Plan’s third-party claims processor pursuant to the agreement with Veris Benefits Consortium, LLC. For the year ending December 31 2024, the claims for self-insured medical benefits are processed by the Plan’s third-party claims processor pursuant to the agreement with Imagine360 Administrators, LLC. For the year ending December 31 2024, the claims for self-insured prescription benefits are processed by the Plan’s pharmacy benefit manager pursuant to the agreement with Rx Benefits. Information about the Plan is available in the Plan documents, the Plan’s Trust agreement and the Service Agreement.

**Contributions**

The Plan is a contributory plan that is funded by participating employees and Company contributions. Active employee contributions are withheld through payroll deductions in amounts determined by the employee’s elections during the annual enrollment period.

For the year ending December 31, 2024, annual contributions are the net of employee contributions, stop loss reimbursements, claims, administrative fees and stop loss premiums as all expenses are paid from the Plan Sponsor’s general assets.

For the year ending December 31, 2023, the annual contributions required are actuarially determined by Benecon Group, LLC and are based on historical claims data; Benecon Group, LLC provides this service to Veris Benefits Consortium, LLC.

**Payment of benefits**

The Plan provides certain medical and prescription drug benefits to participating employees and their eligible dependents based on the type of service rendered and whether an in-network or out-of-network service provider is used.

**Plan administration and expenses**

For the year ending December 31, 2024, administrative expenses are paid from the general assets of the Plan Sponsor.

For the year ending December 31, 2023, administrative expenses are paid from Plan assets. Pursuant to an agreement between the Company and Veris Benefits Consortium, LLC, certain administrative and management services for the Plan are provided by Veris Benefits Consortium, LLC.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis, additions to net assets are recognized when received rather than when due and deductions from net assets are recognized when paid rather than when incurred. Consequently, no liabilities for health claims incurred but unpaid are included in the financial statements. In addition, no assets related to potential insurance recoveries or under funding amounts, if any, are included in the financial statements.

**Cash**

The Plan has no cash as of December 31, 2024. The Plan's cash as of December 31, 2023 consists of an interest bearing account to pay claims as incurred.

**Benefit payments**

For the year ending December 31, 2024, claim payments are recorded when the funds are transferred from the Plan Sponsor's bank account to the third-party claims' processor.

For the year ending December 31, 2023, claim payments are recorded when the funds are transferred from the Plan's bank account to Veris Benefits Consortium, LLC for remittance to the third-party claims' processor.

**Estimated benefit obligations**

The total amount of estimated benefit obligations is determined based on (1) historical data regarding the time that typically elapses between the dates on which claims are incurred and the dates on which they are paid, and (2) available information about the amount of claims that were paid subsequent to the fiscal year end but incurred during the fiscal year.

**Administrative expenses**

All administrative expenses are generally paid by the Plan Sponsor. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Estimates**

The preparation of financial statements using the cash basis of accounting requires Plan management to make estimates and assumptions that affect the amounts reported in the cash basis financial statements. Such estimates primarily relate to unsettled transactions and events as of the date of the cash basis financial statements. Accordingly, upon settlement, actual results may differ from those estimates and assumptions.

**Concentrations of credit risk**

The Plan maintains its cash balances in one financial institution which may, from time-to-time, exceed the FDIC limit. Management does not feel there is a risk of loss.

**Note 3 – Income tax status**

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

**Note 3 – Income tax status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

The plan administrator is in the process of filing an amended 2024 Form 5500 under the Delinquent Filer Voluntary Compliance Program. The Plan administrator has filed an amended 2023 Form 5500 under the Delinquent Filer Voluntary Compliance Program.

**Note 4 – Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Plan shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of Plan management, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the Plan’s participants.

**Note 5 – Other risks and uncertainties**

The present value of benefit obligations is reported based on certain assumptions pertaining to historical claims paid and future claims, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

These estimated benefit obligations and the changes in the benefit obligations are not reported in the accompanying cash basis financial statements because of the Plan’s use of the cash basis of accounting, as described in Note 2.

Note 7 – Stop loss

The Company has a stop loss insurance policy in order to be reimbursed for Plan benefits paid in excess of a specific attachment point. For the Plan year ending December 31, 2024, the specific attachment point was \$125,000 per individual. The policy also includes an aggregating specific attachment point of \$2,534,635. For the Plan year ending December 31, 2023, the specific attachment point was \$115,000 per individual. The policy also includes an aggregating specific attachment point of \$2,172,323. Once an individual exceeds the specific attachment point, then they or a group of participants must also exceed the aggregating specific attachment point before the Plan Sponsor is reimbursed. For the year ending December 31, 2023, the insurance company also provides advance funding of stop loss reimbursements. After acceptable proof of loss and satisfactory proof of paid plan benefits, the insurance company will then reimburse the Plan. Any differences between advance funding of stop loss reimbursements and funding of actual stop loss reimbursements are reconciled once the policy year is closed out. At that time, any funding due to the plan or due to the insurance company are settled. For the Plan years ending December 31, 2024 and 2023, stop loss premiums paid were \$353,040 and \$440,706, respectively.
