## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 401(k) Profit-Sharing Plan for Employees of VNA Care Network, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2 to the financial statements.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The following description of 401(k) Profit-Sharing Plan for Employees of VNA Care Network, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan qualifying under section 401(k) of the Internal Revenue Code (the Code) and covers eligible employees of VNA Care Network, Inc., and its affiliates, VNA Care Network Foundation, Inc.; VNA Care Hospice, Inc.; and VNA Care Advantage, Inc. (collectively, the Association). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, eligible participants may make contributions to the Plan through salary deferrals up to 100% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum amount that a participant may contribute is limited by provisions of the Code.

Rollover contributions may be made by participants from certain other qualified plans described under certain sections of the Code, as defined by the Plan.

Each year, the Association's Board of Directors (Board) determines the amount of employer contributions to be paid to the Plan. Effective January 1, 2020, there are no requirements to be eligible to receive the employer contribution. The contribution is allocated among participants based on their compensation as a percentage of the total compensation of all eligible participants for the Plan year. In 2024, the Association made discretionary employer contributions equal to 50% of the first 4% of an eligible participant's compensation in pay periods in which participants had funds withheld from their pay.

#### Participant Accounts

Individual accounts are maintained for each participant and are credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. The Association offers a group annuity contract and various pooled separate account funds (funds or portfolios of mutual funds).

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Association's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service (1 year of service is 1,000 hours) as follows:

2	20%
3	40%
4	60%
5	80%
6	100%

A participant becomes immediately 100% vested in accounts derived from employer contributions and investment earnings upon death, disability, or attainment of normal retirement age (age 65).

### **Forfeitures**

Participants who terminate their employment prior to becoming 100% vested forfeit their nonvested account balance. These benefits plus accumulated investment earnings are left in the Plan and will be used to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$279. Forfeitures used to reduce employer contribution during 2024 amounted to \$44,747.

### **Notes Receivable from Participants**

Participants may borrow up to \$50,000, subject to certain limitations and vested account balance, as set forth in the Plan document.

### **Benefits Paid to Participants**

Upon severance from employment, attainment of age 59½, normal retirement age (age 65), disability, or death, a participant or beneficiary may receive an amount equal to the value of the participant's vested interest in his or her account in various annuities or lump-sum amounts. If a participant incurs a hardship, as defined by the Plan, a participant may receive an amount equal to the value of the participant's vested interest in his or her account.

A participant who terminates employment with a vested account balance of \$5,000 or less and does not elect to receive a distribution, will receive an involuntary cash-out distribution. If a participant's vested account balance is greater than \$1,000 but less than \$5,000, the vested balance will be rolled over into an individual retirement account, unless otherwise directed by the participant. If a participant's vested account balance is less than \$1,000, a lump-sum distribution will be made.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when incurred.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

**Investments**

Investments are reported at fair value, except for the Interest Accumulation Account which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a summary of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are valued using the unpaid principal balance. Interest income on notes receivable from participants is recorded when it is received. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Administrative expenses are paid by the Association.

**Subsequent Events**

Management has considered transactions or events occurring through March 12, 2026, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### 3. Investments Measured at Contract Value

The Interest Accumulation Account is an investment contract, between participants and Mutual of America Insurance Company (MOA), which is held in the general account of MOA. The contract is a fully benefit-responsive contract. The contract is included in the financial statements at contract value as reported to the Plan by MOA. The account represents contributions made under the contract, plus cumulative interest earnings, less participant withdrawals and administrative expenses. This account becomes part of MOA's general assets, which supports the company's insurance and annuity obligations. MOA bears the full investment risk of all amounts participants allocate to the interest accumulation account. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The average yield earned by the Plan is based on the crediting interest rate declared by MOA from time to time. The interest rate is a result of an agreed upon formula stated in the contract, but not below the guaranteed minimum interest rate of 1%.

To the extent permitted within the Plan contract, participants may ordinarily direct the withdrawal or transfer their investment at contract value.

### 4. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts are valued at the quoted market price of the underlying assets and adjusted for administrative charges of the separate account.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Parties-in-Interest

Certain of the Plan's investments are managed by MOA and, therefore, these transactions qualify as party-in-interest transactions.

## 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

**7. Tax Status**

The Association has adopted a prototype plan which has received a favorable opinion letter from the Internal Revenue Service dated November 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. As a qualified plan, the Plan is exempt from federal and state income taxes.

**8. Information Prepared and Certified by Custodian**

The investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments, and interest and dividends were certified by the MOA as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis);
- Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis); and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

**9. Plan Termination**

Although it has not expressed any intent to do so, the Association has the right to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become fully vested in their employer contributions.
