Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Christian Schools International 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Christian Schools International 403(b) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. Christian Schools International (CSI), the plan sponsor, established the Plan as of July 1, 2019.

General

The Plan is a multiple-employer 403(b) plan covering eligible participating employers (collectively, the "Plan Sponsor" or the "Company"). All employees of participating employers are eligible to participate if they are expected to work more than 20 hours per week or if the participant has 1,000 hours of service in any 12-month period, as defined by terms of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant may elect to make contributions to the Plan through payroll deductions elected by the participant in amounts that may be 1 percent up to 100 percent of the participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to roll over funds from other employer-qualified plans into the Plan.

Each employer may elect to make matching contributions based on the amount of eligible compensation deferred by a participant. An employer may also elect to contribute a discretionary amount based on a percentage of each participant's compensation.

During 2025 and 2024, the Plan Sponsor remitted certain employee deferrals to the Plan after the Department of Labor's required time frame. Contributions of lost earnings were made during and subsequent to the plan year ended June 30, 2025.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

Participant Accounts

Each participant's account is credited with the participant's contributions, contributions by the participant's employer, and plan earnings and charged with an allocation of administrative expenses, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

A participant is immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in employer matching and discretionary contributions, plus actual earnings thereon, is based on years of service. A participant is 100 percent vested in contributions made by the participant's employer after three years of service, as defined by terms of the Plan, unless a participating employer elects for immediate vesting. A participant also becomes fully vested at the time of a participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age. A participant's benefit is equal to the vested balance of a participant's account. A participant may choose the form of payment from the options permitted by the plan document.

Note 1 - Plan Description (Continued)

Financial hardship withdrawals are only permitted from a participant's pay deferral account and Roth 403(b) account. The plan administrator must approve any such hardship withdrawals. Certain amounts invested in the TIAA Traditional Annuity group annuity contract may not be distributed in a lump sum; see redemption restrictions below.

Redemption Restrictions

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Withdrawals from the Retirement Choice (RC) contract are available within 120 days after termination of employment, subject to 2.5 percent surrender charge; otherwise, they must be paid over 84 monthly installments or via an annuity. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to first pay administrative expenses of the Plan and then allocated pro rata to participants based on compensation.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF) and TIAA Trust, N.A. (formerly known as TIAA, FSB) or its affiliates. TIAA-CREF is a service provider of the Plan, and TIAA Trust, N.A. is a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, CSI has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. Additionally, each participating employer has the right to cease participation in the Plan.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The TIAA Traditional Annuity is a guaranteed annuity account issued by TIAA that invests in the general assets of TIAA. TIAA considers the following contract to be benefit responsive: Retirement Choice Plus (RCP). TIAA considers the following contract to be non-benefit responsive: Retirement Choice. The non-benefit-responsive portion is recorded at fair value. The benefit-responsive portion is recorded at contract value. Since there are no specific securities in TIAA's general account related to the contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value is the best estimate of fair value for the non-benefit-responsive contract. Contract value represents principal invested, plus interest earned, less any withdrawals.

The registered investment companies are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. Investments in the pooled separate account are valued at net asset value per share (or its equivalent) of the fund, which is based on the fair market values of the underlying net assets, which consist primarily of rental property subject to long-term leases, and have been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved.

Note 2 - Summary of Significant Accounting Policies (Continued)

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs during the 2025 and 2024 plan years were paid by the participating employers.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 9, 2026, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

TIAA-CREF and TIAA Trust, N.A. hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA-CREF, including TIAA, as agent for TIAA Trust, N.A.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Transfers from Other Plans

The Plan may be adopted by schools that become CSI member schools. Schools may adopt the Plan subject to execution of a participation agreement, in which each employer will elect the eligibility, contribution, participant loan features, and vesting provisions applicable to its adoption of the Plan.

New adopting employers transferring assets from other plans are reflected as net transfers from other plans in the statement of changes in net assets available for benefits. There were no transfers from other plans during 2025 or 2024.

Note 7 - Unallocated Contracts

Based on the terms of the contract, a portion of the TIAA Traditional Annuity is considered benefit responsive. The benefit-responsive portion of the TIAA Traditional Annuity totaled \$4,244,828 and \$3,070,168 at June 30, 2025 and 2024, respectively. The contract issuer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintages approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, it has been between 1.00 percent and 3.00 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
