We have performed an audit of the financial statements of OCDK 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of OCDC 401(K) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Oregon Child Development Coalition (the Plan Sponsor and Organization) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Organization and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Organization and any participating affiliates are subject to the following eligibility requirements:

- Status Exclusions:
 - a. Residents of Puerto Rico
 - b. Independent contractors

Upon satisfying the eligibility requirements, employees may participate in the Plan immediately upon eligibility.

Contributions

The Plan is funded through employee elective deferrals and Organization contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The following contribution types are allowed by the Plan:

- Employer safe harbor
- Participant elective deferrals
- Employer profit sharing
- Participant rollover contributions

The Organization has elected to operate the Plan as a safe harbor 401(k) plan, which makes the Plan exempt from certain compliance testing requirements. The Organization makes a safe harbor matching contribution of 100% of the participant's deferral up to 5% of compensation.

The Organization may make discretionary profit sharing and matching contributions which will be allocated in accordance with the Plan document provisions. Participants must have earned 1,000 hours of service to be eligible to receive discretionary profit sharing and matching contributions. During 2024, the Organization made a discretionary profit sharing contribution of \$2,123,457 and a discretionary matching contribution of \$1,725,729.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the Organization's contributions, and Plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan, continued

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, matching and discretionary contributions, and actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Notes Receivable from Participants

Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the balance in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions and generally repaid within 5 years. Interest rates on outstanding loans at December 31, 2024, ranged from 4.25% to 9.5%.

Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary. Participants whose vested balance is \$7,000 or less may automatically receive a lump-sum distribution at the discretion of the Plan Administrator.

Plan Expenses

The Plan's expenses are paid by either the Plan or the Organization, as provided by the Plan document. Expenses paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Termination of the Plan

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Organization will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

Revenue Sharing

The Plan has a revenue sharing agreement with the Plan's Custodian. This revenue sharing agreement provides the Plan with a portion of the fees collected by the Custodian. During 2024, the Plan received \$104,799 in revenue sharing. At December 31, 2024 and 2023, unallocated revenue sharing totaled \$143,190 and \$35,715, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events were evaluated through March 6, 2026, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by Custodian

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Talcott Resolution Life Insurance Company, collectively, the "Custodian" of the Plan. The Plan Administrator has obtained a certification from the Custodian as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Custodian is complete and accurate:

Note 4 - Fair Value Measurements

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts (PSA): PSAs invest in a variety of domestic stock, international stocks, mutual funds, bonds and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the net asset value (NAV) of each PSA is not valued using publicly quoted prices. The NAV provided by the Custodian is used as the practical expedient to estimate fair value. PSA's can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to each PSA's prospectus for a description of the PSA and its investment strategy.

The investment strategies for these funds are as follows:

Asset Allocation

These funds are part of the target-date "SmartRetirement" series from J.P. Morgan Asset Management, designed to provide a single, all-in-one investment option tailored for a specific retirement date or for the income phase. They follow a glide-path asset-allocation strategy, meaning that early on in the "savings phase" they allocate heavily toward equities and growth-oriented assets, and over time they shift toward more conservative holdings, such as greater fixed-income, inflation-protection, and cash equivalents as the target date approaches and passes. They also integrate data and behavioral insights about how real people save and spend in retirement to inform allocation decisions. They aim to simplify retirement investing by offering diversified exposure to multiple asset classes, dynamically adjusting risk over time, and supporting both accumulation (pre-retirement) and withdrawal (post-retirement) phases.

Balanced

These funds share a core approach of blending multiple asset classes (equities and fixed income) to seek both growth and income while aiming to manage risk through diversification and active allocation. Each fund does not commit exclusively to stocks or bonds but rather dynamically allocates across them (and sometimes across geographies or sectors) to respond to market conditions and deliver a balanced outcome. These funds are actively managed, emphasize long-term horizons, and intentionally integrate flexible strategies (rather than static allocations) to navigate changing markets, seeking to provide a more moderate risk/return profile than a pure equity fund.

Bonds

These funds focus on fixed-income investments with a goal of generating income and managing risk, rather than taking a pure equity growth approach. They primarily invest in bonds (including corporate, high yield, and other debt securities) with varying degrees of credit quality and maturity, aiming to offer current income while seeking some capital appreciation. Each fund uses active management by analyzing credit, duration, sector, and market conditions to construct diversified portfolios of debt securities rather than simply tracking a bond index. While they differ in risk exposure and duration/credit-quality mix, the underlying theme is to invest in debt instruments, generate income, actively manage portfolio composition, and diversify credit risk to support steady returns in fixed income.

These funds share a global-equity focus with an emphasis on identifying companies outside the U.S. that offer above-average growth potential. They are actively managed, look through geographic and sector boundaries, and aim for long-term capital appreciation, with some funds also targeting current income in addition to growth. While their precise geographic or income tilt differs between a dividend/growth hybrid or growth-only in non-U.S. markets, the common thread is a belief that global companies exposed to innovation, shifting trade or economic patterns, and emerging consumer demand can deliver stronger long-term returns than a purely domestic or index-bound equity approach.

Large Cap

These funds share a common strategy centered on long-term capital appreciation through active equity investing. Each fund primarily invests in common stocks of companies with strong fundamentals and favorable growth prospects, using rigorous research and stock selection to identify opportunities. They are actively managed, emphasizing individual company analysis rather than index tracking. While some flexibility exists across market capitalizations and geographic regions, the funds generally focus on U.S. equities. Collectively, they aim to build diversified portfolios of quality businesses positioned for sustained earnings and capital growth, reflecting a shared belief that disciplined, research-driven investing in fundamentally sound companies can outperform over the long run.

Mid Cap

These funds focus their investments on the mid-cap, and in some cases small- to mid-cap, segment of the U.S. equity market, applying an active, bottom-up stock-selection process to identify companies believed to offer superior long-term capital appreciation. While some lean toward value, seeking companies temporarily undervalued or selling at a discount, and others lean toward growth or a blend approach, seeking companies with strong prospects and high-quality management, the shared element is a targeted emphasis on mid-sized companies rather than large-cap market-leaders, with the belief that these firms may offer a favorable mix of growth potential, latent value, and inefficiencies that active managers can utilize for above-average returns.

Small Cap

These funds concentrate on U.S. small-cap equities, employing active management to seek long-term capital appreciation. They invest in smaller companies that they believe offer above-average growth potential or companies deemed undervalued relative to their fundamentals. They tend to focus on the less-efficient segment of the market where active research can uncover mis-priced opportunities. Each fund embraces a higher-risk/higher-reward profile typical of small-cap investing, greater volatility, but also greater potential upside, with the idea that over time, disciplined selection of well-positioned small firms can deliver stronger returns.

Specialty

These funds are sector/theme specific equity funds that invest in particular slices of the investment universe rather than diversified broad-market portfolios. Each fund concentrates on a defined asset class or industry, such as real estate securities, precious metals/minerals companies, natural-resources and commodity firms, and utilities companies. They seek long-term appreciation, and in some cases income, through active management in that segment. They generally embody higher risk and return potential relative to broad-based funds, because they are exposed to the economic, regulatory, commodity-cycle, or sector-specific dynamics of their niches. These funds are designed to offer targeted exposure to major structural themes such as real assets, commodities, infrastructure/utility services, rather than being core holdings. They may serve as strategic or satellite pieces in a broader portfolio rather than the diversified foundation.

Note 5 - Fully Benefit-Responsive Investment Contracts

The Plan invests in the Talcott Resolution Life Insurance Company Fixed Account (the Contract), which is a fully benefit-responsive guaranteed investment contract (GIC). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established in a contract between the Plan and the contract issuer, which will not fall below 0%. The crediting rate is reviewed quarterly for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan).
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 - Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$104,102 to Empower Annuity Insurance Company of America and Empower Advisory Group, LLC for recordkeeping and investment management fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Tax Status

The Plan sponsor adopted a plan which received a favorable Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA opinion letter, sponsored by Empower Retirement LLC from the Internal Revenue Service (IRS) dated November 14, 2022, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
