As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 1, 2025 and December 31, 2024, and for the period January 1, 2025 through July 1, 2025, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Blank Rome Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Blank Rome Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1. Description of Plan

The following description of Blank Rome Savings Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a deferred compensation salary reduction program for attorneys, other than partners, public policy advisors of Blank Rome Government Relations LLC, and individuals who are Of Counsel to Blank Rome LLP (collectively, the "Firm"). Under the Plan, a participant may elect to have contributions made on his or her behalf by way of salary reduction. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended ("ERISA").

Effective July 1, 2025, the Plan was merged into Blank Rome Profit-Sharing Plan, the name was changed to Blank Rome Retirement Savings Plan, and all participant account balances were transferred. Effective July 1, 2025, participants were no longer eligible to make contributions into the Plan.

Deferred Compensation

All eligible employees are immediately eligible to participate in the Plan. The Plan provides for participants to elect pretax and Roth contributions, pursuant to a salary reduction program, not to exceed the limitations specified under the Internal Revenue Code ("Code") or the Plan.

Effective January 1, 2025, the plan was amended to include an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant makes an affirmative election otherwise.

Vesting

Participants are always fully vested in their account balances.

Rollovers and Transfers from the Plan

Rollovers into the Plan consist of participant account balances of a qualified plan of another employer or individual retirement account. Transfers out of the Plan are principally accounts of newly promoted partners into the Blank Rome Profit-Sharing Plan ("Profit-Sharing Plan"). Transfers into the Plan consist of participant accounts from the Profit-Sharing Plan (late career partners transitioning to senior counsel roles).

Investment Options

A participant may invest in a common/collective trust and a number of mutual fund investment options offered within the Blank Rome LLP Master Trust ("Master Trust") (see Note 3). The options also include a self-directed brokerage account. The participant alone decides how to invest these assets. The participant can invest in most listed stocks, options (if approved for options trading), corporate bonds, zero-coupon bonds, U.S. Treasury securities, mortgage securities and U.S. government agency bonds, certificates of deposit, unit investment trusts, foreign securities, and other mutual funds.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of Plan earnings and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined in the Plan document. Participant's accounts are invested at the participant's election in one or more investment options authorized under the Plan. Investment allocations may be changed by the participant at any time. Each participant's account is reduced for amounts withdrawn, distributed, or transferred from the Plan for the participant's benefit.

Revenue Sharing

Excess investment related revenue generated by Plan assets is used to cover Fidelity's cost of various processing, distribution, and recordkeeping services. Fidelity provides a revenue credit to the Plan on a quarterly basis, which is used to cover the Plan's cost of actuarial, audit, and investment advisory services. To the extent that the balance in the Plan's revenue credit account exceeds the cost of services rendered to the Plan, excess funds are distributed to Plan participants on a pro-rata basis.

Benefits

On termination of service, a participant receives a lump-sum payment from the Plan, either in the form of a cash payment or a direct rollover transfer to another qualified employee retirement plan or an individual retirement account. A terminated participant may defer receipt of benefits until attainment of age 72 (age 73 if the participant attained age 72 after December 31, 2022), unless the amount in the participant's account is less than the statutory minimum, \$1,000.

Effective September 13, 2017, the Plan was amended to allow for participants who are at least 59½ to elect a single in-service distribution in an amount not to exceed 10% of his or her account balance. The Plan was further amended, effective December 10, 2018, to allow for participants who are at least 75 to elect a single in-service distribution in an amount not less than 100% of his or her account balance.

Effective May 1, 2021, the Plan was amended to allow for benefits to be paid out either as a single-sum distribution or as a series of installments.

Effective July 1, 2022, the Plan was amended to allow participants who attain age 59 ½ to elect to receive a distribution such that the net proceeds from such distribution will be used to fund a health savings account for the benefit of the participant.

On March 27, 2020, the *Coronavirus Aid, Relief, and Economic Security (CARES) Act* was signed in to law. The *CARES Act* includes several relief provisions available to the Plan and its participants. Plan management has evaluated the relief provisions available to plan participants under the *CARES Act* and has implemented the following provisions:

- Special coronavirus distributions up to \$100,000.
- Increase the available loan amount to the lesser of \$100,000 or 100% of the participant's vested account balance.
- Extend the period for loan repayments, if applicable, up to one year.

Notes Receivable from Participants

A participant may borrow a maximum loan amount equal to the lesser of 50% of his or her vested account balance or \$50,000, minus the highest outstanding balance of the participants' loans during the preceding 12 months. The loans are secured by the balance in the participant's account, must be repaid within five years and bear interest at rates established by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are reflected on a trade-date basis. The net appreciation (depreciation) in the fair value of the Plan's investments consists of realized gains and losses and unrealized appreciation (depreciation) on those investments bought and sold as well as held during the year. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Substantially all expenses of maintaining the Plan are paid out of the Plan's revenue credit account.

Bonding

Section 412(a) of ERISA requires the Firm, as fiduciary of the Plan, to maintain a fiduciary bond in the minimum amount of 10% of Plan assets (which is not required to exceed \$500,000). During 2025 and 2024, the Firm's fiduciary bond was in the amount of \$500,000.

Subsequent Events

Management has evaluated subsequent events for the Plan through March 3, 2026, the date the financial statements were available to be issued.

Note 3. Plan's Interest in Master Trust

All of the Plan's investments are held in the Master Trust along with investments of the Blank Rome Profit-Sharing Plan. Each participating plan's interest in the investment funds of the Master Trust is based on account balances of the participants and their elected investment funds. The Master Trust assets are allocated between the two plans by assigning to each plan the specifically identified transactions. Each participating plan has a divided interest in the Master Trust.

In connection with the merger of the Plan assets into the Blank Rome Profit-Sharing Plan, the Master Trust was terminated effective July 1, 2025.

Note 4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures* ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1** inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** inputs to the valuation methodology, other than Level 1 inputs, that are based on observable market data. These include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** inputs to the valuation methodology are unobservable and significant to the fair value measurement, reflecting the Plan's own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation techniques employed by the Plan and Master Trust to determine each investment's fair value use prices and other relevant information generated by market transactions involving identical or comparable assets. There have been no changes in the methodologies used at July 1, 2025 and December 31, 2024.

Shares of mutual funds are valued at quoted market prices, which represent the net asset value of the shares held as of the reporting date. Investments in the common/collective trust are composed of units of an underlying trust which primarily is composed of fully-benefit responsive investment contracts and is valued at the net asset value ("NAV") of units of the underlying trust. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reporting NAV. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions. Self-directed brokerage accounts include investments in common stock, preferred stock, mutual funds, certificates of deposit, bonds, and cash and cash equivalents each with their own valuation method. Common stock, preferred stock, and mutual funds are valued at quoted market prices. Certificates of deposit are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. Bonds (government, municipal, and corporate) are valued based on yields currently available on comparable securities of issuers with similar credit ratings. Cash and cash equivalents are reported at amortized cost which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- a) In accordance with ASC Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in the above tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain of the Plan's investments in the Master Trust are mutual funds and a common/collective trust managed by Fidelity Management Trust Company, which is a related party to Fidelity Management Trust Company, the trustee of the Plan. Consequently, these transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Fidelity provides a revenue credit to the Plan on a quarterly basis, which is used to cover the Plan's cost of actuarial, audit, and investment advisory services. During 2025 the revenue credit amounted to 48,091 after paying all Fidelity record keeping expenses and was used to pay other vendors for fees incurred by the Plan. Blank Rome LLP provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

The Company reserves the right to amend, alter or terminate the Plan subject to the provisions of ERISA. The plan was terminated as of July 1, 2025, and all participant balances were transferred into the Blank Rome Profit-Sharing Plan. All participants were fully vested in their individual balances as of July 1, 2025.

Note 7. Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated May 24, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 1, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2022.

Note 8. Trustee of the Plan

The Plan, along with the Blank Rome Profit-Sharing Plan, has entered into a master agreement with Fidelity Management Trust Company ("Fidelity") to provide investment services and serve as the trustee for the Plans.

Note 9. Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The investments of the Plan are held by the principal trustee, Fidelity. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments included in the Plan's interest in the Master Trust and notes receivable from participants, as shown in the statements of net assets available for benefits as of July 1, 2025 and December 31, 2024,
- Investment income from the Plan's interest in the Master Trust and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period ended July 1, 2025, and
- Master Trust Level detail included in the footnotes herein

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
