## Notes to Financial Statements

May 31, 2025 and 2024

### 1. Description of Plan

The following description of Index Packaging, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan provisions for more detailed information.

#### General

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Index Packaging, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Vanguard Group, Inc. is the recordkeeper of the Plan. The Vanguard Group, Inc. outsources substantially all administrative, recordkeeping and reporting functions to Ascensus, Inc. and, therefore, Ascensus, Inc. also serves as the recordkeeper of the Plan. Ascensus Trust Company, a wholly-owned subsidiary of Ascensus, Inc., is the trustee of the Plan.

#### Eligibility

The Plan is available to substantially all Company employees. Eligible employees may begin making elective deferrals to the Plan and are eligible for the employer contributions upon attaining age 21 and completing one year of service in which they work at least 1,000 hours.

#### Vesting

Participants are immediately vested in their own contributions and vest in the employer contributions in accordance with the following vesting schedule:

#### Contributions

Each year, eligible employees may make contributions to the Plan through salary deferrals on a pre-tax basis up to 100% of their compensation, as defined in the Plan. Participants may also elect to make Roth contributions. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code).

The Company may make discretionary matching contributions and profit-sharing contributions to the Plan on behalf of eligible participants. For the year ended May 31, 2025, the Company elected to contribute 75% of employee elective deferrals on up to 6% of compensation or less (limit of 3% of compensation, as defined in the Plan) beginning June 21, 2024.

### **Participant Accounts**

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and Company's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable from Participants**

Participants may borrow up to the lesser of 50% of their individual account balance or \$50,000. Notes receivable from participants terms generally range from one to five years, but may be longer for the purchase of a primary residence. The interest rate for notes receivable from participants will be computed using the prime rate (as specified in the Wall Street Journal) plus 1%.

### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in various mutual funds and a common collective trust fund.

### **Benefit Payments**

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65 and early retirement is age 60 with one year of service in which the employee works 1,000 hours or more), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive benefit payments in a single lump-sum or a monthly annuity. Hardship withdrawals are not permitted under the Plan.

## 2. **Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses and related liabilities are recognized when paid, rather than when incurred.

### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### **Investments**

Investments are reported at fair value, except for the common collective trust, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a summary of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan gains and losses on investments bought and sold, as well as those held, during the year.

### **Administrative Expenses**

Certain administrative expenses are paid by the Company; however, distribution and loan processing fees are paid by the respective participants at the time of the transaction. The Plan also pays recordkeeping fees to the recordkeeper.

### **Benefit Payments**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through March 16, 2026, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Investment in Common Collective Trust**

The Plan has an investment in the MetLife Stable Value Fund, a fully benefit responsive investment contract, which maintains contributions in a general account. Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by MetLife. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

#### 4. Income Tax Status

The Plan operates under a prototype plan document and is intended to qualify for tax-exempt status under the applicable sections of the Code. The Internal Revenue Service has determined and informed the Company or the recordkeeper, by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. Accordingly, the plan administrator believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 5. Information Prepared and Certified by Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividend amounts were certified by Ascensus, Inc., the recordkeeper of the Plan acting as agent for Ascensus Trust Company, the trustee of the Plan, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis);
- Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis); and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

#### 6. Parties-In-Interest

Certain of the Plan's investments are managed by the Plan's recordkeeper; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and certain administrative expenses amounted to \$14,778 for the year ended May 31, 2025.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

### 9. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued using market quotations at year-end.
