Management, having determined it is permissible in the circumstances, has elected to have the audits of Smith Senior Living 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Note 1. Description of Plan**

The following description of the Smith Senior Living 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### ***General***

The Plan is a defined contribution plan covering all employees of Smith Senior Living (Company or Employer), a nonprofit organization, except for leased employees, and nonresident aliens, who have three months of service and are at least twenty-one years of age. Employees must be employed for one year to become eligible for nonelective discretionary contributions. An eligible employee becomes a participant in the Plan as of the date on which he or she meets the eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as subsequently amended.

### ***Contributions***

Participants may contribute a portion of their annual compensation, as defined in the Plan. Contributions can be made on either a pre-tax or after-tax (Roth) basis and are subject to certain Internal Revenue Code limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Employer elected to include the safe harbor provisions for Employer-matching contributions. The Employer-matching contributions are 100% of the participants' contributions up to 3% of the participants' compensation and 50% of the participants' contributions for the next 2% of compensation. Additional nonelective discretionary contribution amounts may be contributed annually at the option of the Company's Board of Trustees, subject to certain limitations. Participants direct the investment of their contributions into a selection of registered investment company options offered by the Plan.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### ***Vesting***

Participants are immediately vested in their contributions and the Company safe harbor matching contribution plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in nonelective discretionary contributions after six years of credited service. Participant balances merged into the Plan from the Company's Money Purchase Plan were transferred at the vesting percentage on the merger date and continue to vest after the transfer, with a participant becoming 100% vested after six years of credited service.

### ***Payment of Benefits***

On termination of service, a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in annual installments for required minimum distributions.

### ***Forfeitures***

At June 30, 2025 and 2024, the Plan held forfeited nonvested accounts totaling \$61,068 and \$24,373, respectively. These amounts may be used to pay for certain plan expenses or reduce future Employer safe harbor matching contributions, as defined in the plan agreement. No forfeitures were used during 2025.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### ***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments consist of shares of registered investments companies which are stated at fair value based upon quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Administrative expenses may be paid by the Company, Plan or the participants, or paid through a revenue sharing arrangement, as defined in the plan service agreement.

## **Note 3. Fair Value Measurements**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, and qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of June 30, 2025 and 2024
- Investment income components as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2025
- Investment information, at fair value, included in the accompanying schedule of assets (held at end of year) as of June 30, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedules.

## **Note 5. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of registered investment companies managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain investment related expenses are included in net appreciation in fair value of investments.

The Plan paid administrative expenses, prior to the effect of revenue sharing, in the amount of \$39,921 during 2025. The Company provides certain administrative services at no cost to the Plan.

Principal receives revenue from certain registered investment companies that is reallocated back to participant's accounts on a monthly or quarterly basis. During 2025, revenue credits totaled \$3,319 and have been offset against administrative expenses on the statement of changes in net assets available for benefits. There were no unused credits as of June 30, 2025.

## **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

## **Note 7. Tax Status**

The Plan has operated under a nonstandardized adoption agreement in connection with a prototype retirement plan sponsored by Principal Life Insurance Company, which received a favorable opinion letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefit.

**Note 9. Nonexempt Transactions**

The Department of Labor (DOL) requires defined contribution plans to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. The DOL considers late deposits to be prohibited transactions requiring disclosure in the notes to the financial statements as well as in the accompanying Schedule H, Line 4a – Schedule of Delinquent Participant Contributions. During 2025, the Plan engaged in prohibited transactions related to late deposits of employee contributions totaling \$27,718. Plan management is in the process of correcting these late deposits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated March 16, 2026, which is the date the financial statements were available to be issued.
