To Whom It May Concern:

I am writing to request to have the late fees and penalties removed in connection with Form 5500 for the above-referenced plan year.

The retirement plan was formally terminated on March 24, 2025. At the time of termination, there was a misunderstanding regarding the ongoing Form 5500 filing requirements for the plan that had ceased operations during the year. It was my understanding that once the plan was terminated and assets were distributed, no further annual filing obligation applied.

This misunderstanding was unintentional and once it became clear that a final Form 5500 filing was still required I promptly moved to have the issue resolved.

As the plan sponsor there was no intent to avoid reporting or compliance obligations. No participants were harmed, and all plan assets were properly handled in connection with the plan termination.

Given the plan's termination during the year and the absence of willful neglect I respectfully request that the late filing penalties be waived.

I'm also attaching the plan's final distribution as proof of the plan's termination.
