## INDEPENDENT AUDITORS' REPORT

### Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Employee Benefit Trust for Community Health Group's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Employee Benefit Trust for Community Health Group's ability to continue as a going concern for a reasonable period of time.
- We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis of Matter — Uncertainty Regarding VEBA Trust Tax-Exempt Status**

As discussed in Note 5, the Voluntary Employees' Beneficiary Association ("VEBA") Trust under which the Plan operates is believed to have received a tax-exempt determination letter, but management is unable to locate the tax-exempt letter in order to confirm that such tax-exempt status is valid. As discussed in Note 5, this uncertainty could affect the VEBA Trust's current and future tax position and the Plan's financial statements amounts and disclosures. Our opinion is not modified with respect to this matter.

### NOTE 1. DESCRIPTION OF PLAN

The following description of the Employee Benefit Trust for Community Health Group (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### General

The Plan is a health and welfare benefit plan established by Community Health Group (the “Company”) on March 1, 1997 to provide health, disability, and death benefits to full-time employees and to their beneficiaries and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Chief Executive Officer, who is also the Plan’s authorized representative, is responsible for oversight of the Plan. Administrative services are provided by Centrix Benefit Administrators, Inc.

#### Benefits

The Plan provides health benefits (medical, dental, vision, and pharmacy) for eligible employees of the Company and their beneficiaries/dependents. These health benefits are self-insured. See “Stop-Loss Insurance Policy” later in this section. All covered employees also receive term life insurance benefits equal to two times their annual salary (up to a maximum of \$300,000 face value) and an equivalent amount for accidental death and dismemberment insurance. In addition, the Plan purchases insurance for long-term disability and long-term care benefits upon election by the employees.

In accordance with the Consolidated Omnibus Budget Reconciliation Act (“COBRA”), the Plan provides for continuation of benefits for certain terminated employees up to eighteen months and certain dependents for a period of up to thirty-six months depending upon eligibility. The cost of these benefits is paid by the terminated employees or their dependents. The Plan also provides the sponsorship of voluntary and supplemental benefits.

The Plan includes a cafeteria arrangement maintained pursuant to Section 125 of the Internal Revenue Code (“IRC”) in which employees may elect to reduce their taxable salary in favor of purchasing nontaxable benefits including reimbursements of medical expenses and dependent childcare expenses.

#### Eligibility

Those employees who are employed a minimum of thirty hours per week are eligible to participate on the first day of the month following thirty days of service. An employee will become a participant in the Plan on the first day of the month immediately following the date the employee satisfies the eligibility conditions.

#### Participant Contributions

In addition to deductibles and co-payments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of voluntary supplemental, dependent life insurance, and supplemental ancillary benefit programs based on elections.

The Plan also receives contributions from employees which are deducted per a salary reduction arrangement as provided by Sections 125 and 129 of the IRC.

#### Employer Contributions

The Company provides funds to the Plan administrator to pay health claims, insurance premiums, and administrative fees. The Company makes contributions to the Plan as needed to fund claims in excess of participant contributions. Any deficiency resulting from benefit obligations in excess of Plan net assets available for benefits is funded by the Company on a pay-as-you-go basis.

#### Benefit Obligations

Plan liabilities for estimated health claims incurred but not reported are estimated by the Plan primarily based on health benefit claim payment registers and claims reports provided by the Plan administrator and are reported at their present value. These amounts are paid by the Plan only if claims are submitted and approved for payment within 180 days after the Plan year. Health claims payable and claims incurred but not reported totaled \$1,243,051 and \$310,437 as of December 31, 2024 and 2023, respectively.

#### Stop-Loss Insurance Policy

The Company has obtained reinsurance coverage from a third-party carrier for medical claims which generally exceed \$150,000 per participant per year in 2024 and 2023 with no maximum limit. As of December 31, 2024 and 2023, there were \$650,900 and \$539, respectively, in receivables for unpaid claim reimbursements based upon the stop-loss coverage limits. For the year ended December 31, 2024, \$650,900 has been netted against health and pharmacy claims in the accompanying statement of changes in net assets available for benefits.

#### Administration Expenses

The Plan has an agreement with a third-party administrator to provide administrative services, claims adjudication, COBRA administration and other services. In addition, the Plan pays fees for services provided through other contracts. Administrative expenses were \$530,672 for the year ended December 31, 2024.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits of or on account of the participants. No assets of the Plan may revert back to the Company or be used for a purpose other than the exclusive benefits of the Plan's participants.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). Employee and employer contributions are recognized in the period that contributions are due.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that may affect the reported amounts of assets, benefit obligations, and changes therein, claims incurred but not reported, claims payable, liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Payment of Benefits

Premiums are expensed when paid by the Company in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits and benefit obligations. As of December 31, 2024 and 2023, there are no payables to claims administrators.

#### Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued.

### NOTE 3. CONTRACTS WITH INSURANCE COMPANIES FOR STOP-LOSS REIMBURSEMENTS

The Plan has contracts with insurance companies, whereby the insurance companies pay claims exceeding a predetermined deductible threshold, which are then used to reduce the Plan's payments. Premiums paid by the Plan for such insurance contracts are included in the accompanying statements of changes in benefit obligations and net assets available for benefits under insurance premiums for the provision of benefits.

### NOTE 4. RELATED PARTIES AND PARTY IN-INTEREST TRANSACTIONS

The Plan has entered into an administrative contract with Centrix Benefit Administrators, a third-party administrator, to provide administrative services, to collect contributions, transmit payments to the various insurers and provide claims and COBRA administration. The Plan also incurs other administrative fees with parties in-interest for purposes of operating the Plan. Fees incurred by the Plan for these services are included in the accompanying statement of changes in benefit obligations and net assets available for benefits.

### NOTE 5. INCOME TAX STATUS

Plan management believes that the Voluntary Employees' Beneficiary Association ("VEBA") Trust established under the Plan to hold the Plan's assets qualifies pursuant to Section 501(c)(9) of the IRC and, as such, is exempt from taxation. Plan management believes the Plan is also exempt from California income taxes and is exempt under Section 23701(i). Plan management believes the VEBA Trust continues to meet the applicable requirements for exemption, including that substantially all operations are in furtherance of providing permissible health and welfare benefits to members and their dependents or designated beneficiaries and that no part of the VEBA Trust's net earnings inures to the benefit of any private shareholder or individual other than through payment of such benefits. As such, no provision for income taxes has been recorded.

### NOTE 5. INCOME TAX STATUS (Continued)

Plan management is unable to locate an IRS determination letter specifically confirming the VEBA Trust's current tax-exempt status under IRC Section 501(c)(9). In addition, the VEBA Trust's qualification for exemption is subject to additional statutory requirements, including nondiscrimination requirements applicable to certain plans funded through a Section 501(c)(9) organization. Required nondiscrimination testing has not been completed for the 2024 Plan year as of the date the accompanying financial statements were issued. Because satisfaction of the nondiscrimination requirements is a condition to exemption for a Section 501(c)(9) organization that is part of a plan, completion of this testing is relevant to Plan management's evaluation of the VEBA Trust's tax-exempt status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Notwithstanding the absence of a current IRS determination letter and the fact that nondiscrimination testing has not yet been completed for the 2024 Plan year, Plan management believes the VEBA Trust continues to operate in compliance with the applicable requirements for tax exemption and has evaluated its tax positions in accordance with ASC 740, *Accounting for Income Taxes*, including the tax position that the VEBA Trust is not subject to federal income tax. Under ASC 740, tax benefits are recognized only if it is more likely than not that the related tax position will be sustained upon examination based on its technical merits. Based on this evaluation, no material liabilities for income taxes are recognized in the accompanying financial statements as of December 31, 2024. Plan management intends to complete the nondiscrimination testing for the Plan on a prospective basis and will continue to monitor the VEBA Trust's operations for ongoing compliance with the applicable requirements for exemption and for any activities that could give rise to taxable income.

### NOTE 6. CONCENTRATIONS

The Plan maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts.
