To Whom It May Concern,

We are writing in response to Notice CP283 regarding the assessed penalty of \$29,750 related to the late filing of Form 5500 for the plan year ending December 31, 2024.


We respectfully request abatement of this penalty based on reasonable cause. The delay in filing was the result of a transition between plan service providers, from ADP to Guideline, which took place in January 2025. During this transition period, responsibilities related to the preparation and filing of Form 5500 were not clearly aligned between providers, which resulted in an unintentional oversight. As soon as the issue was identified, we took immediate corrective action and filed the complete and accurate Form 5500 on February 9, 2026. We take our compliance obligations seriously and have implemented improved procedures to ensure this does not occur again. These include clearly defined responsibilities with our current provider, enhanced internal tracking systems, and additional oversight to ensure timely filings.

This was an isolated incident resulting from a provider transition, and not due to willful neglect.

Based on the above, we respectfully request full abatement of the assessed penalty.
