Note 1. Description of Plan

The following description of Stone Source 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

On February 1, 2025, the Plan was merged into Happy Floors/Ceramic Technics 401(k) Plan as part of a corporate restructuring involving the Plan Sponsor. As a result of the merger, all plan assets and participant account balances were transferred to the successor plan, and the Plan ceased to operate as a separate entity. This transaction was approved by the Plan Administrator in November 2024 and executed in accordance with ERISA requirements.

General and Eligibility

The Plan is a defined contribution 401(k) profit sharing plan covering all employees of Stone Source, LLC (the Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The effective date of the Plan is May 1, 1999, and the latest amendment was effective March 18, 2022, where the Plan adopted CARES Act provisions providing all relief provisions for qualified participants including COVID-related distributions, loan relief, and 2020 required minimum distributions waiver. On March 31, 2022, all the ownership interests of the Company were acquired by Ceramic Technics LLC. Subsequently, the Plan was frozen and there were no employee or employer contributions, and the payroll was transferred to the acquired company.

All employees, except part-time/temporary/seasonal employees with less than 1,000 hours of service, are eligible to participate in the Plan beginning on the first day of the month after completing 30 days of employment.

Contributions

Prior to January 1, 2023, participants may contribute up to 100% of pretax eligible compensation subject to the annual limit of the Internal Revenue Code (IRC) and may designate all or a portion of their deferrals as Roth deferrals. Participants of age 50 and over may make additional pre-tax contributions. The Plan provides for automatic enrollment for each eligible participant at a pre-tax salary deferral of 1% upon meeting eligibility requirements.

Participants who are highly compensated employees, determined as of the beginning of a plan year, may defer up to 6% of his/her pretax eligible compensation, subject to the annual IRC limit. There were no employee contributions in 2025.

The Company can make discretionary matching contributions limited to 100% on the first 1% of employee compensation, 50% on the next 2% and 25% on the next 2%, up to a maximum of 50% on the first 5% of employee compensation. There were no employer contributions for the period ended February 1, 2025.

Payment of Benefits

A participant may elect to receive benefit payments at the normal retirement age of 65. Upon retirement, death or disability, all amounts credited to the participant's account shall be distributed to the participant or the participant's beneficiary, as applicable. Other withdrawals from participants' account balances may be made under certain circumstances, as defined in the plan agreement. The loans are secured by the balance in the participant's account. Interest rates applicable to new participant loans are 1% over the prime interest rate (8.5% as of February 1, 2025). Loans are repaid ratably through periodic payroll deductions over a term not exceeding five years, or ten years for loans used for the purchase of a primary residence. Participants may also repay loans through automated clearinghouse electronic funds transfers. Terminated participants may continue to repay loans following their termination date.

Default on repayment of a loan is treated as a distribution to the participant.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Payment of Benefits

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and the plan custodian (see Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest and approximate fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2025. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities, could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

The Company can make discretionary matching contributions limited to 100% on the first 1% of employee compensation, 50% on the next 2% and 25% on the next 2%, up to a maximum of 50% on the first 5% of employee compensation. There were no employer contributions for the period ended February 1, 2025.

Participants may also contribute amounts representing eligible rollovers from other qualified plans.

Payment of Benefits

A participant may elect to receive benefit payments at the normal retirement age of 65. The Plan also provides for distribution of benefits upon death or in the event of disability of the participant. Upon retirement, death or disability, all amounts credited to the participant's account shall be distributed to the participant or the participant's beneficiary, as applicable. Other withdrawals from participants' account balances may be made under certain circumstances, as defined in the plan agreement. In-service withdrawals may be made from a participant's account at any time upon the participant's attainment of age 59½.

The Plan allows participant withdrawals for hardship, as defined by the Plan, which cannot exceed the amount needed to meet the immediate financial hardship, as defined by the Plan. The distribution is allowed to be made from all vested accounts of the participant. A participant may not make elective deferrals to the Plan for a six-month period after such withdrawals.

Participant Accounts

Each participant's account is credited with the participant's contribution, employer matching contributions, and earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are based on participant's earnings, account balances, or specific transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their salary deferred contributions, as well as any employer contributions, and related investment income and losses thereon.

Notes Receivable from Participants

A participant may borrow the lesser of 50% of his/her vested account balance or up to \$50,000, subject to a \$1,000 minimum. A participant may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account. Interest rates applicable to new participant loans are 1% over the prime interest rate (8.5% as of February 1, 2025). Loans are repaid ratably through periodic payroll deductions over a term not exceeding five years, or ten years for loans used for the purchase of a primary residence. Participants may also repay loans through automated clearinghouse electronic funds transfers. Terminated participants may continue to repay loans following their termination date.

Default on repayment of a loan is treated as a distribution to the participant.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Payment of Benefits

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and the plan custodian (see Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest and approximate fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2025. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Subsequent Events

The Plan has evaluated subsequent events through March 9, 2026, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of February 1, 2025 and December 31, 2024
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period ended February 1, 2025
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of February 1, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Recurring Measurements

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Mutual funds are stated at fair value based on quoted prices in an active market for each share held by the Plan.

Stable value collective trust fund: Composed primarily of fully-benefit responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments and the redemption notice period of 12 months is applicable only at the plan level.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and common trust funds managed by the plan custodian and therefore these investments qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Administrative expenses paid to the Plan's custodian were \$8,702, and expenses paid to third parties responsible for financial advisory services were \$6,760 for the period ended February 1, 2025.

Note 6. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by AT Retirement Services LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Note 7. Risk and Uncertainties

The Plan invests in funds that invest in investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities, could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.
