Opinion

NOTES TO FINANCIAL STATEMENTS YEAR ENDED JUNE 30, 2025 (with comparative information at June 30, 2024)

1. Description of Plan and summary of significant accounting policies:

The following description of the Motor Truck Equipment Company Health Care Plan (the Plan), established July 1, 2014, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The trust related to the Plan was established on July 1, 2015, the beginning of the initial Plan year.

General:

The Plan provides health and other benefits covering eligible employees and covered dependents of the Motor Truck Equipment Company and Motor Truck Pac Lease, (collectively the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits:

The Plan provides health benefits (medical and prescription). Effective January 1, 2019, the Plan also provides life insurance benefits, long-term disability and accidental death and dismemberment (AD&D) benefits. The Plan covers full-time employees and their dependents following the completion of 30 days of employment.

Self-insured benefits:

The health benefits are self-insured by the Company. The claims for these self-insured benefits are processed by the Plan's third-party administrators. The third-party administrators pay claims directly to or on behalf of the participants. The payments for these claims are paid from the Plan's trust, which is funded by the general assets of the Company and employee contributions. Despite the Plan's utilization of third-party administrators for claims processing, the ultimate responsibility for payments to providers and participants is retained by the Plan.

Insured benefits:

The Plan fully insures the life insurance benefits, long-term disability, short-term disability and AD&D benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company from employee and employer contributions.

Stop-loss coverage:

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for health benefits (individual participant claims over a specific dollar amount), as well as its aggregate exposure for all claims. Starting January 1, 2023, the Plan's stop-loss coverage amount was \$90,000 per individual and provided coverage up to a maximum of \$1,000,000 aggregate benefit.

NOTES TO FINANCIAL STATEMENTS YEAR ENDED JUNE 30, 2025 (with comparative information at June 30, 2024)

1. Description of Plan and summary of significant accounting policies (continued):

Contributions:

The Plan is contributory. Employees pay a flat rate toward their coverage and that of their dependents, which varies depending upon which medical plan options are selected.

Employees are able to utilize flexible spending accounts. The account allows an employee to contribute up to \$3,200 per year, on a pre-tax basis, for use on qualified medical expenses; and \$5,000 per year, on a pre-tax basis, for use on dependent care assistance. Employees are permitted to roll over balances up to \$640 into the next Plan year and have 90 days subsequent to the Plan year end to submit claims. Account balances held on deposit at a third-party processor are reported as flexible spending accounts on the statements of net assets available for benefits. The flexible spending account was closed effective December 31, 2023. Brown Plus noted the Plan document was amended and restated effective July 1, 2024 to remove the flexible spending account from the Plan.

The Company funds the health benefits through the use of a trust established by the Veris Benefits Consortium, LLC (Consortium) for the Plan. Monthly contributions are made to the trust in an amount sufficient to cover expected claims and administrative expenses of the Plan.

COBRA:

The Plan offers continuation of benefits (COBRA) for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event.

Each qualifying individual pays his/her premium directly to the service provider.

Plan administration:

The Plan provides health benefits through the Consortium, developed in 2011 for private sector employers. The Company is a participating member of the Consortium and executed an agreement to administer the Plan through the Consortium.

The Company has engaged third parties to act as service providers. The Company also entered into a membership agreement with the Consortium whereby the manager of the Consortium will perform administrative services on behalf of the Plan, including development of the program with respect to eligibility and underwriting standards, placing stop-loss insurance, coordination of regulatory compliance and document preparation.

The Company also entered into an agreement with an insurance provider to administer the health benefits under the Plan in accordance with its policies and procedures. The insurance provider invoices the Plan for claims paid on a weekly basis.

The service providers charge an administrative fee related to the services performed, of which certain administrative expense is paid from the Plan's trust account. These service providers noted above are considered parties-in-interest under ERISA.

In addition, the Plan's other administrative expenses are paid either directly by the Company or by the Plan.

1. Description of Plan and summary of significant accounting policies (continued):

Plan termination and modification:

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the Company must pay the claims incurred and expenses of the Plan due up to the date of termination, plus extended benefits, if any, provided under the Plan.

Basis of accounting:

The accompanying financial statements have been prepared using the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States.

Receivables:

Stop-loss receivable and reimbursements represent amounts to be reimbursed for claims paid in excess of the individual stop-loss coverage.

Other receivables represent ordinary interest income and claim fund revenue received after year end.

Valuation of investments:

The Plan's interest-bearing cash (money market fund) is valued at cost, which is fair value.

Claims payable:

Claims payable represents the amount of benefit claims incurred and reported to the Plan by the end of the period. See Note 2 for benefit obligations.

Claims incurred but not reported:

Claims incurred but not reported are the estimated claims, which have service dates prior to the year end, but are reported to the Plan subsequent to the year end. Those amounts are estimated based on actual claims experience. See Note 2 for benefit obligations.

The Plan had no accumulated eligibility credits or postretirement benefit obligations.

Payment of benefits:

Claim payments for health benefits are recorded when paid by the service providers.

Insured benefits, including life insurance, long-term disability and AD&D benefits, are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those amounts. Significant estimates used in the preparation of these financial statements relate to claims payable and currently due and claims incurred but not reported to the Plan.

2. Benefit obligations:

Plan obligations at June 30, 2025 and 2024 for claims incurred by participants but not reported at that date are measured by the Plan's actuary at the estimated ultimate cost to the Plan of settling the claims. Estimated ultimate cost reflects the Plan's obligation to pay claims to or for participants, regardless of status of employment beyond June 30, 2025 and 2024, pursuant to the provisions of the Plan. The method used to derive the estimated unpaid claims liability applies the reserve factor to a monthly average of the past several months of medical and drug claims, which is then adjusted as needed based on actual subsequent period claims paid.

The Plan does not offer postemployment benefits, and thus, they are not included in the above calculations.

Claims expense at June 30, 2025 are net of \$116,193 in stop-loss reimbursements.

4. Risks and uncertainties:

Plan assets include cash, which is held at a bank insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At June 30, 2025 and 2024, the cash balances exceeded the FDIC insured limit by \$2,075,434 and \$1,163,397, respectively.

The actuarial value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare and prescription drug costs and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

5. Tax status:

The Plan is intended to qualify as an employee welfare benefit plan, as defined in ERISA, as amended. The Plan benefits are funded out of the general assets of the Company and employee contributions. The health benefits are paid in part from the trust established by the Veris Benefits Consortium, LLC and in part by pre-tax contributions made by the employees.

The trust established under the Plan to hold the Plan's assets is a taxable trust.
