Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Guardian Dentistry Practice Management 401k Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained certifications from Fidelity Management Trust Company (FMTC) and Mid Atlantic Trust Company (MATC), qualified institutions, as of December 31, 2024 and 2023 respectively, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1 Description of Plan

The following description of Guardian Dentistry Practice Management 401k Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan providing participants the option of deferring a portion of their current compensation and a related employer contribution to their deferred balances. The Plan is available to all employees of Guardian Dentistry Practice Management LLC (Plan Sponsor). Employees age twenty-one and older become eligible for employer profit sharing contributions on the first month after three consecutive months of employment. There are no eligibility service requirements for elective deferrals and matching contributions.

The Plan commenced on January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's recordkeeper (FMTC), appointed by the Plan Administrator, is responsible for providing reporting services and compliance services, including reporting to participants. Additionally, the custodian is responsible for the management, sale, redemptions, and repurchase of the investments. Assets of the Plan were held by Mid Atlantic Trust Company (MATC) until July 2024, and then transferred to Fidelity Management Trust Company (FMTC) the Plan Trustee (“Trustee”).

Contributions

Employee

Participant contributions to the Plan are made through payroll deductions. The contributions are tax deferred and represent a reduction in federal taxable wages to the participant. Participants are able to contribute up to 100% of their eligible gross pay, as defined, with a total dollar limitation of \$23,000 for 2024 (employees may contribute an additional \$7,500 if over 50 years old). Employer matching contributions are on a discretionary basis as determined by the Plan Sponsor and applied to all participants on a uniform basis.

Employer

Employer matches 100% of participant contributions up to 4% with a cap of \$1,000 of elective deferral percentages and applied to all participants on a uniform basis. Matching contributions for the year ended December 31, 2024 totaled \$923,343, net of forfeitures.

Participant Accounts

Each participants’ account is credited with their own contributions and allocations of (a) the Plan Sponsor’s discretionary matching and/or employer discretionary contributions, (b) Plan earnings or (losses) and charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. All investments are participant directed. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Note 1 Description of Plan (continued)

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary matching and employer discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

Upon termination of employment, a participant's non-vested amounts are forfeited in accordance with the Plan document. A participant becomes 100% vested automatically in their contributions, while still employed, upon attainment of normal retirement age, death, or disability.

Forfeitures

Forfeited non-vested balances may be used to offset plan expenses or may be used to reduce future employer contributions. As of December 31, 2024 and 2023, forfeitures used to offset employer contributions totaled \$390,797 and \$152,807 respectively.

Notes Receivable from Participants

Participants may borrow from their vested account balances an amount up to the lesser of \$50,000 or 50 percent of their account balance. Participants cannot have more than two loans outstanding at any time. The maximum loan term is five years unless the loan is for the purchase of a primary residence for which the maximum loan term is thirty years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined from time to time by the Plan Administrator. Principal and interest are paid ratably through payroll deductions or other methods as approved by the Plan Administrator. Interest rates on the loans vary from 4.25% - 9.5% recorded as of December 31, 2024 and 2023. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments are recorded when paid. On termination of service due to retirement, resignation, dismissal or death, a participant's account balance is distributed to the participant or designated beneficiary by payment in a lump sum for accounts valued at less than \$5,000. If the total vested account balance under the Plan is \$5,000 or less as of the distribution date and the participant does not consent to a distribution of the vested account balance, the vested benefit automatically will be rolled over to an IRA selected by the Plan Administrator. For accounts valued in excess of \$5,000, the participant may elect to remain in the Plan, withdraw a lump sum payment, or withdraw equal monthly payments over a fixed period.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Administrative Expenses

All expenses of the Plan including expenses for recordkeeping, insurance and auditing are paid by the Plan and appear as deductions of the Plan. The expenses paid directly by the Plan were \$126,043 for the year ended December 31, 2024.

Investment Valuation and Income Recognition

The Plan invests in a Fidelity Management Trust Company (FMTC) Contract (the "Contract"), which offers pooled separate accounts that invest in various investment options. The Contract is not fully benefit responsive and therefore the Plan's investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as a distribution based on the terms of the Plan Document.

Note 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value:

Mutual Funds and Money Market Funds: are valued at the daily closing price as reported by the funds. These funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Note 5 Tax Status

The Plan is based on the Volume Submitter Profit Sharing Plan with CODA (cash or deferred arrangement) of the recordkeeper of the Plan, which received an opinion letter from the IRS dated August 31, 2020 stating that the volume submitter plan was designed in accordance with provisions of the IRC. The Plan has not yet filed for its own determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes due from the Plan has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. In the event the Plan is subject to interest and/or penalties, interest would be included with interest expense and penalties would be included as a component of administrative expenses. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 6 Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, it may terminate the Plan upon notice in writing to the Trustee or it may discontinue its contributions to the Plan. In the event of termination, the Plan provides that the amounts in each participant's account will be fully vested and distributed in accordance with the provisions of the Plan and in compliance with all applicable regulations.

Note 7 Related-Party Transactions and Party-In-Interest Transactions

Pooled separate accounts invest in underlying investment vehicles or are portfolios of investments managed by FMTC and MATC. FMTC and MATC are the Trustees and the recordkeepers, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the administrative services amounted to \$126,043 during the year ended December 31, 2024, and are recorded as administrative expenses on the statement of changes in net assets available for benefits. Participant loans are also party-in-interest transactions.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
