Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Family Focus Employees Savings Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of Plan

General

The following description of the Family Focus Employees Savings Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution salary deferral plan sponsored by Family Focus (Organization), which provides an individual account for each participant and provides benefits upon retirement that are based on the amounts contributed by the employee and employer plus earnings on those contributions less any plan administrative expenses. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Effective January 1, 2021, the Chicago Child Care Society merged with Family Focus, Inc. Effective with the merger, the Family Focus, Inc. Tax Deferred Annuity Plan was terminated. That Plan's participants had the option to take a qualified distribution or roll their balance into the Plan or a combination of these options. If participants of that Plan chose to roll their balances into the Plan, participants were credited with prior service upon joining the Plan. Participant balances that were rolled into the Plan have been included in rollover contributions on the statement of changes in net assets available for benefits.

Effective January 1, 2021, the Society's name was changed to Family Focus, and the Plan name changed to Family Focus Employees Savings Trust.

Effective February 1, 2022, the Plan changed trustees, and all assets were transferred from CUNA Mutual Retirement Solutions with Matrix Trust Company as Custodian to Fidelity Management Trust Company.

Eligibility

The Plan covers all employees of the Organization except nonresident aliens, leased employees, work study students, and substitute teachers. Effective February 1, 2022, part time, temporary, and seasonal employees are also excluded, unless they meet certain criteria, as defined in the plan document. Prior to February 1, 2022, an employee became eligible after completing three consecutive months of eligible service, as defined in the plan document. Effective February 1, 2022, an employee becomes eligible after completing one year of service with 1,000 hours, as defined in the plan document. Effective February 1, 2024, an employee becomes eligible after completing 3 months of service, as defined in the plan document. Employees will enter the Plan on the first day of the month following the date eligibility requirements are met.

Contributions

Participants may contribute a percentage of their compensation as pre-tax contributions as defined in the Plan up to the Internal Revenue Service limit each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employees will be automatically enrolled in the Plan at a 1% pretax contribution rate unless the employee elects a higher or lower pretax contribution rate or declines participation in the Plan. Effective August 15, 2021, participants are permitted to make Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

For the year ended June 30, 2025, the Organization elected to make a safe harbor nonelective contribution of 3% of a participant's eligible compensation. Prior to February 1, 2022, the Organization could make a discretionary profit-sharing contribution. The discretionary profit-sharing contributions were allocated to eligible participants based on a ratio of each individual participant's compensation to all participants' compensation. The Organization may also make a discretionary matching contribution. For the year ended June 30, 2025, the Organization made a discretionary matching contribution of 100% of the first 2% of compensation contributed by eligible participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions, plan earnings, and applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan currently offers various registered investment companies and common or collective trusts as investment options for participants. The investment of participant, discretionary matching, and safe harbor matching contributions into these investment options is determined by each participant. Contributions are subject to certain limitations.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Organization's discretionary matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. One year of service is defined as 1,000 hours during the plan year. Prior to July 1, 2021, a participant was 100% vested in the Organization's discretionary matching and profit-sharing contributions after two years of credited service.

Effective July 1, 2021, discretionary matching and employer nonelective contributions and any earnings thereon will be vested in accordance with the following schedule:

Years of Credited Service	Percent Vested
Less than 2 years	0%
2 years	25%
3 years	50%
4 years	75%
5 years	100%

Participant accounts become fully vested upon attainment of the normal retirement age of 65 or in the event of death or total disability.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50% at June 30, 2025. Loan terms are not to exceed five years except for those loans utilized for the purpose of purchasing a primary residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or can elect to receive the account balance in installments. If the value of the vested benefit exceeds \$5,000, the participant must give written consent before the distribution will be made. A participant may withdraw any part of his or her rollover account balance at any time. The Plan also provides for hardship withdrawals from a participant's account as defined in the plan document.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce employer contributions or pay administrative expenses. During 2025, \$2,995 of forfeitures were used to reduce employer contributions. At June 30, 2025 and 2024, forfeited nonvested account balances available for future use were \$41,026 and \$25,902, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of investments held in registered investment companies are valued at quoted market prices.

The common or collective trust funds are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The Plan's interest in the common or collective trust funds are valued based on information reported by the investment advisor of the collective trust at year end. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at June 30, 2025.

Purchases and sales of securities are reflected on a trade-date basis. The realized gains or losses on the sale of securities are based on average cost. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Organization, Plan, or the participants, as defined in the plan service agreement. Additionally, certain employees of the Organization provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value.

- Level 1** Quoted market prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 5. Transactions With Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by Fidelity Management Trust Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Investment related expenses are included in net appreciation in fair value of investments.

Administrative expenses paid by the Plan during 2025, totaled \$36,607.

Note 6. Plan Termination

Although they have not expressed any intent to do so, the Organization has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

The Plan adopted a non-standardized adoption agreement in connection with a prototype profit sharing plan sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the IRC and that the related trust was tax exempt as of the financial statement date.

Although the Plan has been amended since receiving these opinion letters, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Note 8. Information Certified by the Custodian of the Plan

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2025 and 2024
- Investment income components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2025
- Investment information, at fair value, and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of June 30, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 9. Reconciliation of Financial Statements to Form 5500

The difference between the *Annual Return/Report of Employee Benefit Plan* (Form 5500) filed with the IRS and the accompanying financial statements is that the common or collective trust fund amount in Form 5500 does not reflect the effect of ASU 2015-12 and, therefore, reflects an adjustment to the fair value of that investment. Accordingly, the net assets available for benefits per the financial statements is \$3,148 and \$3,753 higher than the net assets available for benefits per the Form 5500 as of June 30, 2025 and 2024, respectively. Additionally, the net increase in the net assets available for benefits per the financial statements is \$605 lower than the net increase in the net assets available for benefits per the Form 5500 for the year ended June 30, 2025.

Note 10. Subsequent Events

Subsequent events have been evaluated through February 13, 2026, which is the date the financial statements were available to be issued.
