To Whom It May Concern:


Please accept this as our letter of explanation for the late filing of Form 5500-SF (FINAL) for Prime Management, Inc. related to its 401K profit sharing plan as referenced above.

Prime Management, Inc. was acquired by Continuum Companies, Inc. on June 1, 2023. Upon acquisition, Prime Management, Inc. was merged into Prime Management Services, Inc. and the 401(k) Profit Sharing Plan was subsequently transferred. Due to the transition, we were unaware that ADP (the plan administrator for Prime Management, Inc.) did not file a final form 5500-SF upon transfer of the plan. We were mistakenly under the impression it was addressed by either ADP or the acquiring entity.

Upon receipt of notice about the failed filing, I responded to the notice stating that the plan was transferred and there were no assets or participants in the plan at the end of the plan year. I was instructed to file a final Form 5500-SF via the EFAST system on the Department of Labor's website.
