### Opinion on the 2024 Financial Statements

## Notes to Financial Statements

### Note 1 – Description of the Plan and Trust

The Washington State Auto Dealers Insurance Trust Benefit Plan (the Plan) was established on May 1, 1949. The Plan was established to provide programs of health and other welfare benefits for participant employers under the employee benefit plans they maintain for their employees and dependents. The following description of the Plan provides only general information. Participants should refer to the plan documents, summaries, and other descriptive plan literature for a more complete description of the Plan's provisions.

This Plan is considered a "multiple employer welfare arrangement" as defined by the regulations promulgated under the Employee Retirement Income Security Act of 1974 (ERISA). ERISA regulations define a "multiple employer welfare arrangement" as an employee welfare benefit plan or any other arrangement, which is established or maintained for the purpose of offering or providing any welfare benefit to the employees of two or more employers, or to their beneficiaries. The types of benefits available through the Plan through December 31, 2024, are described as follows: dental, vision, basic life, voluntary life, and short-term and long-term disability benefits. Until August 31, 2023, medical benefits were funded under an insurance agreement, which was not renewed subsequent to that date. Accordingly, the Plan no longer provides medical benefits.

Participation in the Plan is limited to the Washington State Auto Dealers Association (WSADA) itself and any associated, qualified employer. Qualified employers include any sole proprietorship, partnership, corporation, trust, or other business entity that is an active member of the WSADA and who has executed a Participation Agreement with the Board of Trustees. The only individuals who are entitled to participate in and to receive benefits from the Plan are those employees and dependents identified by participating employers.

Each participating employer agrees to promptly remit contributions to the related trust to adequately cover the payment of insurance premiums for its participants and beneficiaries and its share of any reasonable and necessary obligations and expenses incurred during its participation. The Board of Trustees may bring action to collect contributions if coverage has been provided or if benefits have been paid and no contributions or incorrect amounts of contributions have been paid.

Employer and participant contributions are received and held by the related trust pending payment of approved insurance premiums. Such contributions are determined pursuant to rules adopted by the Board of Trustees.

During the years ended December 31, 2024 and 2023, the Plan and related trust were administered by the Board of Trustees of the Washington State Auto Dealers Insurance Trust, with the assistance of Vimly Benefit Solutions, Inc., a contract administration organization; Marsh & McLennan Agency, LLC (Marsh), a benefits consulting services firm; and The Cicotte Law Firm, PLLC, a legal services firm. Financial statement accounting and auditing services were provided by Anastasi, Moore & Martin, PLLC, and Schoedel & Schoedel, PLLC, for the years ended December 31, 2024 and 2023, respectively. The Plan is marketed to employers by insurance brokers, including Marsh.

## Notes to Financial Statements

### Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Board of Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year. See Note 6 for a further discussion of fair value measurements.

- d. **Contributions** – Employer and participant contributions are recognized as the Plan becomes obligated for the payment of insurance premiums. Therefore, contributions received after December 31 for premiums paid before the beginning of the subsequent year are recognized as contributions receivable. On the other hand, contributions received before December 31 for premiums to be paid in the subsequent year are recognized as unearned.
- e. **Payment of insurance premiums** – Insurance premiums are recognized when paid.
- f. **Reclassifications** – Certain amounts in the 2023 financial statements have been reclassified for comparative purposes to conform with the 2024 presentation with no effect on previously reported net assets available for benefits.
- g. **Subsequent events** – Subsequent events have been evaluated through February 24, 2026, which is the date the financial statements were available to be issued.

### Note 3 – Income Tax Status

The trust established under the Plan to hold the assets of the Plan is qualified as a tax-exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the net investment income of the trust is exempt from income taxes. The trust obtained its latest tax determination letter from the Internal Revenue Service (IRS) dated February 16, 1966. In the letter, the IRS stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC. The trust has been amended since receiving the determination letter. The Board of Trustees and legal counsel believe the trust and related plan are designed and have been operated through December 31, 2024, in accordance with applicable provisions of the IRC.

## Notes to Financial Statements

### Note 3 – Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the tax-exempt status; however, there are currently no audits for any tax periods in progress.

### Note 4 – Priorities Upon Termination

The Plan may be terminated at any time by action of the Board of Trustees. Upon the termination of the Plan, the Board of Trustees will wind up the affairs of the Plan. Where the termination occurs as a result of a merger, any and all monies and assets remaining in the Plan, after the payment of expenses, will be transferred to the successor plan. With respect to any other termination, any and all monies and assets remaining in the Plan, after the payment of expenses, will be used for the continuance of the benefits for participating employees then covered by the Plan until such monies and assets have been exhausted or until such assets are no longer sufficient to provide any sort of meaningful benefit to participating employees. At this point, the remaining assets may be disposed of in any manner permitted by law and consistent with the Trust Agreement and the fiduciary obligations imposed by ERISA.

### Note 5 – Risks and Uncertainties

The Plan provides for investment in a variety of investment securities. In general, investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Currently, the Plan operates as a fully insured arrangement and, therefore, is contracted with particular insurance carriers. In the Plan's service area, there is a limited number of qualified insurance carriers willing and capable of meeting the Plan's insured benefit needs.

The Plan maintains its cash balances in a high credit quality financial institution. Accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000 through December 31, 2024, at which time the insured coverage amount may be changed. At times, such cash balances may be in excess of the insurance limit.

The Plan and related insurance carriers face an increasingly challenging regulatory environment. Certain interpretations of laws, rules, and regulations could potentially result in adverse effects to the Plan.

### Note 6 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1* – The fair values of short-term funds and mutual funds are based on the closing price reported on the active market in which the individual securities are traded.

*Level 2* – The Plan has no investments that are classified as Level 2 at December 31, 2024 or 2023.

*Level 3* – The Plan has no investments that are classified as Level 3 at December 31, 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
