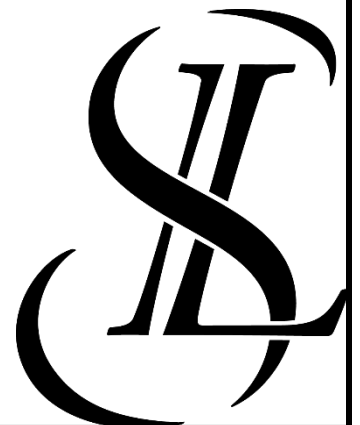

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the KELC 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and January 31, 2024, and the related statements of changes in net assets available for benefits for the respective period and year then ended, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certification from a qualified institution as of December 31, 2024 and January 31, 2024, and for the respective period and year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan

The following description of the KELC 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

Effective February 1, 2024, the Plan’s year-end was amended to be December 31, beginning with the period ended December 31, 2024.

General

The Plan is a defined contribution plan covering substantially all employees of Kaplan Early Learning Company, Inc. (“KELC”), and its wholly-owned subsidiaries, AlphaBEST Education, Inc. and Gryphon House, Inc., and affiliated company, Guidecraft USA, Inc. (collectively, the “Company” or “Employer”). Employees who have attained age 18 or older and have completed three months of service with at least 249 hours are eligible to participate in the Plan. If the initial service requirement is not met, employees must complete a year of service with 1,000 hours to participate. Employees may begin participation as of the first day of the month coinciding with or following the date on which they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees are automatically enrolled to defer 3% of pre-tax compensation, which will increase by increments of 1% to a maximum of 6%, unless they elect an alternative percentage or decline participation in the Plan. Participants may otherwise elect to contribute a percentage of their pre-tax or after-tax (“Roth”) compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollovers”). The Company will make safe harbor matching contributions equal to 100% of each participant’s deferral up to 1% plus 50% of the next 5% up to 6% of compensation. Profit sharing contributions to the Plan are discretionary and are determined by the Board of Directors. However, no profit sharing contributions were made for the period ended December 31, 2024 or year ended January 31, 2024.

Upon enrollment in the Plan, a participant may direct participant contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Participants may direct the investment of their account balances into various investment options offered by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions and any income or loss thereon. Vesting in the Company’s matching portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 100% vested in Company’s safe harbor matching contributions after two years of service.

1. Description of Plan (Concluded)

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan.

Forfeitures

Forfeitures of terminated participants' non-vested amounts may be used to reduce Company contributions or offset administrative expenses. Forfeitures of approximately \$107,000 and \$48,000 were used to reduce Company matching contributions during the period ended December 31, 2024 and year ended January 31, 2024, respectively. Forfeited non-vested accounts of approximately \$19,000 and \$52,000 were available at December 31, 2024 and January 31, 2024.

Notes Receivable from Participants

Participants may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. Terms are generally up to five years and only one note may be outstanding at a time. The notes are secured by the participant's vested account balance and bear interest at the prime rate plus 1% at the date of the application for the note. Principal and interest are paid through payroll deductions.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Fees for trustee, recordkeeping, and asset fees are paid by the Plan. Distribution and note receivable fees are paid from affected participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Empower Investments ("EI") Fixed Account (Note 9).

2. Summary of Significant Accounting Policies (Concluded)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and January 31, 2024. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through October 10, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and January 31, 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the respective period and year ended December 31, 2024 and January 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (“Empower”), the trustee of the Plan.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by Empower Retirement, LLC. The IRS has determined and informed Empower Retirement, LLC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants’ accounts will become fully vested and nonforfeitable.

7. Party-in-Interest Transactions

Fees paid by the Plan to Empower or its affiliates for recordkeeping, investment advisory, and administrative services were approximately \$99,000 and \$95,000 during the period ended December 31, 2024 and year ended January 31, 2024, respectively. Certain plan investments are managed by an affiliate of Empower. Empower is the trustee and recordkeeper as defined by the Plan and, therefore, those transactions qualify as party-in-interest.

Fees paid by the Plan to Oppenheimer & Co., Inc. for investment advisory services were approximately \$27,000 and \$33,000 during the period ended December 31, 2024 and year ended January 31, 2024, respectively.

8. Fair Value Measurements

The Plan adopted Accounting Standards Codification, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurements

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and January 31, 2024.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Investments at Contract Value

The EI Fixed Account (“EIFA”) is a general account product of Empower Investments offered through a group annuity contract. Principal and accumulated interest are fully guaranteed by the general account assets of Empower. Each quarter an interest rate is established for all money invested in the EIFA, regardless of when it was originally deposited. The average yield was 1.66% and 1.50% during the period ended December 31, 2024 and year ended January 31, 2024, respectively. Participants may transfer their account balance from the EIFA to any other investment option offered under the Plan at any time without restrictions or penalties. Certain events limit the ability of the Plan to transact at contract value with the issuer. However, the plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.
